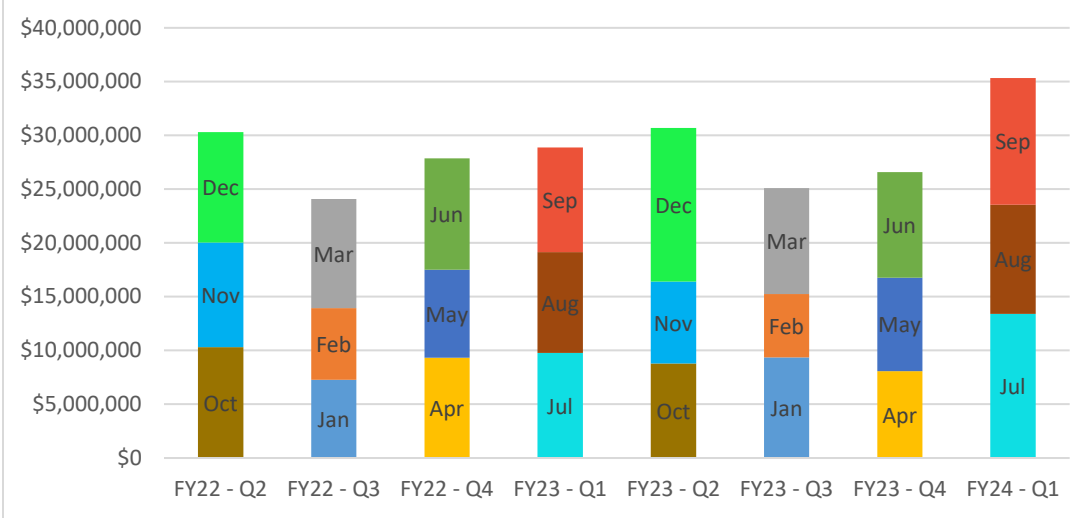

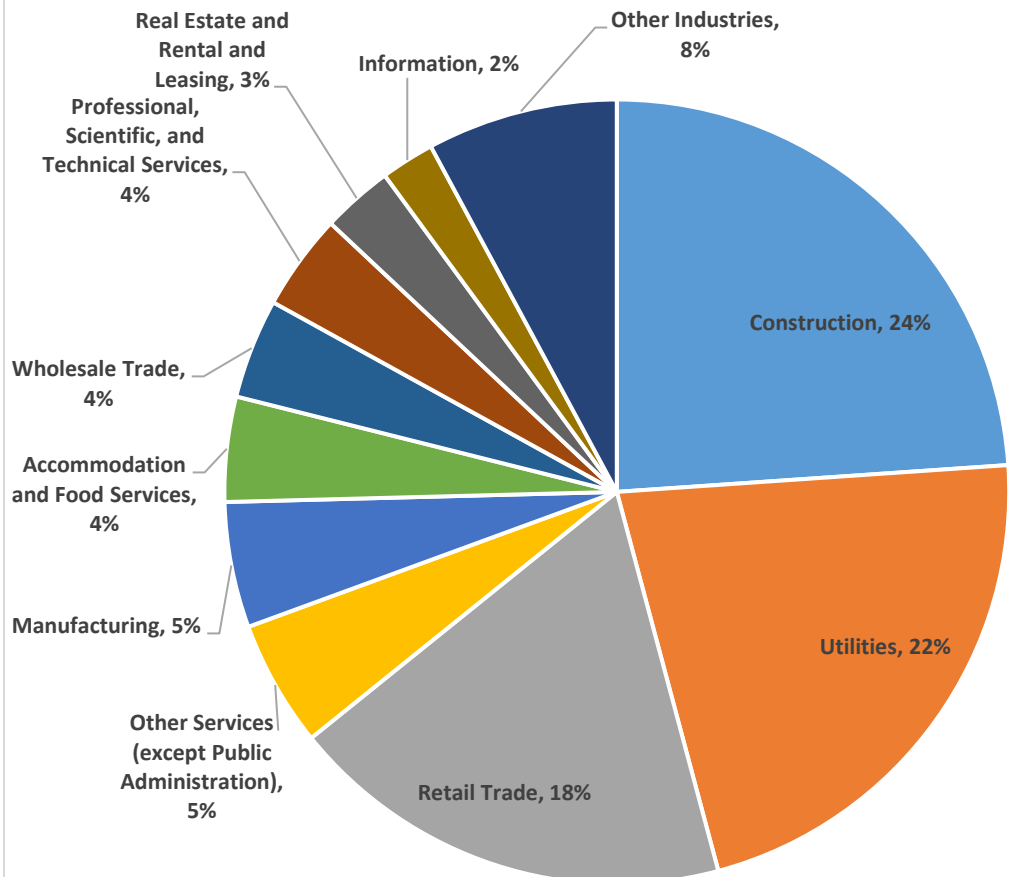
Chart 1. Matched Taxable Gross Receipts Per Quarter



In the first quarter of FY24, 28 of 33 counties saw year-over-year economic growth, with 9.1% growth statewide in matched taxable gross receipts (MTGR). State gross receipts increased from the fourth quarter of FY23, bringing it to the highest ever quarterly total in MTGR for the state.

Union County's matched taxable gross receipts (MTGR) increased by nearly \$8.8M, or 33%, from Q4 FY23 to Q1 FY24, as seen in Chart 1. The amount reported during Q1 FY24 (\$35.3M) was \$6.7M more than the eight-quarter average (\$28.6). As seen in Chart 2, the largest industry as a percentage of total MTGR was the construction industry, which accounted for 24% of the total MTGR during Q1 FY24. Last quarter the industry accounted for 16%.

**Matched Taxable Gross Receipts (MTGR)** are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

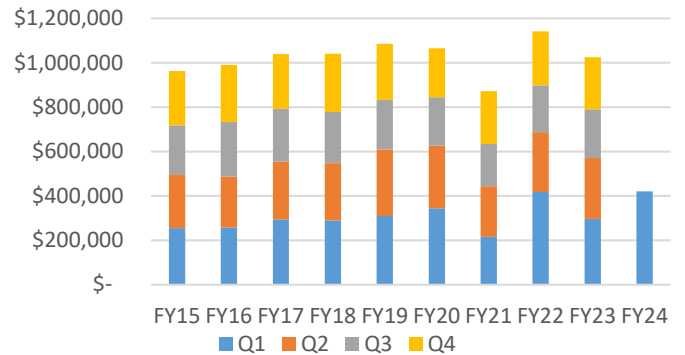

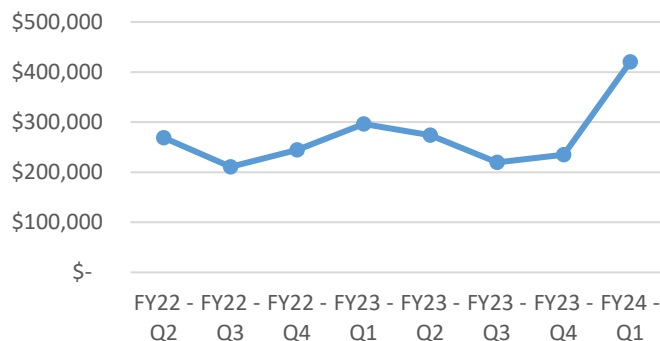
Table 1 shows that all but eight industries reported a year-over-year (YOY) increase. The largest increase came from the construction industry, which posted a YOY increase of \$5.3M. The largest decline came from the utilities industry, which posted a YOY decrease of \$1.7M.

The amount of quarterly gross receipts tax (GRT) collections during Q1 FY24 (\$421K), as seen in Chart 4, is an increase of \$186K, or 79.2%, as compared to Q4 FY23. The amount collected during Q1 FY24 is \$149K larger than the eight-quarter average (\$271K).

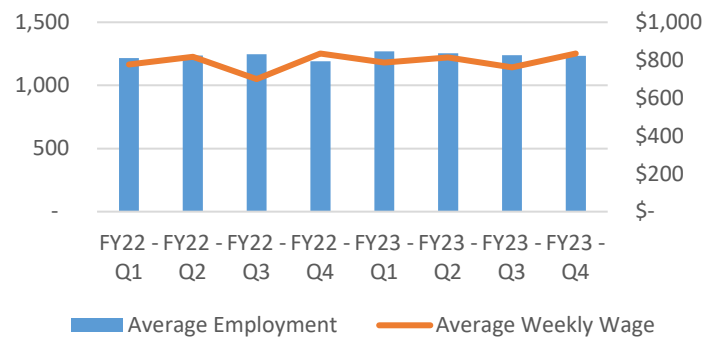
**Chart 3. Annual Total GRT Revenue Collections**



**Chart 4. Quarterly GRT Revenue Collections**



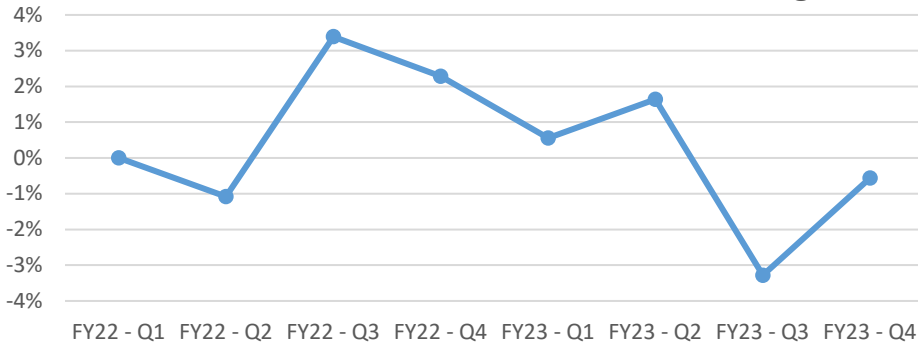
**Chart 5. Total Employment & Weekly Wage**

An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and engaged, predominantly, in one type of economic activity.

**Gross Domestic Product (GDP)** is the value of all goods and services produced in an area. The percentage that GDP grew (or shrank) from one period to another is an important indicator as to how the economy is performing. Table 2, below, shows the percentage of GDP each industry accounts for in the total GDP, in a specific county and the state. The chart also compares the county to the entire state of New Mexico, by showing the impact of specific industry sectors on the county's GDP compared to that of the whole state.

Chart 7. Calendar Year % Change In Real GDP Year-Over-Year

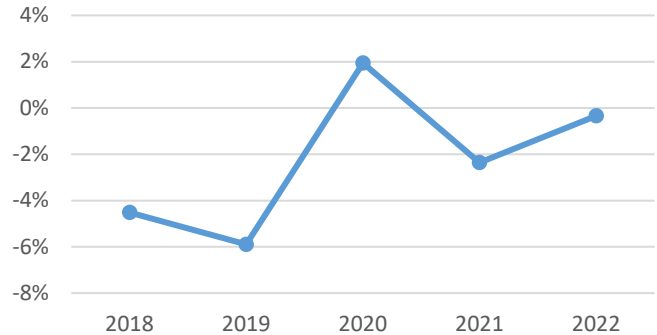

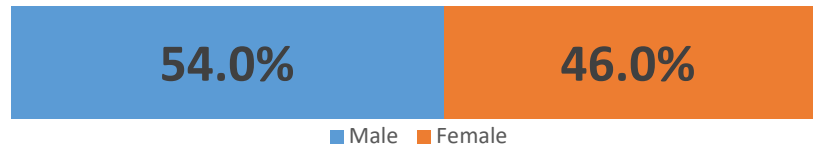

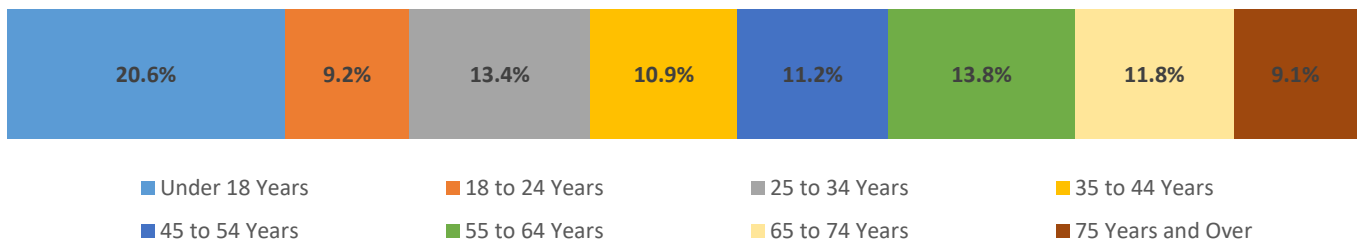

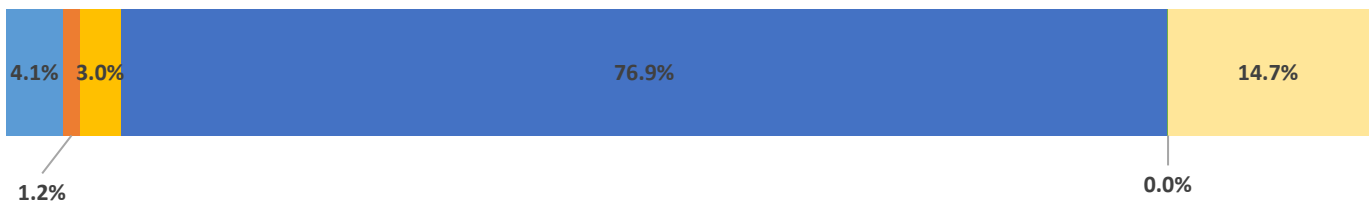
### Population Sex

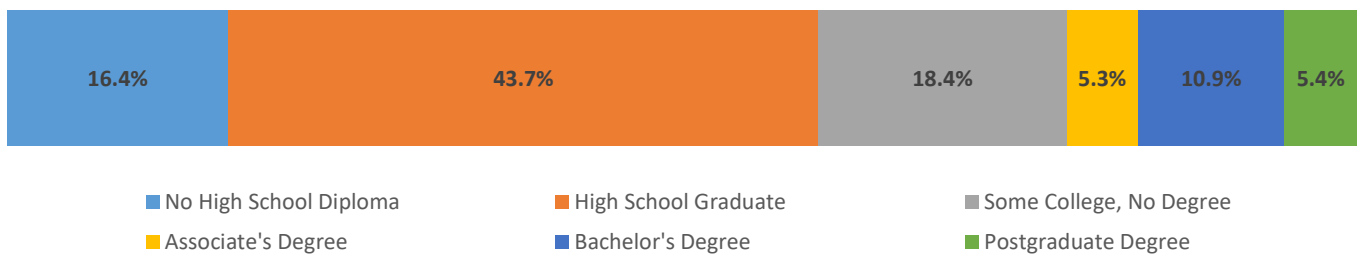
