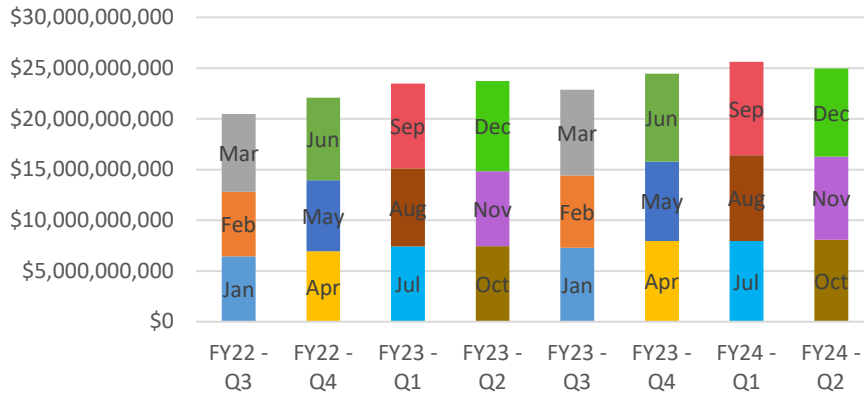

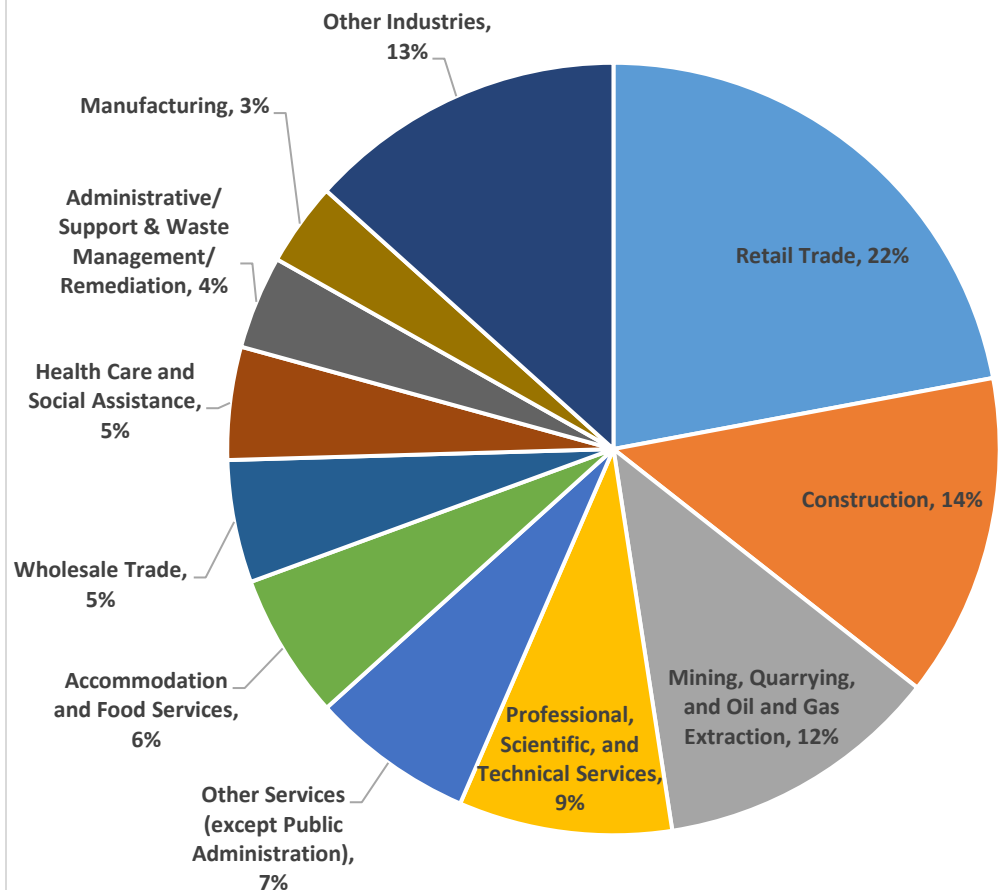
Chart 1. Matched Taxable Gross Receipts Per Quarter



New Mexico's total matched taxable gross receipts (MTGR), in Q2 FY24, decreased by \$678M (-2.6%) from the previous quarter. Despite this decrease, Q2 FY24 was the second highest MTGR reported in the state (\$24.9B), only trailing Q1 FY24 (\$25.6B). The average monthly MTGR for the previous 24 months is \$7.8B, which is \$853M less than the amount reported during the month of December, the largest reported amount, in Q2 FY24 (\$8.7B). Over the last 8 quarters MTGR has maintained an upward trend. As seen in Chart 2, the largest industry as a percentage of MTGR

was the retail trade industry, which accounted for 22% of the total MTGR during Q2 FY24. Last quarter, the industry accounted for 20%. Table 1, on the next page, shows that the largest year-over-year (YOY) increase came from the construction industry followed by the professional, scientific, and technical services industry. Employment in New Mexico experienced year-over-year (YOY) growth of 15,665 in Q1 FY24, seen on page 3, chart 5. Average weekly wages increased YOY by \$14 in Q1 FY24, bringing average weekly wages to \$1,099.

**Matched Taxable Gross Receipts (MTGR)** are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

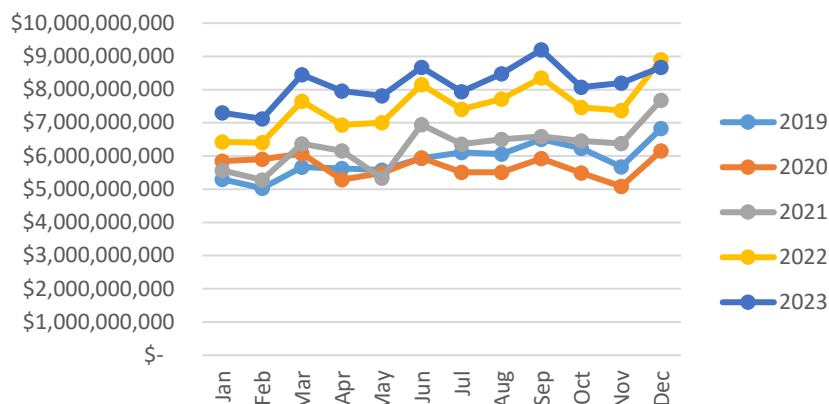

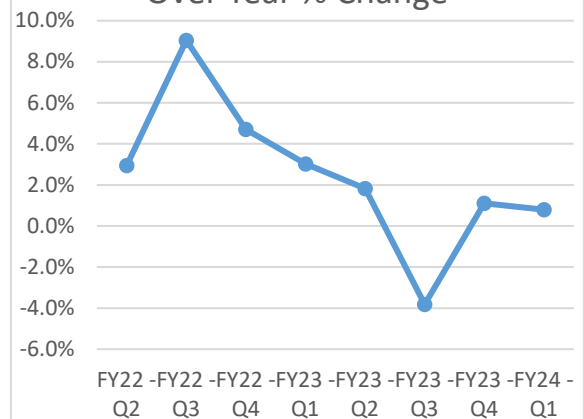

The **Quarterly Census of Employment and Wages** or the **QCEW**, used in Charts 4-5, produces comprehensive data on the number of establishments, monthly employment and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state and national). Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.

Chart 5. Total Employment & Weekly Wage

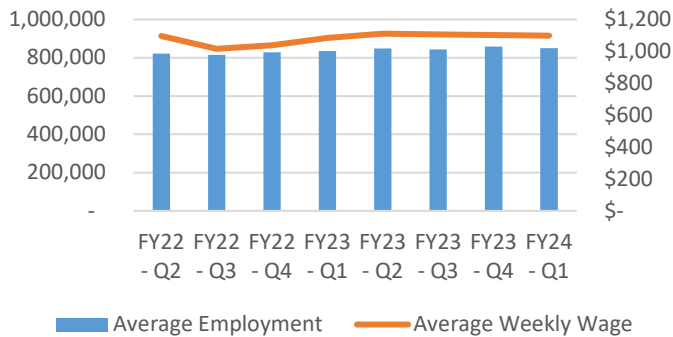


Chart 6. YOY % Change in GDP per Quarter

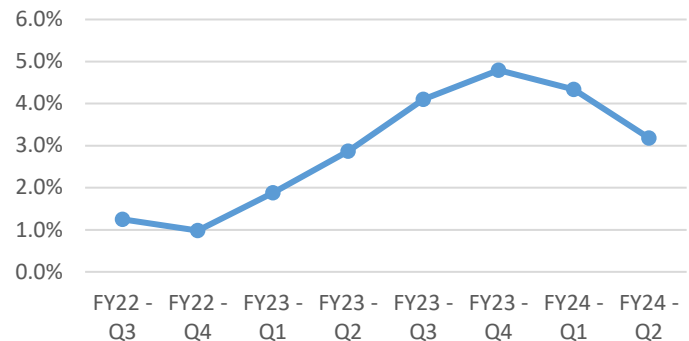
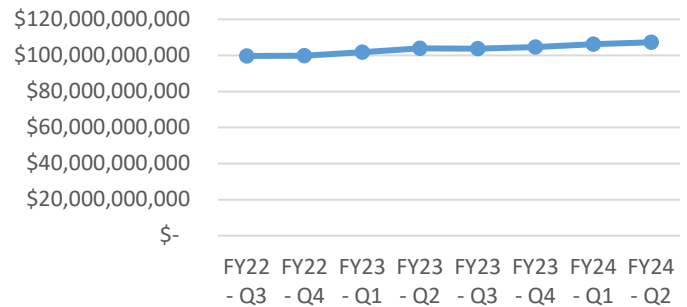


Chart 7. Gross Domestic Product Per Quarter



The value of all goods and services produced in New Mexico is the **Gross Domestic Product (GDP)**. The percentage that GDP grew (or shrank) from one period to another is an important way for the state to gauge how the economy is performing. GDP in Charts 7-8 and Table 2 are real GDP in chained 2017 dollars.

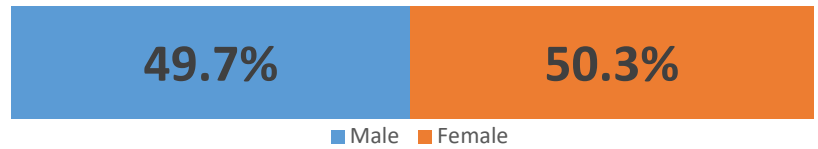

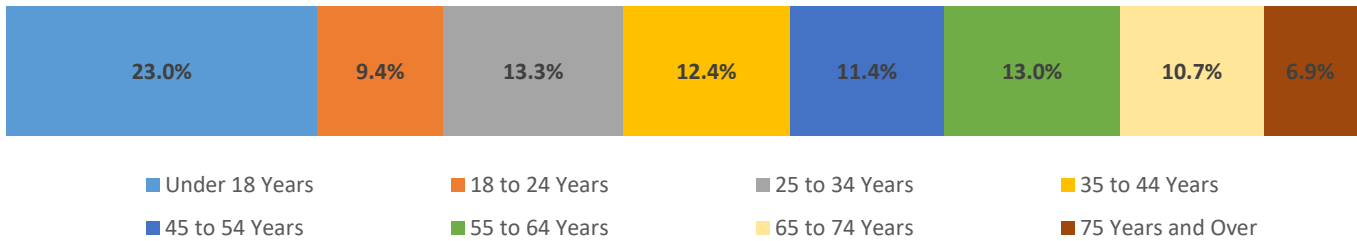

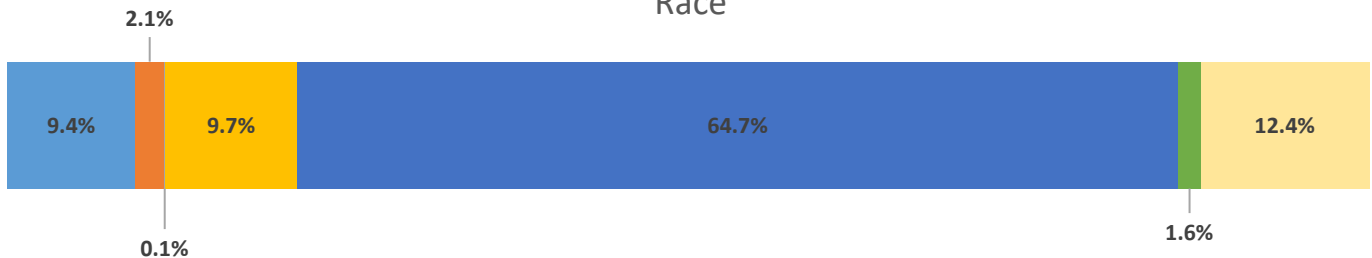
#### Population Sex

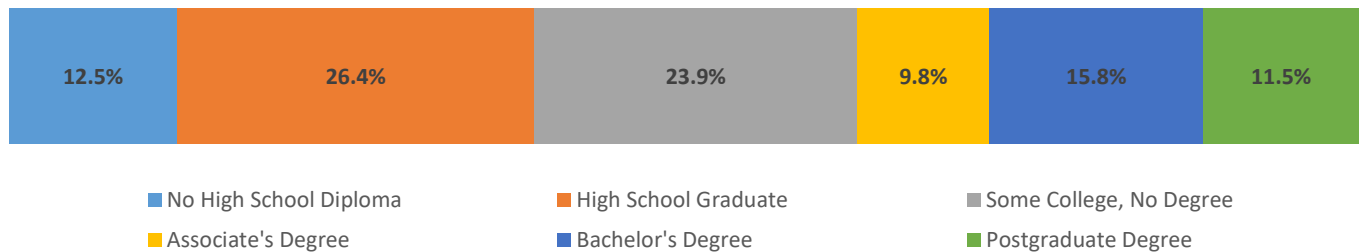
