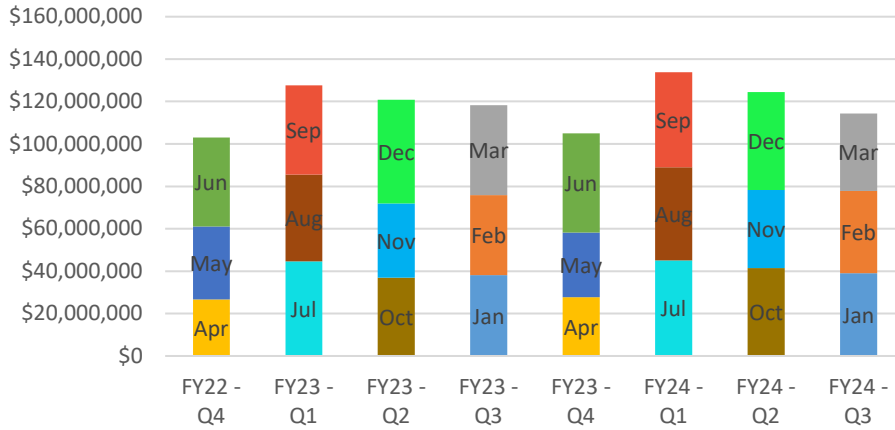

Chart 1. Matched Taxable Gross Receipts Per Quarter

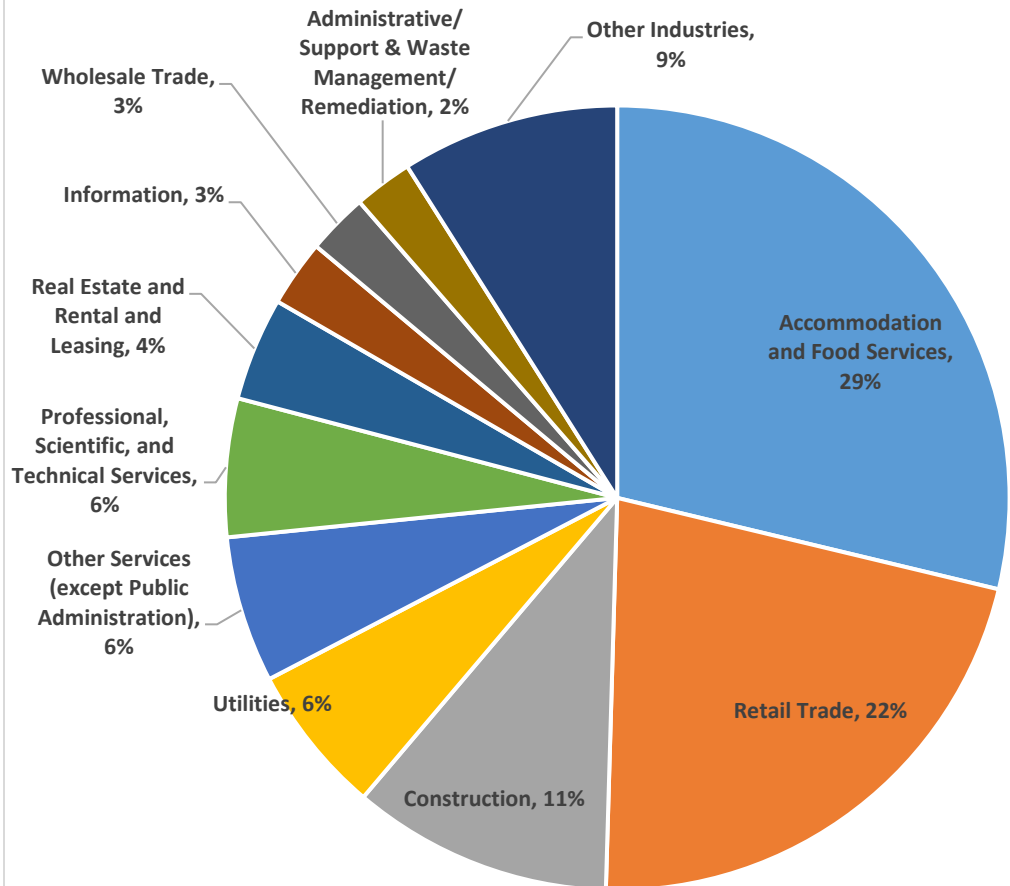

In the third quarter of FY24, 27 out of 33 counties reported positive year-over-year (YOY) economic growth, with a statewide 8.5% increase in matched taxable gross receipts (MTGR). Statewide growth was seen across most industry sectors, with construction and professional, scientific, and technical services leading. As inflation remains stubborn, employment, wages, and the number of establishments are up YOY in New Mexico.

Colfax County's MTGR decreased by 8.1%, or \$10M, from Q2 FY24 to Q3 FY24, as seen in Chart 1. The trend of increasing MTGR in Q1 followed by a decrease in Q2 and Q3 was observed in FY23 as well. According to Chart 2, the accommodation and food services industry accounted for the largest share of MTGR during Q3 FY24 (29%). Last quarter, this industry only accounted for 16%, ranking third behind retail trade and construction industries.

**Matched Taxable Gross Receipts (MTGR)** are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

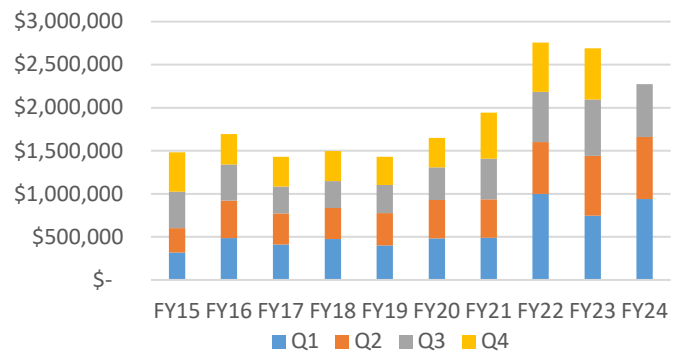

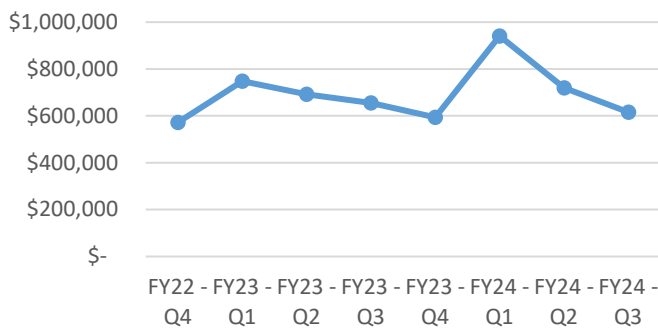
Table 1 shows that 8 industries reported a YOY increase in MTGR. The largest increase came from the accommodation and food services industry, which posted a YOY increase of \$4.6M. However, Colfax County recorded an overall net decrease in MTGR of \$3.9M, or 3%, with the largest decline coming from the construction industry. The quarterly gross receipts tax (GRT) collections during Q3 FY24 (\$615K), as seen in Chart 4, show a decrease of \$104K, or 14.5%, compared to Q2 FY24. While average employment decreased by 3.3%, or 139 YOY, average weekly wages posted an increase of \$48, or 5.7% YOY (Chart 5).

**Chart 3. Annual Total GRT Revenue Collections**



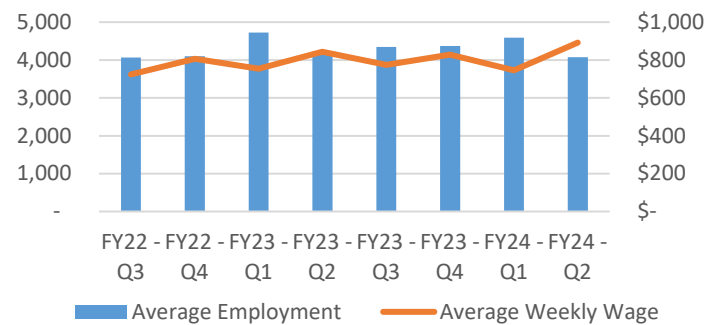

**Chart 5. Total Employment & Weekly Wage**



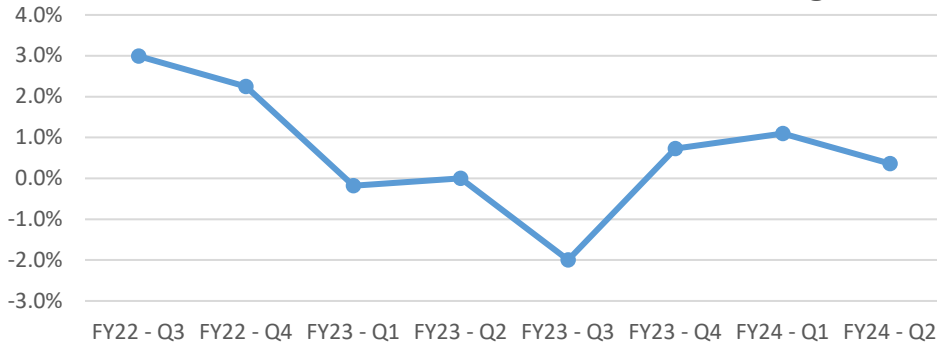

An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and is engaged, predominantly, in one type of economic activity.

The **Quarterly Census of Employment and Wages**, or the **QCEW**, used in Charts 5-6 and Table 2, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national).

Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.
