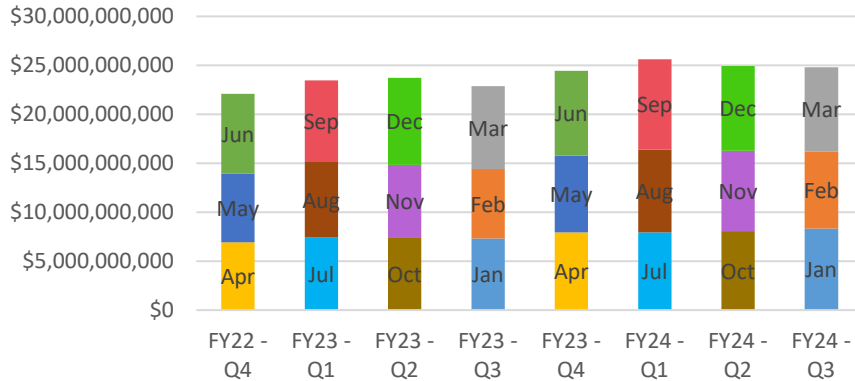

Chart 1. Matched Taxable Gross Receipts Per Quarter

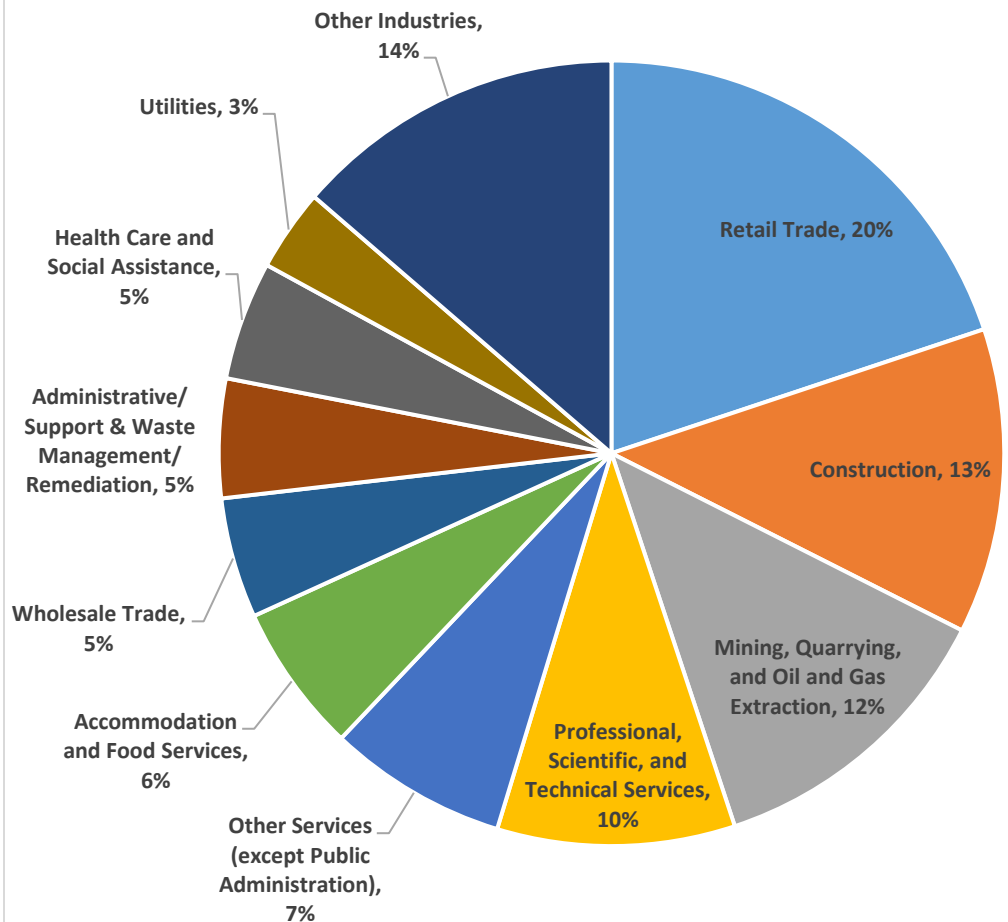

New Mexico's total matched taxable gross receipts (MTGR) in Q3 FY24 decreased by \$133M (.5%) from the previous quarter. This follows the seasonal trend in the state where Q3 typically sees a decline from Q2. The average monthly MTGR for the previous 24 months is \$7.998B, which is \$605M less than the amount reported during the month of March, the largest reported amount in Q3 FY24 (\$8.6B). Over the last 8 quarters, MTGR has maintained an upward trend (Chart 1). As seen in Chart 2, the largest industry as a percentage of MTGR was the retail trade industry, which

accounted for 20% of the total MTGR during Q3 FY24. Last quarter, the industry accounted for 22%. Table 1, on the next page, shows that the largest year-over-year (YOY) increase from the construction industry, followed by the professional, scientific, and technical services industry, as was the case in the previous quarter. Employment in New Mexico experienced YOY growth of 16,528 in Q2 FY24, as seen in Chart 5 on page 3. Average weekly wages increased YOY by \$54 in Q2 FY24, bringing it to \$1,165.

**Matched Taxable Gross Receipts (MTGR)** are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

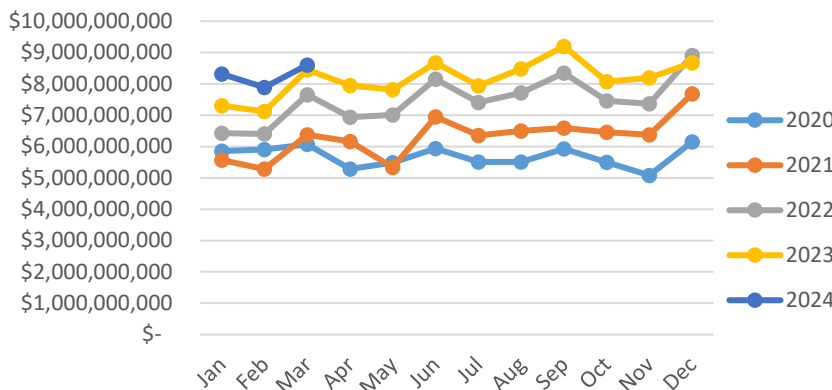

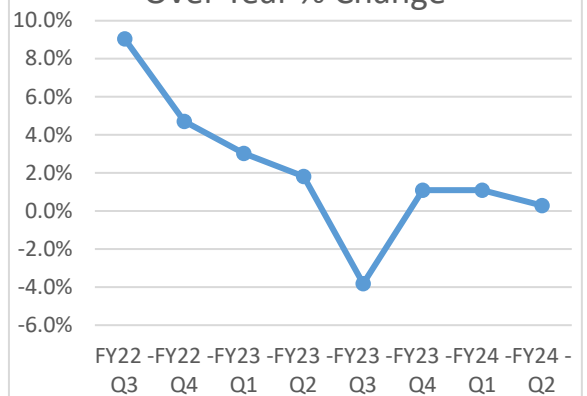
The **Quarterly Census of Employment and Wages** or the **QCEW**, used in Charts 4-5, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national). Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.

**Chart 4. Establishment Year Over Year % Change**



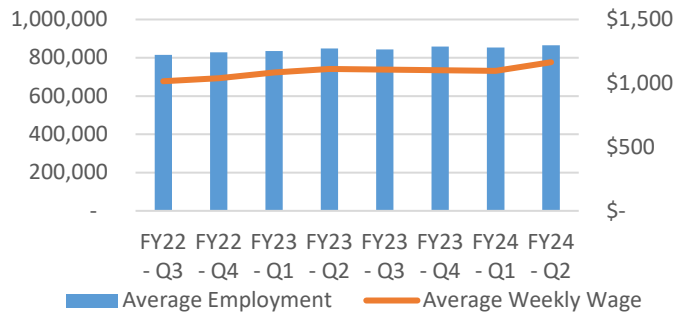

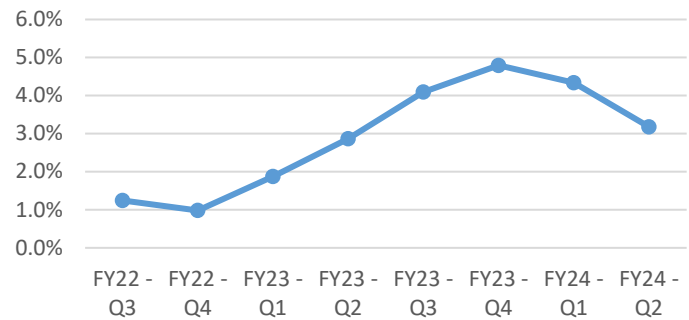


Chart 5. Total Employment & Weekly Wage

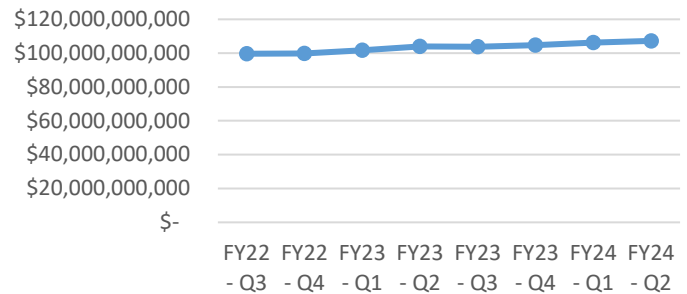
Chart 6. YOY % Change in GDP per Quarter

The value of all goods and services produced in New Mexico is the **Gross Domestic Product (GDP)**. The percentage that GDP grew (or shrank) from one period to another is an important way for the state to gauge how the economy is performing. GDP in Chart 7 and Table 2 is real GDP in chained 2017 dollars.

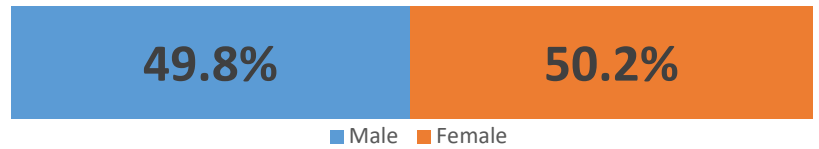

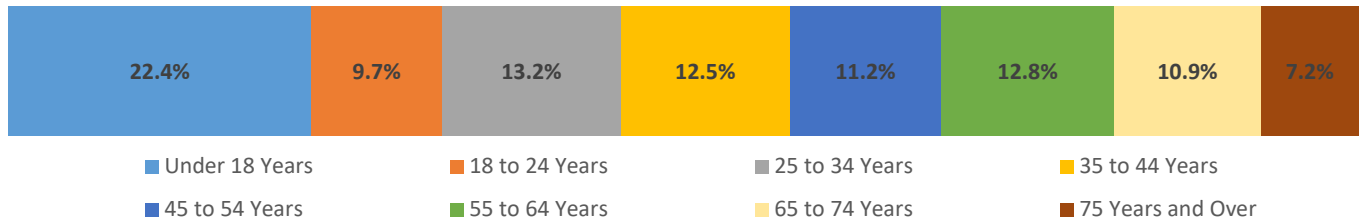

### Population Sex



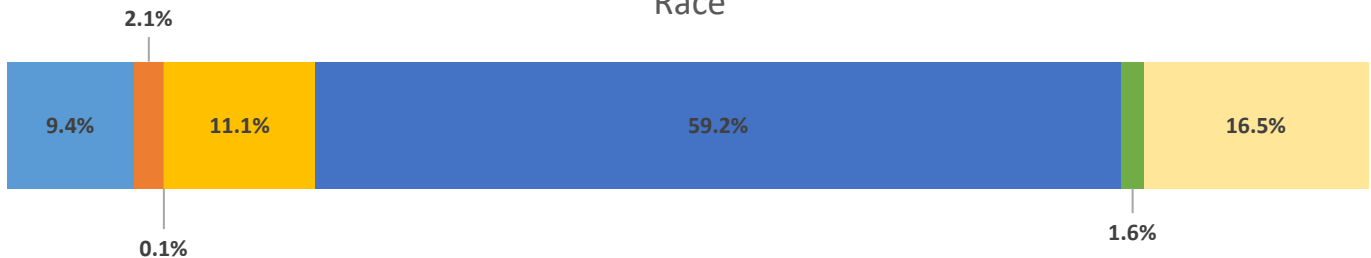

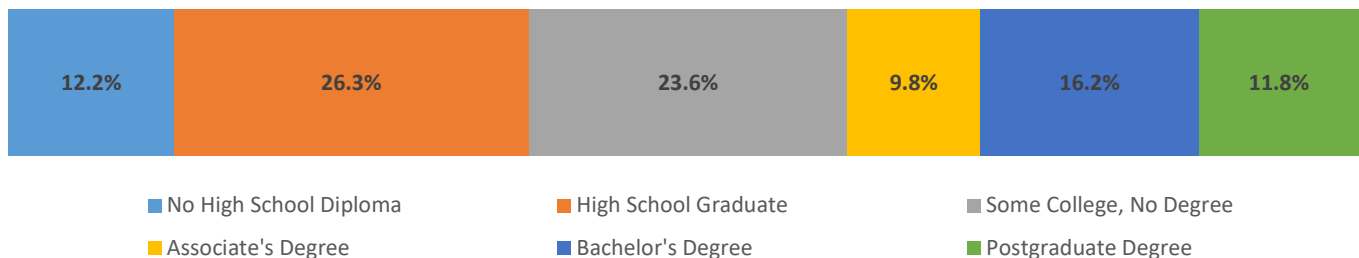
