
## Quarterly Economic Summary



In the fourth guarter of FY24, 23 out of 33 counties reported positive year-over-year (YOY) economic growth, with a statewide 3.2% increase in matched taxable gross receipts (MTGR). Statewide growth was seen across most industry sectors, with professional, scientific, and technical services and other services leading. Employment, number of wages, and the establishments are up YOY in New Mexico.

Over the last eight quarters, De Baca County's MTGR has averaged \$10.4M, which is \$1M more than the amount reported during Q4 FY24 (\$9.4M). From Q3 FY24 to Q4 FY24, MTGR decreased by 12.9%, or just under \$1.4M. Despite this decline, MTGR in the county shows an upward trend over the previous 8 quarters. As seen in Chart 2, the construction and retail trade industries accounted for 51% of total MTGR, down from 53% in Q3 FY24.

Matched Taxable Gross Receipts (MTGR) are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.








Table 1 shows that, when comparing YOY MTGR growth, the largest contribution came from the construction industry, which posted an increase of \$2.3M. The largest decline came from the other services (except public administration) industry, which posted a YOY decrease of \$105K. The quarterly gross receipts tax (GRT) collected during Q4 FY24 (\$94K) was 19.4% less than the amount collected during Q3 FY24 (\$117K), as seen in Chart 4. Over the last eight quarters, GRT collections have averaged \$122K and show an upward trend, influenced by higher than usual collections in recent quarters.





An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and is engaged, predominantly, in one type of economic activity.

The **Quarterly Census of Employment and Wages,** or the **QCEW**, used in Charts 5-6 and Table 2, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national).


Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.
