







In the fourth guarter of FY24, 23 out of 33 counties reported positive year-over-year (YOY) economic growth, with a statewide 3.2% increase in matched taxable gross receipts (MTGR). Statewide growth was seen across most industry sectors, with professional, scientific, and technical services and other Employment, services leading. the number of wages, and establishments are up YOY in New Mexico.

Over the last eight quarters, Otero County's MTGR has averaged \$355.7M, which is \$5.6M more than the MTGR reported in Q4 FY24 (\$350M). From Q3 FY24 to Q4 FY24, MTGR increased by 1.2%, or \$4.1M. Despite this increase, MTGR has shown a flat trend over the last three quarters. As seen in Chart 2, the retail trade and construction industries accounted for 46% of MTGR in Q4 FY24, slightly down from their 48% share in Q3 FY24.

Matched Taxable Gross Receipts (MTGR) are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.






Table 1 shows that, when comparing YOY MTGR changes, Otero County experienced an overall decline of 2%, or \$7.5M. While the accommodation and food services industry had the largest growth, increasing by \$3.2M, the professional, scientific, and technical services sector saw a sharp decrease of \$7.4M.

Quarterly gross receipts tax (GRT) collected during Q4 FY24 (\$3.7M) was 1.8% higher than the amount collected during Q3 FY24 (\$3.6M), as seen in Chart 4. Annual total GRT collections have shown an overall upward trend since FY 15, except for the spike in FY 22 (Chart 3).



An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and is engaged, predominantly, in one type of economic activity.

The **Quarterly Census of Employment and Wages,** or the **QCEW**, used in Charts 5-6 and Table 2, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national).

Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.
