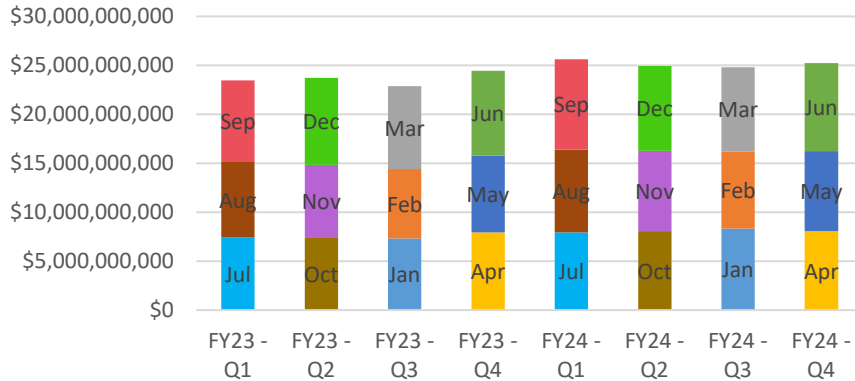

Chart 1. Matched Taxable Gross Receipts Per Quarter

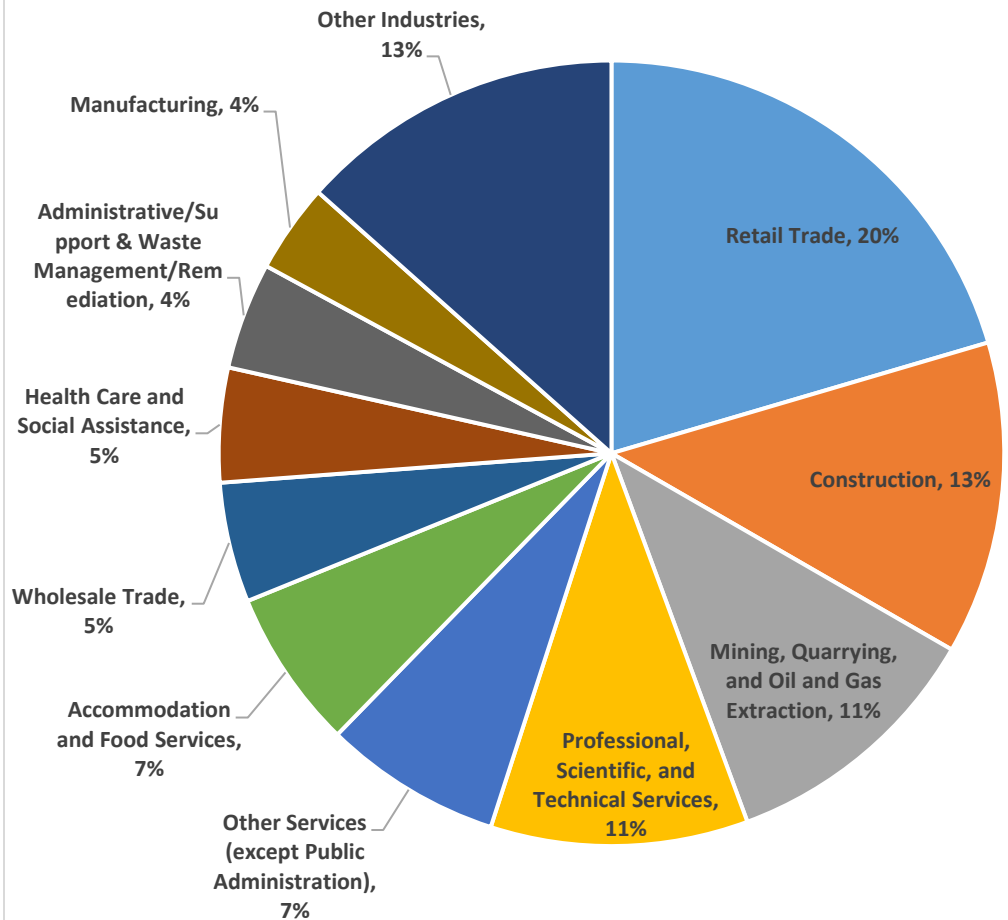

New Mexico's total matched taxable gross receipts (MTGR) in Q4 FY24 increased by \$422.4M, or 1.7%, from the previous quarter. This follows the seasonal trend in the state, where Q4 typically sees an increase from Q3. The average monthly MTGR for the past 24 months was \$8.13B, which is \$861M less than the amount reported in June, the largest monthly amount in Q4 FY24 (\$8.99B). As shown in Chart 2, the largest industry by percentage of MTGR was the retail trade industry, which accounted for 20% of total MTGR in Q4 FY24, similar to the previous quarter.

Table 1 on the next page shows that New Mexico reported an overall year-over-year (YOY) MTGR increase of 3%. The largest contributor to this growth was the professional, scientific, and technical services industry, followed by the other services industry, while the construction industry led the growth in the previous quarter. Employment in in Q3 FY24 was nearly 860K, growing by just over 15K, or 1.8%, YOY, as seen in Chart 5 on page 3. Average weekly wages increased by 4.8% YOY in Q3 FY24, bringing the average weekly wage in the state to \$1,159.

**Matched Taxable Gross Receipts (MTGR)** are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

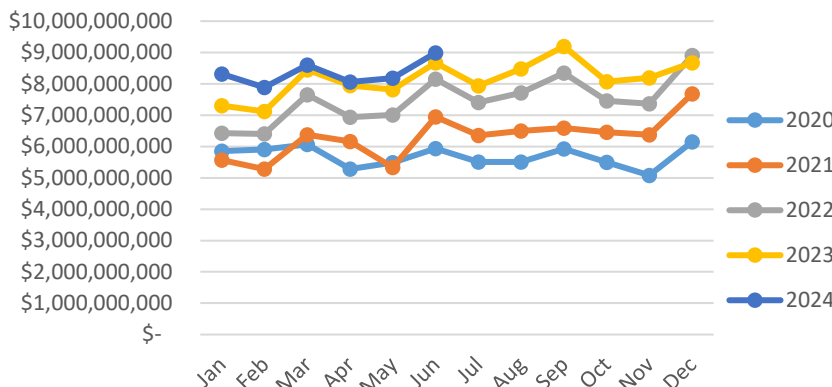

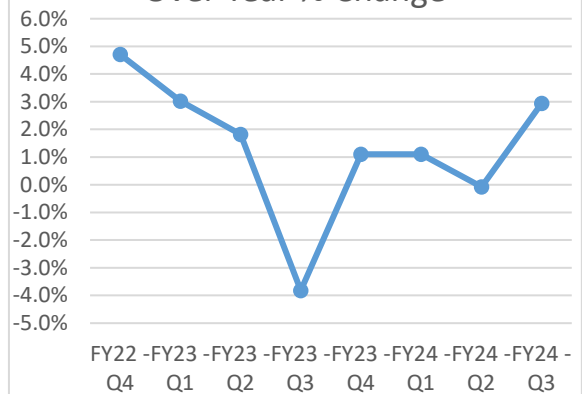
The **Quarterly Census of Employment and Wages** or the **QCEW**, used in Charts 4-5, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national). Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.

**Chart 4. Establishment Year Over Year % Change**



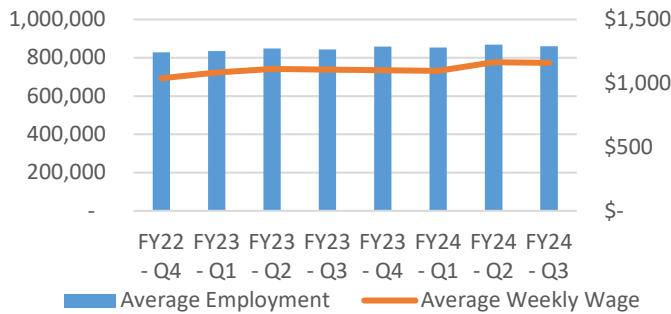

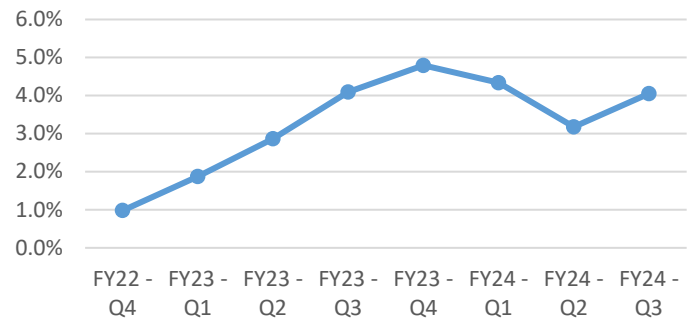


Chart 5. Total Employment & Weekly Wage

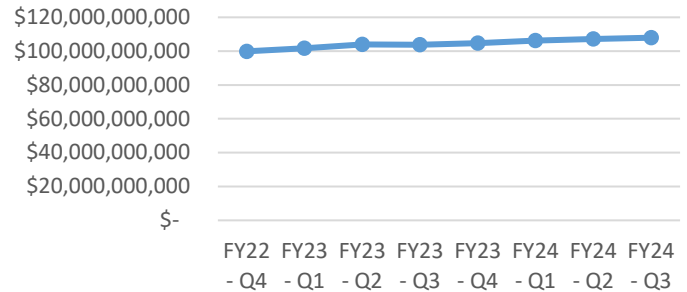
Chart 6. YOY % Change in GDP per Quarter

The value of all goods and services produced in New Mexico is the **Gross Domestic Product (GDP)**. The percentage that GDP grew (or shrank) from one period to another is an important way for the state to gauge how the economy is performing. GDP in Chart 7 and Table 2 is real GDP in chained 2017 dollars.

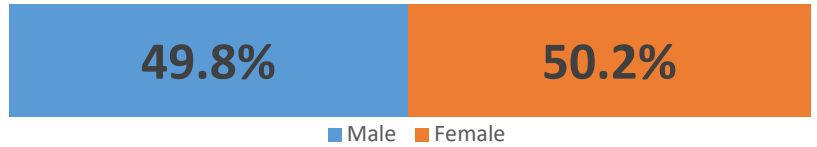

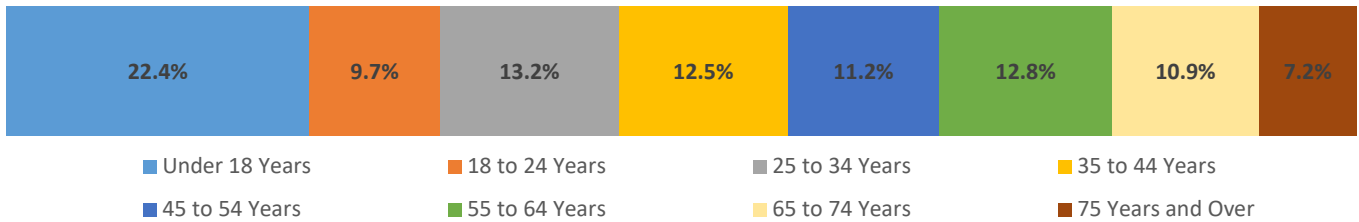

### Population Sex



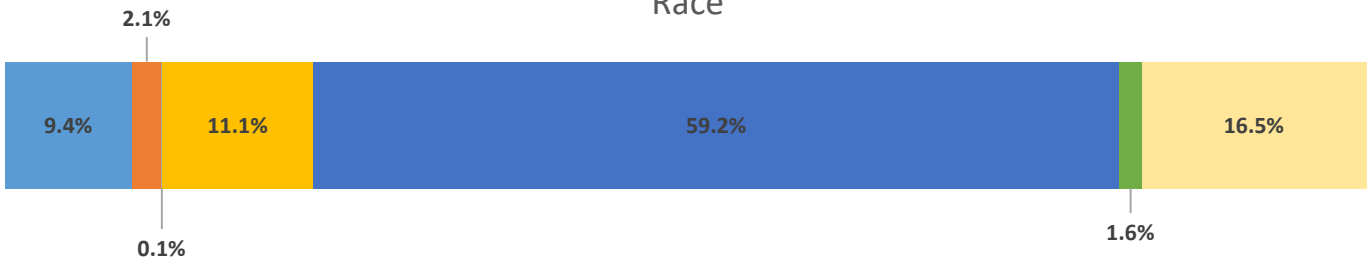

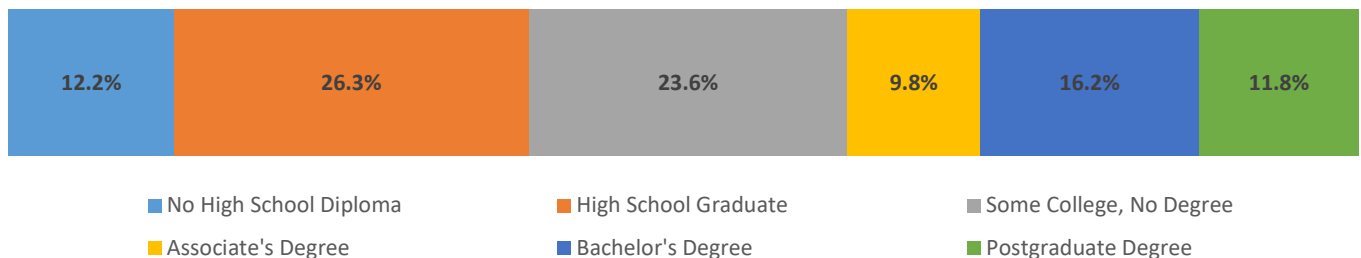
