

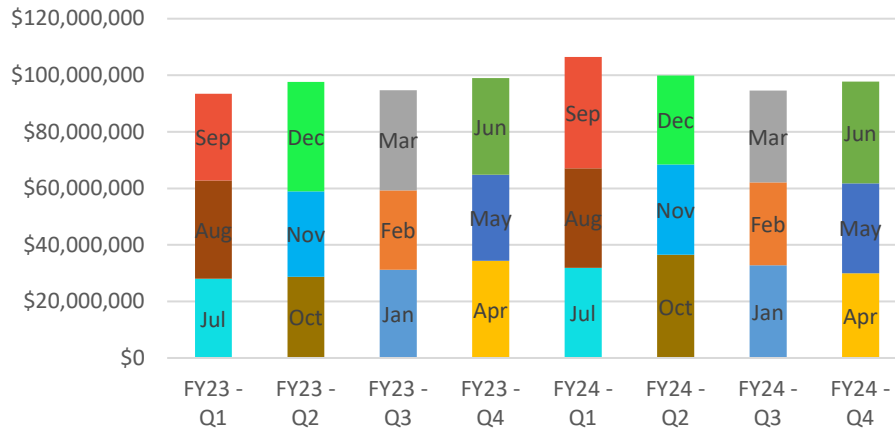

Chart 1. Matched Taxable Gross Receipts Per Quarter



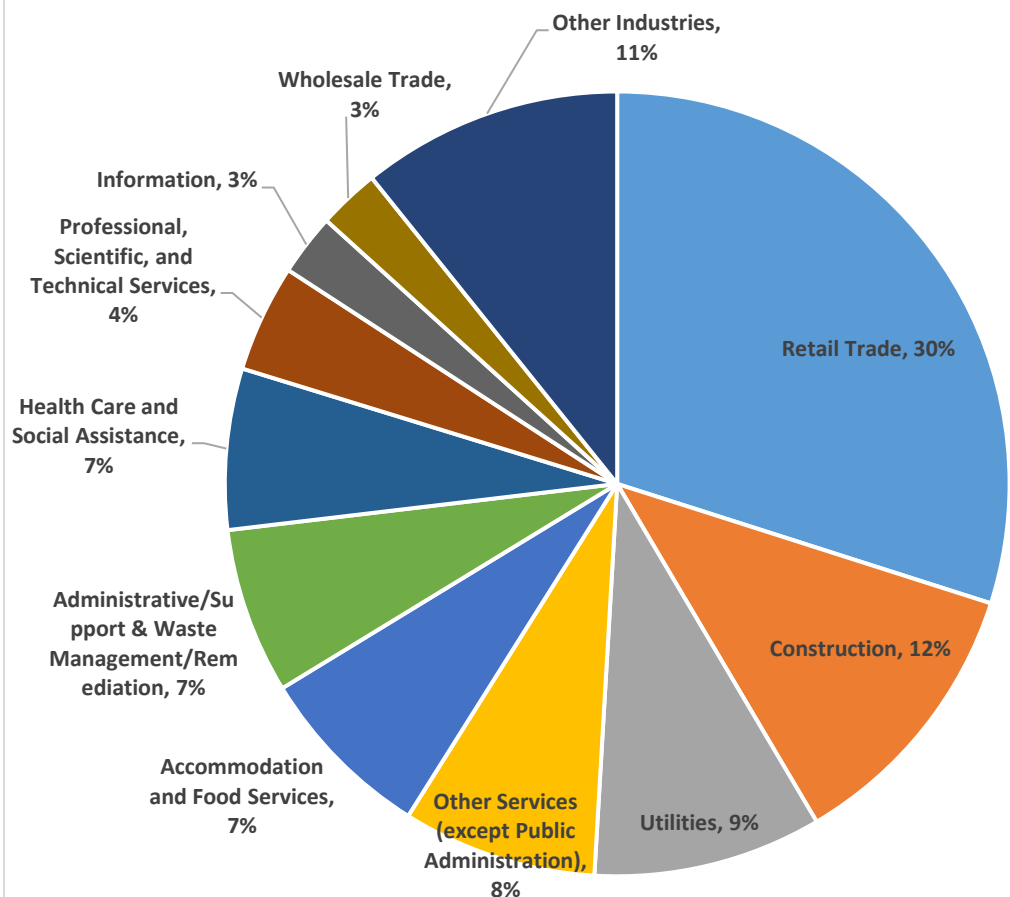

In the fourth quarter of FY24, 23 out of 33 counties reported positive year-over-year (YOY) economic growth, with a statewide 3.2% increase in matched taxable gross receipts (MTGR). Statewide growth was seen across most industry sectors, with professional, scientific, and technical services and other services leading. Employment, wages, and the number of establishments are up YOY in New Mexico.

Roosevelt County's MTGR increased by just over \$3.1M, or 3.3%, from Q3 FY24 to Q4 FY24, as shown in Chart 1. The amount reported during Q4 FY24 (\$97.7M) was \$208K lower than the eight-quarter average (\$97.9M). As seen in Chart 2, the largest industry by percentage of MTGR was the retail trade industry, accounting for 30% of total MTGR during Q4 FY24. The retail trade industry accounted for 31% of MTGR in Q3 FY24.

Matched Taxable Gross Receipts (MTGR) are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

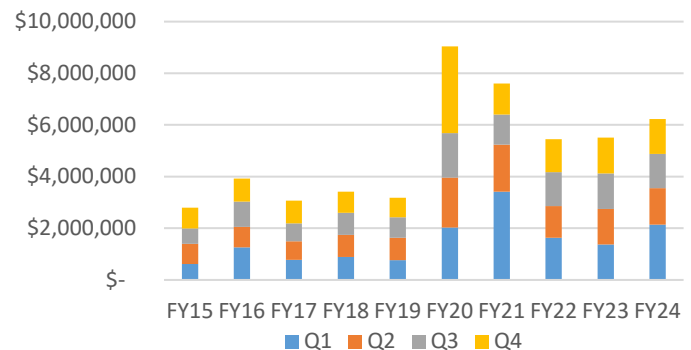

Table 1 shows that, when comparing YOY MTGR changes, Roosevelt County experienced a decrease of 1%, or \$1.3M, across all industries. Despite a \$2M increase in the administrative/support and waste management/remediation industry, the construction industry saw a \$4.1M decrease.

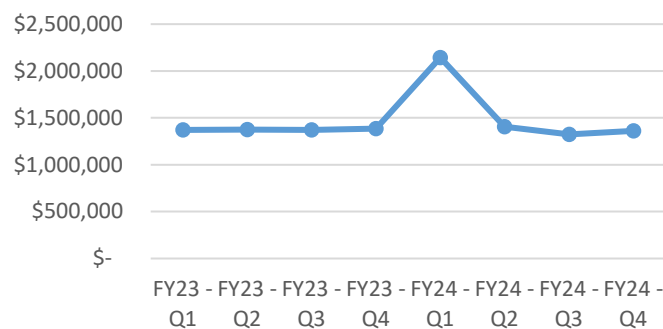
Quarterly gross receipts tax (GRT) collected during Q4 FY24 (\$1.4M) was 2.7% higher than the amount collected during Q3 FY24 (\$1.3M), as shown in Chart 4. Chart 6 on the next page depicts that the number of establishments in Roosevelt County grew by 2.4% in Q3 FY24 compared to Q3 FY23.

Chart 3. Annual Total GRT Revenue Collections



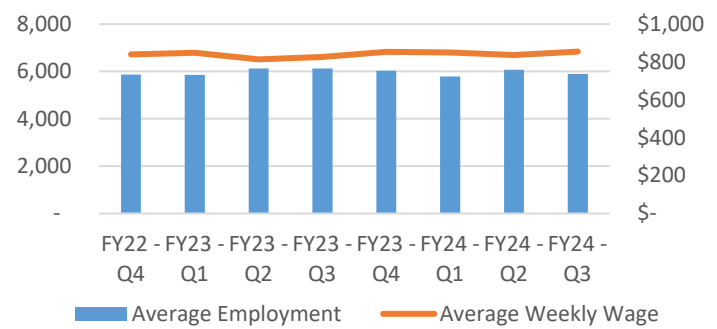

Chart 5. Total Employment & Weekly Wage



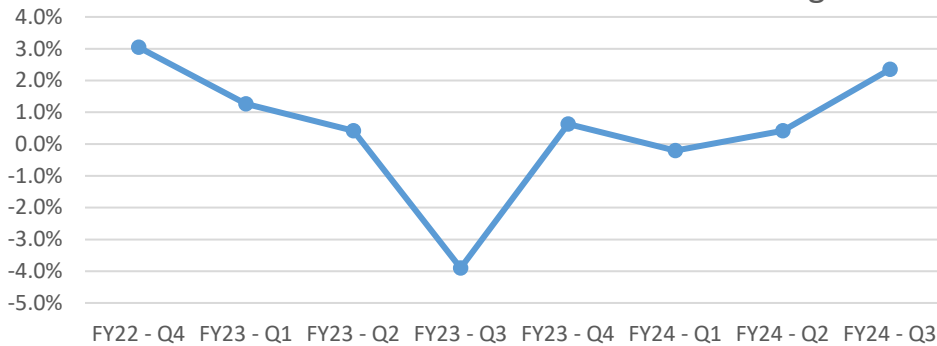

An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and is engaged, predominantly, in one type of economic activity.

The **Quarterly Census of Employment and Wages**, or the **QCEW**, used in Charts 5-6 and Table 2, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national).

Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.

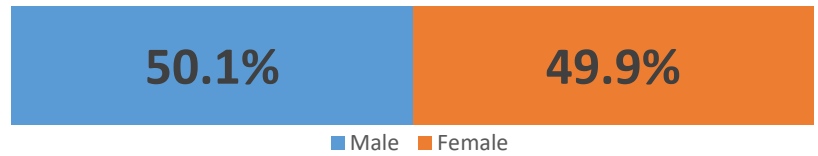

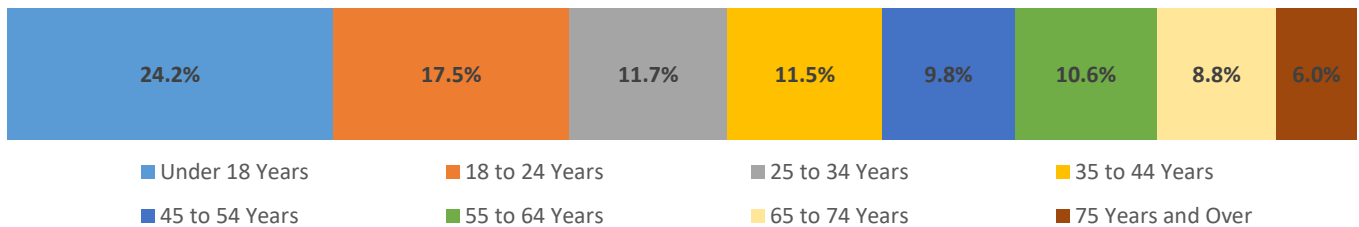

Population Sex



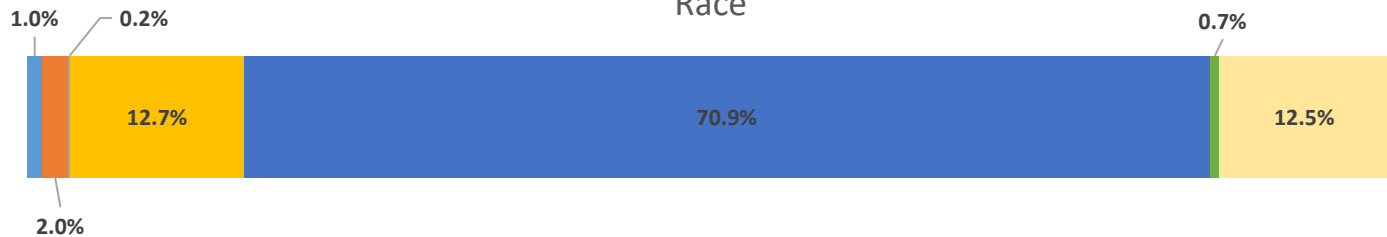

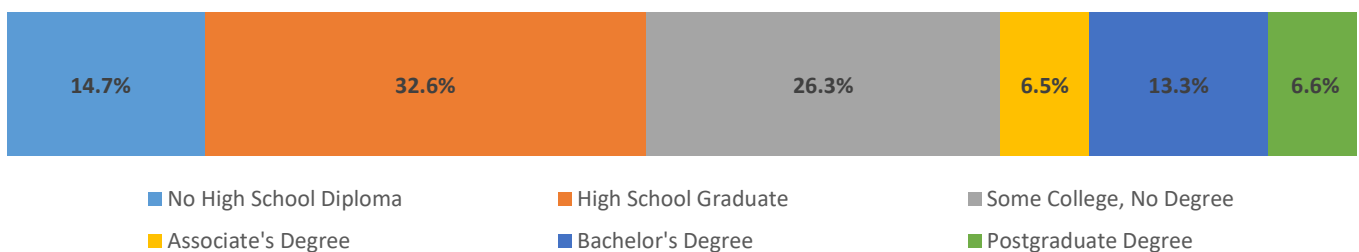
