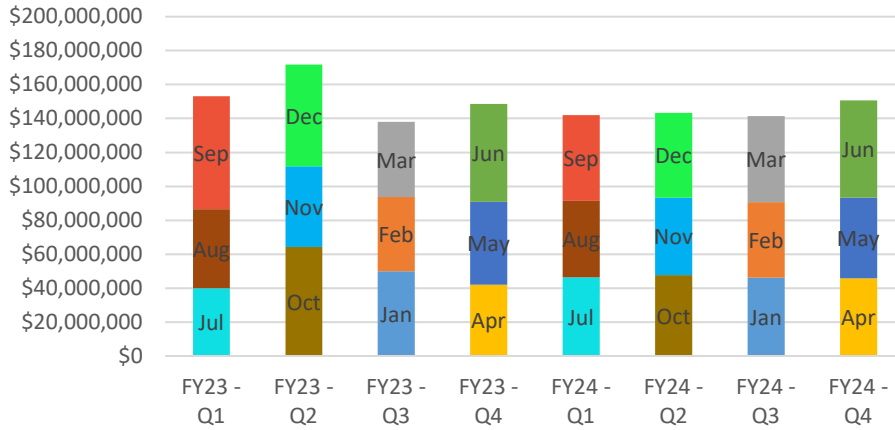

Chart 1. Matched Taxable Gross Receipts Per Quarter

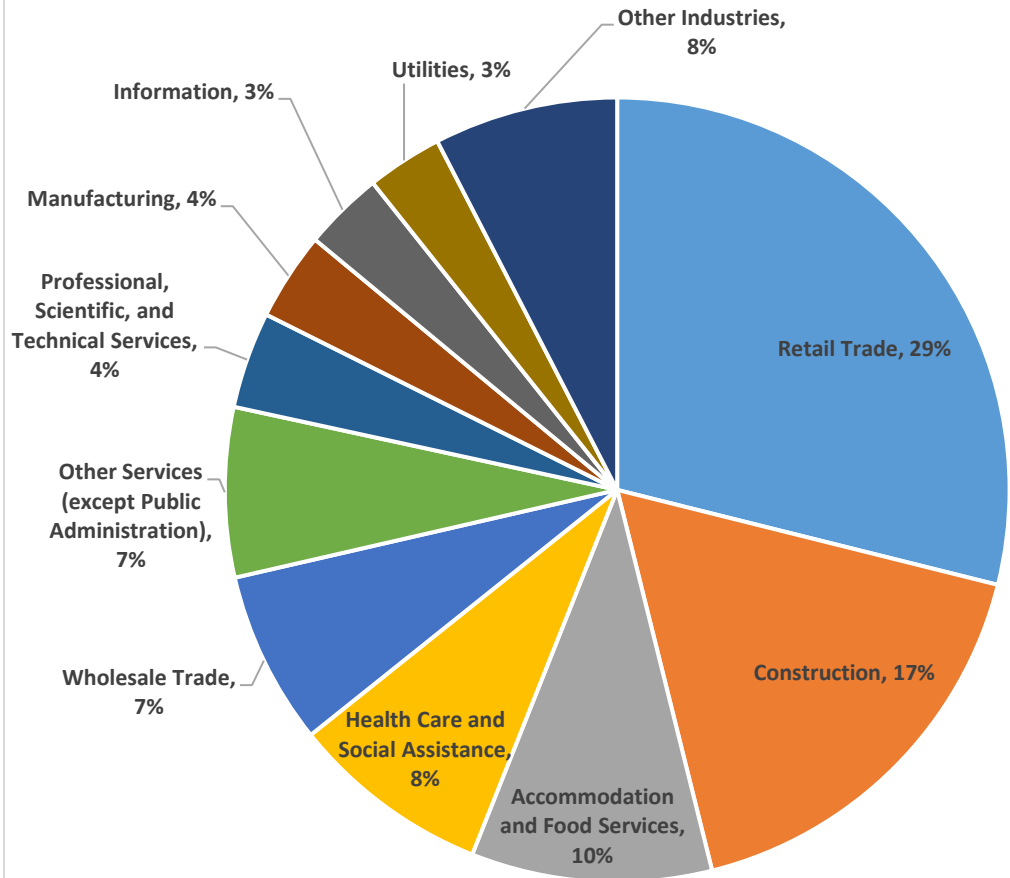

In the fourth quarter of FY24, 23 out of 33 counties reported positive year-over-year (YOY) economic growth, with a statewide 3.2% increase in matched taxable gross receipts (MTGR). Statewide growth was seen across most industry sectors, with professional, scientific, and technical services and other services leading. Employment, wages, and the number of establishments are up YOY in New Mexico.

Over the last eight quarters, San Miguel County's MTGR has averaged \$148.6M, which is \$2.1M less than the amount reported during Q4 FY24 (\$150.7M). From Q3 FY24 to Q4 FY24, MTGR increased by 6.6%, or \$9.4M. As seen in Chart 2, the retail trade and construction industries accounted for 46% of total MTGR in Q4 FY24. These industries were also the top two sectors in Q3 FY24, comprising 44% of total MTGR.

Matched Taxable Gross Receipts (MTGR) are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

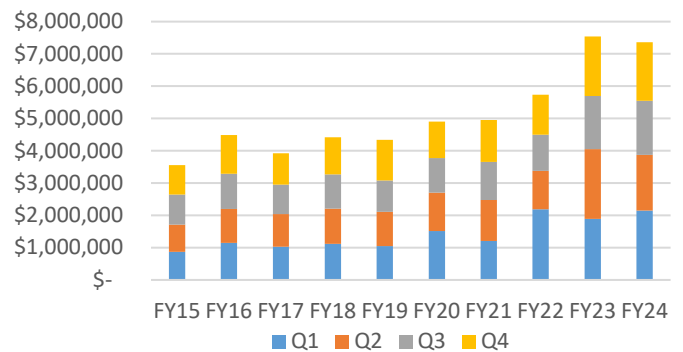

Table 1 shows that when comparing YOY MTGR growth, the largest contribution came from the wholesale trade industry, with a YOY increase of \$7.6M. This increase was mostly offset by a \$6.9M YOY decrease in the construction industry.

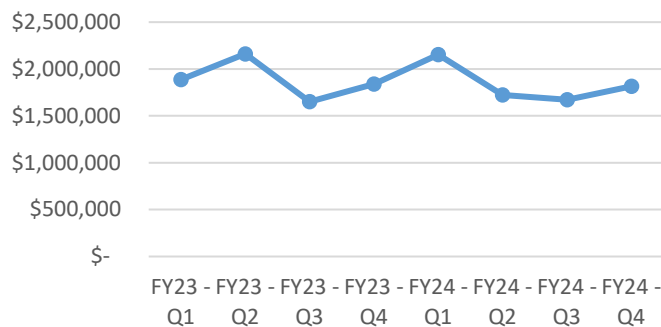
Quarterly gross receipts tax (GRT) collected during Q4 FY24 was 8.6% higher than the amount collected during Q3 FY24, as shown in Chart 4. Chart 5 indicates that total average employment in San Miguel County grew by 228, or 3%, YOY in Q3 FY24. Average weekly wages in Q3 FY24 also experienced a YOY increase of \$42, or 5.4%.

Chart 3. Annual Total GRT Revenue Collections



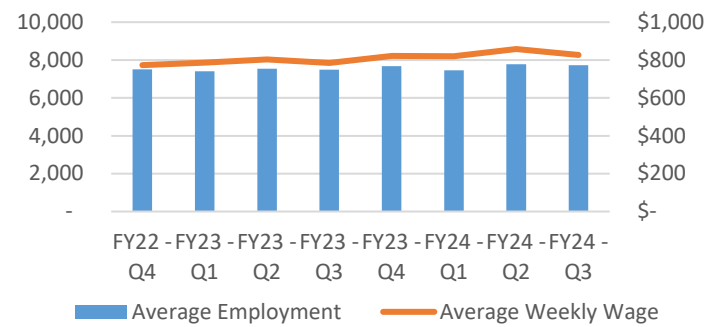

Chart 5. Total Employment & Weekly Wage



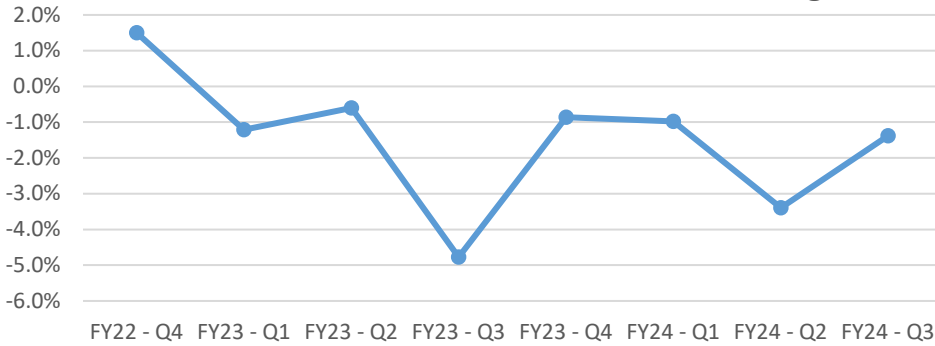

An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and is engaged, predominantly, in one type of economic activity.

The **Quarterly Census of Employment and Wages**, or the **QCEW**, used in Charts 5-6 and Table 2, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national).

Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.

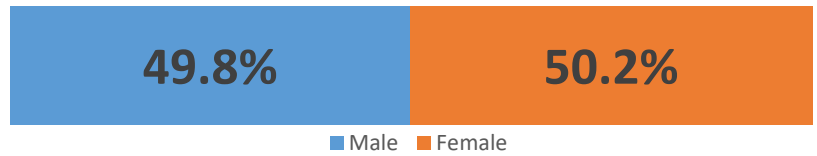

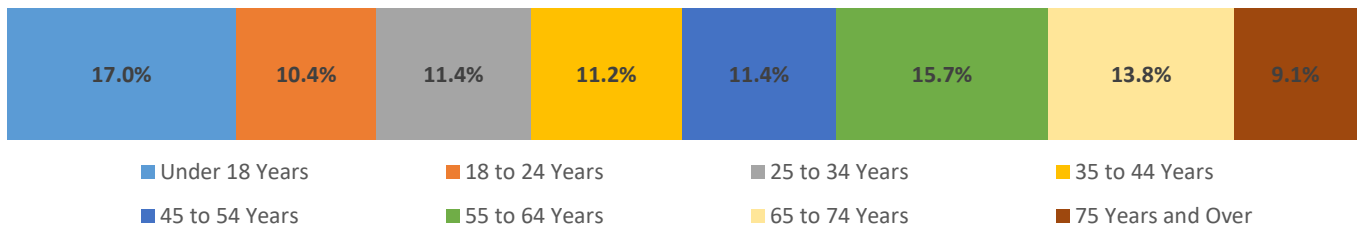

Population Sex



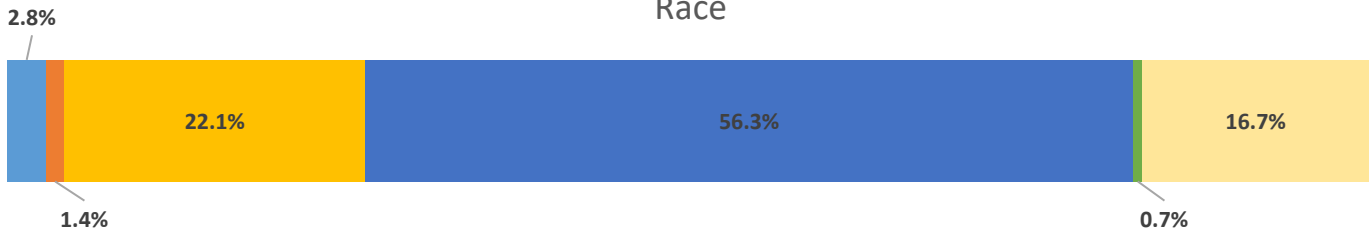

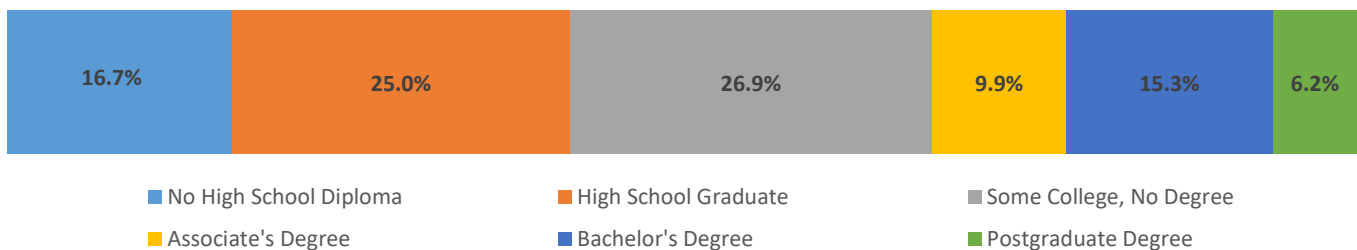
