

In the fourth quarter of FY24, 23 out of 33 counties reported positive year-over-year (YOY) economic growth, with a statewide 3.2% increase in matched taxable gross receipts (MTGR). Statewide growth was seen across most industry sectors, with professional, scientific, and technical services and other services leading. Employment, number of wages, and the establishments are up YOY in New Mexico.

Santa Fe County's MTGR increased by \$255.6M, or 17%, from Q3 FY24 to Q4 FY24, as shown in Chart 1. The amount reported during Q4 FY24 (\$1.76B) was \$154.6M higher than the eight-quarter average of \$1.61B. Chart illustrates that the largest industry by percentage of MTGR was the retail trade industry, which accounted for 25% of the total in Q4 FY24, slightly down from its 27% share in the previous quarter.

Matched Taxable Gross Receipts (MTGR) are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.










Table 1 shows that Santa Fe County recorded an overall 7% growth in MTGR YOY. The largest increase came from the professional, scientific, and technical services industry, which posted a YOY increase of \$50.3M. The largest decline came from the retail trade industry, with a YOY decrease of nearly \$18M.


Quarterly gross receipts tax (GRT) collections in Q4 FY24 (\$26.3M), as seen in Chart 4, increased by \$3.6M, or 15.7%, compared to Q3 FY24. Table 2 on the next page show that total employment, average weekly wages, and the number of establishments increased YOY in Q3 FY24.











An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and is engaged, predominantly, in one type of economic activity.

The **Quarterly Census of Employment and Wages**, or the **QCEW**, used in Charts 5-6 and Table 2, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national).

Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.
