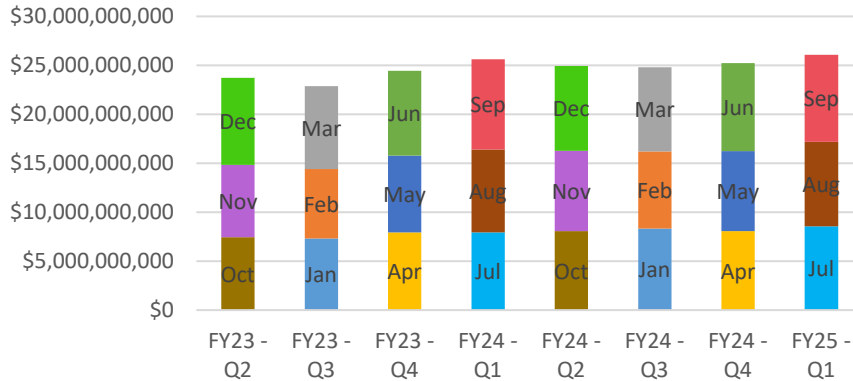

Chart 1. Matched Taxable Gross Receipts Per Quarter

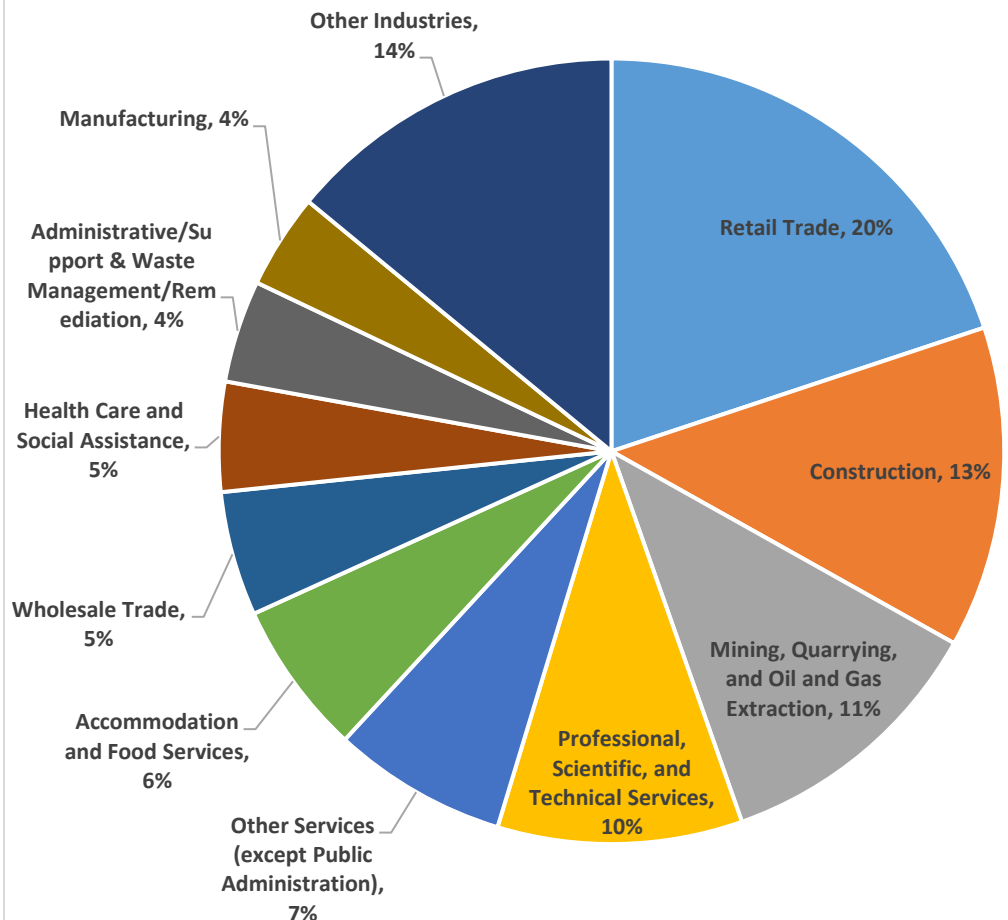

New Mexico's total matched taxable gross receipts (MTGR) in Q1 FY25 increased by \$840M (3.3%) from the previous quarter. This follows the seasonal trend in the state, where Q1 typically experiences growth compared to Q4. The average monthly MTGR over the past 24 months is \$8.237B, which is \$638.5M less than the amount reported in September—the highest MTGR reported in Q1 FY25 at \$8.876B. Over the last eight quarters, MTGR has maintained an upward trend (Chart 1). As shown in Chart 2, retail trade remained the largest industry by MTGR

percentage, maintaining a 20% share consistent with the previous quarter. Table 1 on the next page shows that the largest year-over-year (YOY) increase came from the construction industry, followed by the professional, scientific, and technical services industry. With their growth, New Mexico posted an overall 2% YOY increase in MTGR. Employment in New Mexico experienced YOY growth of 11,316 (1.3%) in Q4 FY24, as seen in Chart 5 on page 3. Average weekly wages increased YOY by \$49 (4.4%) in Q4 FY24, reaching \$1,151.

Matched Taxable Gross Receipts (MTGR) provide the most accurate tax data for assessing underlying economic activity. The data collection process involves matching tax payments with reported receipts for each taxpayer by industry.

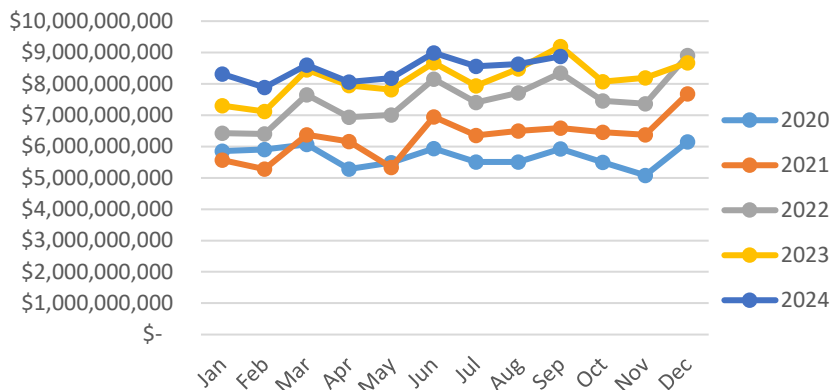

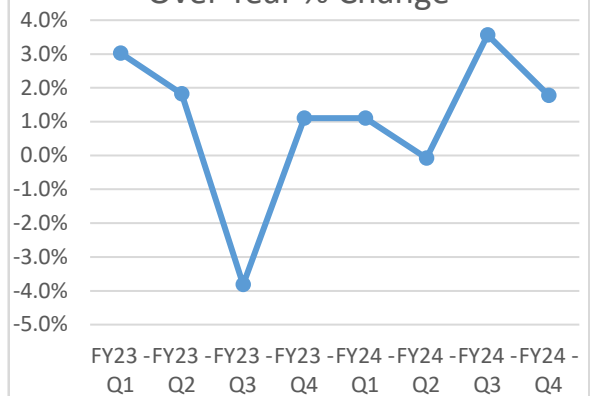
The **Quarterly Census of Employment and Wages** or the **QCEW**, referenced in Charts 4-5, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws, as well as federal workers covered under the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated across various levels, starting from the 6-digit NAICS industry level to broader industry categories (such as NAICS industry groups, sectors, and supersectors) and geographic levels (including metropolitan statistical areas, state, and national levels). Based on information reported by New Mexico employers, the data cover 97% of nonfarm wage and salary workers and are published quarterly. Renowned for their reliability, QCEW data are considered the gold standard for industry statistics, offering the most complete universe of monthly employment and quarterly wage information by detailed industry.

Chart 4. Establishment Year Over Year % Change



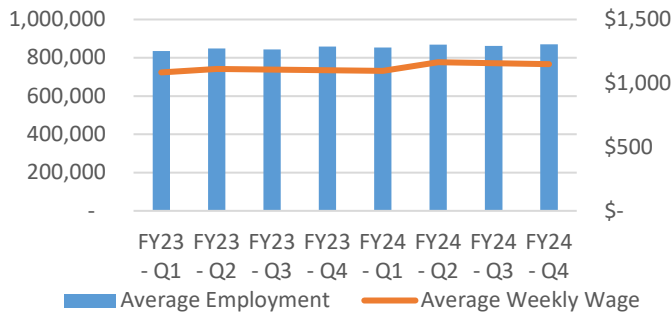

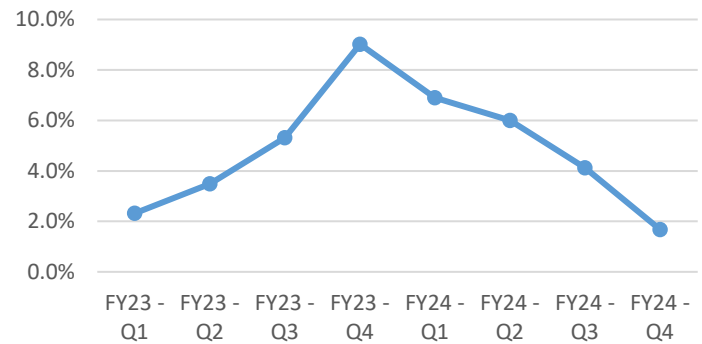


Chart 5. Total Employment & Weekly Wage

Gross Domestic Product (GDP) measures the value of all goods and services produced within New Mexico. Changes in GDP from one period to another are important indicators of the state's economic performance. Chart 7 provides quarterly statewide GDP, while Table 2 below details a breakdown of GDP by industry and their YOY changes. Both Chart 7 and Table 2 present real GDP figures, adjusted to chained 2017 dollars.

Chart 7. Gross Domestic Product Per Quarter

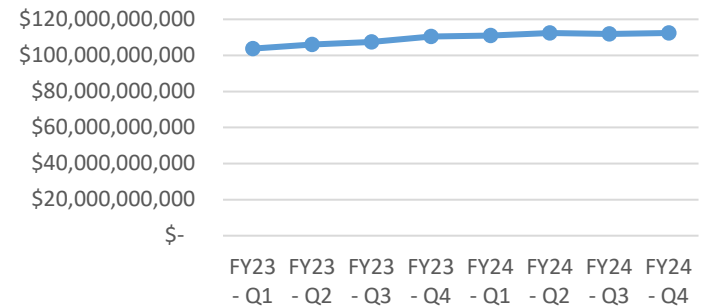
