
Quarterly Economic Summary Chaves County



In the first quarter of FY25, 20 out of 33 counties reported positive year-over-year (YOY) economic growth compared to Q1 FY24, with a statewide 1.8% increase in matched taxable gross receipts (MTGR). Statewide growth was observed across most industry sectors, with the construction industry leading the way. Employment, wages, and the number of establishments have also increased YOY at the state level.

Chaves County's MTGR in Q1 FY25 totaled \$455.6M (Chart 1). This is a 1.2% increase compared Q4 FY24 (\$450.4M) and \$13.1M higher than the eight-quarter average (\$442.5M). The largest industry percentage of MTGR was the retail trade industry, accounting for 31% of MTGR in Q1 FY25, as seen in Chart 2. Retail trade also the **largest** was industry the previous in quarter, comprising 32%.

Matched Taxable Gross Receipts (MTGR) provide the most accurate tax data for assessing underlying economic activity. The data collection process involves matching tax payments with reported receipts for each taxpayer by industry.








Table 1 shows that 10 industries reported a YOY increase in MTGR. The largest increase came from the manufacturing industry, which posted a YOY increase of \$9.1M. However, Chaves County recorded an overall net 0% change in MTGR, with the largest decline coming from the healthcare and social assistance industry. Quarterly gross receipts tax (GRT) collections during Q1 FY25 (\$6.7M), as seen in Chart 4, show an increase of 45%, or nearly \$2.1M, compared to Q4 FY24. Total employment increased by 1.2%, or 249, YOY, while average weekly wages increased by 6.3%, or \$55, YOY (Chart 5).



An establishment, as defined by the Quarterly Census of Employment and Wages (QCEW) and referenced in Chart 6, is an economic unit, such as a farm, factory, or store, located at a single physical address and engaged in one type of economic activity.

Gross Domestic Product (GDP) measures the value of all goods and services produced within a specific area. Changes in GDP from one period to another are important indicators of how the economy is performing. Chart 7 illustrates the YOY percentage change in real GDP for calendar years. Table 2 below details the percentage contribution of each industry to the total GDP for a specific county and how each industry's GDP changed compared to the previous calendar year.


