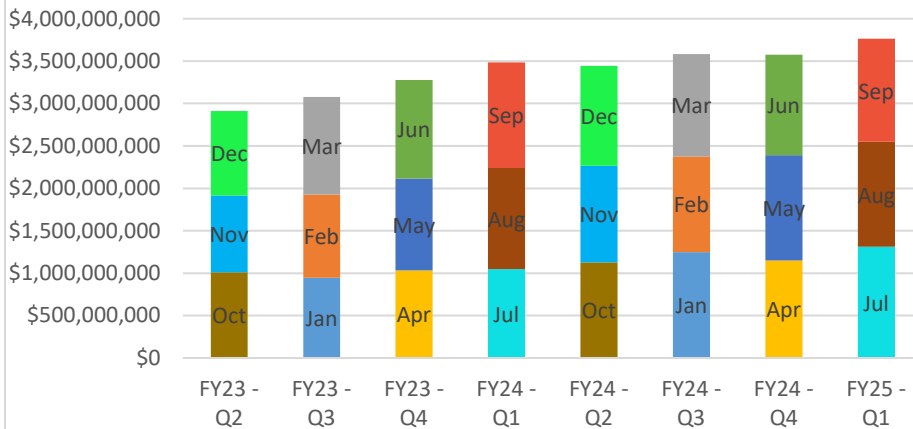

Chart 1. Matched Taxable Gross Receipts Per Quarter

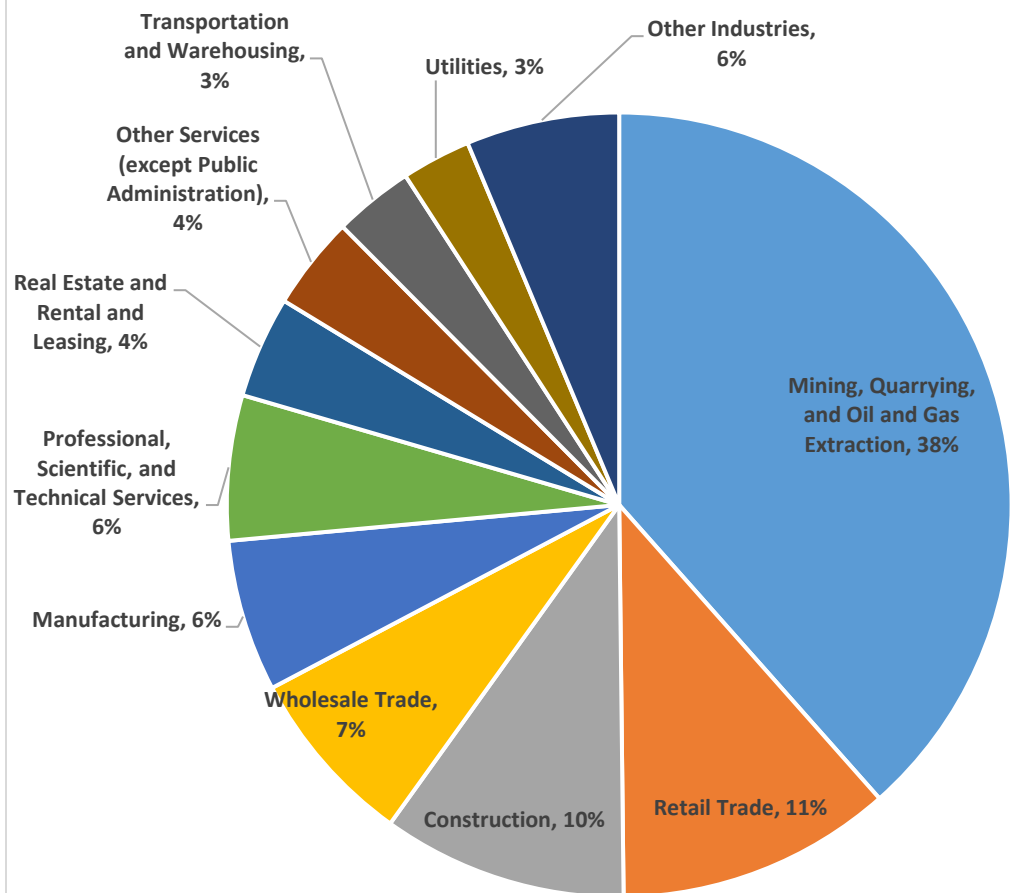

In the first quarter of FY25, 20 out of 33 counties reported positive year-over-year (YOY) economic growth compared to Q1 FY24, with a statewide 1.8% increase in matched taxable gross receipts (MTGR). Statewide growth was observed across most industry sectors, with the construction industry leading the way. Employment, wages, and the number of establishments have also increased YOY at the state level.

Over the last eight quarters, Eddy County's MTGR has averaged \$3.39B, which is \$374M less than the amount reported during Q1 FY25 (\$3.76B). From Q4 FY24 to Q1 FY25, MTGR increased by 5.3%, or \$189M. With this increase, MTGR in the county shows an upward trend (Chart 1). Chart 2 shows that mining, quarrying, and oil and gas extraction remained the largest industry, accounting for 38% of total MTGR, similar to its 37% share in Q4 FY24.

**Matched Taxable Gross Receipts (MTGR)** provide the most accurate tax data for assessing underlying economic activity. The data collection process involves matching tax payments with reported receipts for each taxpayer by industry.

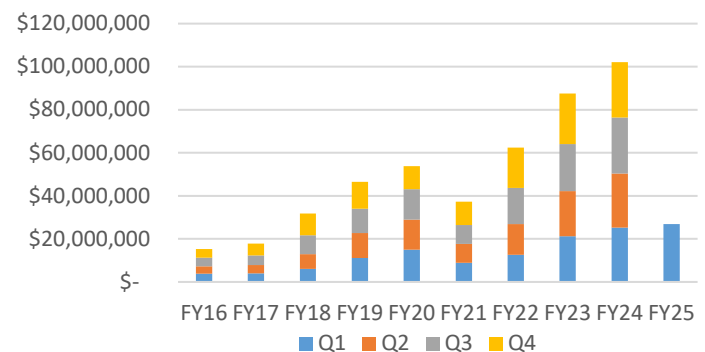

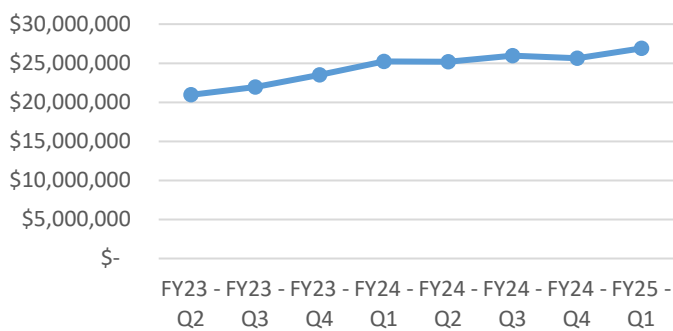
Table 1 shows that, when comparing YOY MTGR growth, the largest contribution came from the mining, quarrying, and oil and gas extraction industry, which posted a YOY increase of \$133.5M. The largest decline came from the wholesale trade industry, which posted a YOY decrease of \$62.4M.

Quarterly gross receipts tax (GRT) collected during Q1 FY25 (\$26.9M) was 5% more than the amount collected during Q4 FY24 (\$25.6M), as seen in Chart 4. Over the last eight quarters, GRT collections have averaged \$24.4M and have shown an upward trend.

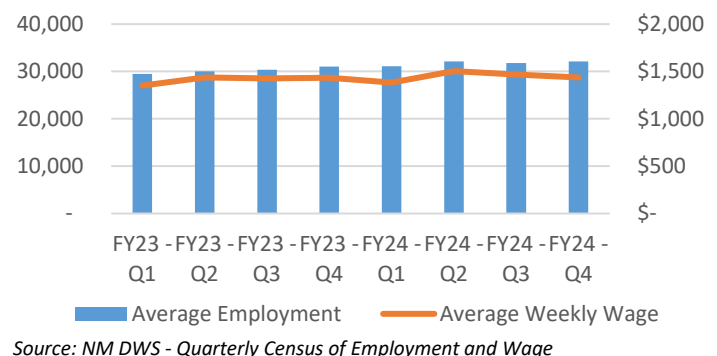
**Chart 3. Annual Total GRT Revenue Collections**

**Chart 5. Total Employment & Weekly Wage**

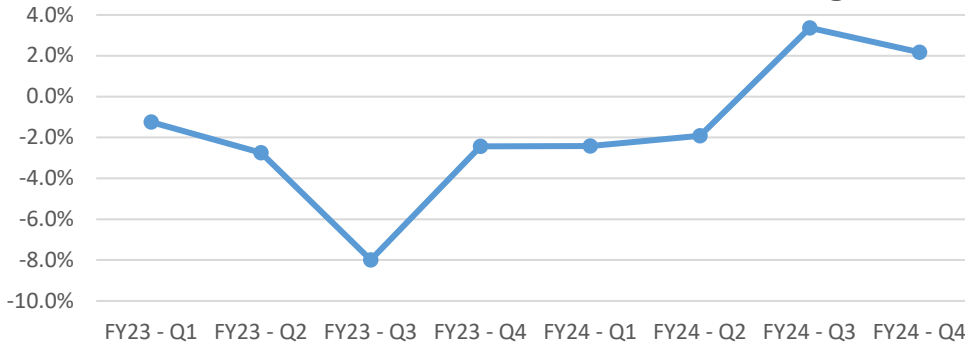

Chart 6. Establishment Year Over Year % Change

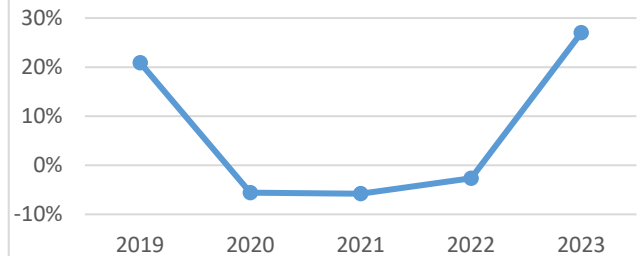

An **establishment**, as defined by the Quarterly Census of Employment and Wages (QCEW) and referenced in Chart 6, is an economic unit, such as a farm, factory, or store, located at a single physical address and engaged in one type of economic activity.

**Gross Domestic Product (GDP)** measures the value of all goods and services produced within a specific area. Changes in GDP from one period to another are important indicators of how the economy is performing. Chart 7 illustrates the YOY percentage change in real GDP for calendar years. Table 2 below details the percentage contribution of each industry to the total GDP for a specific county and how each industry's GDP changed compared to the previous calendar year.

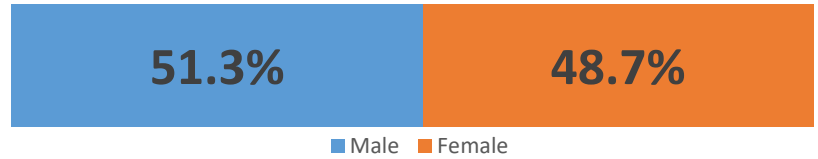

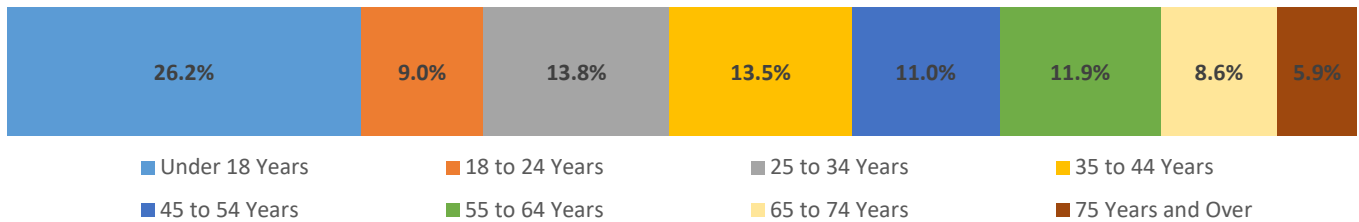

### Population Sex



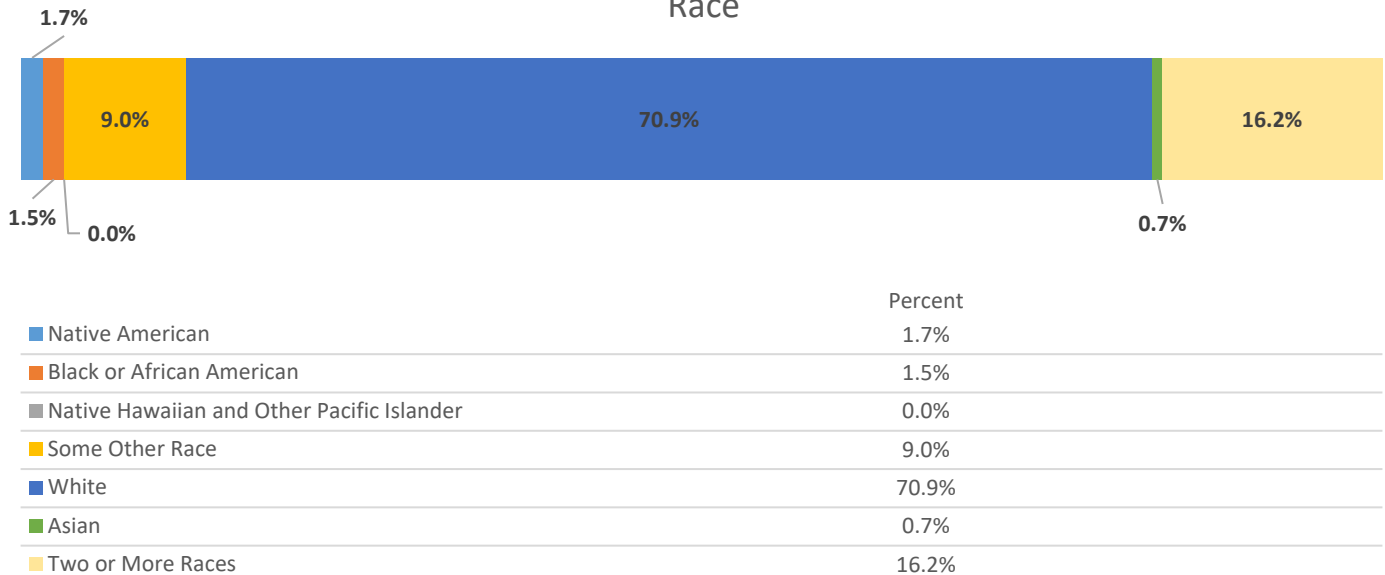

### Population Age



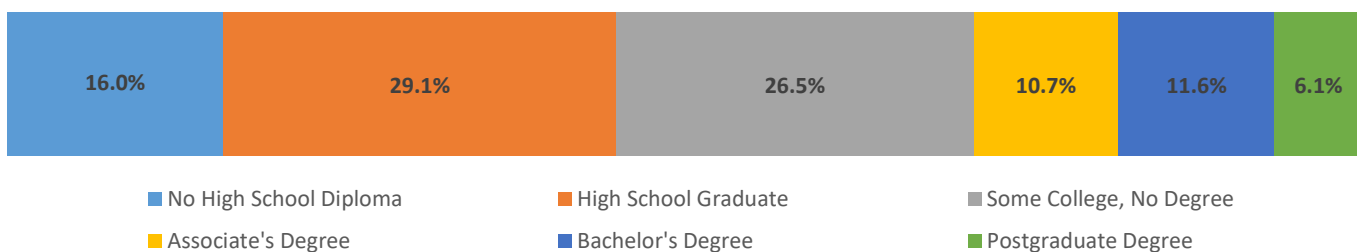
