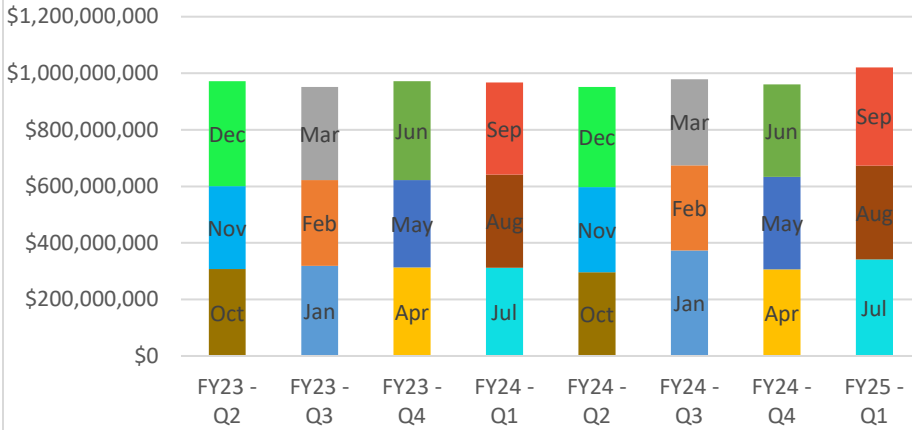

Chart 1. Matched Taxable Gross Receipts Per Quarter

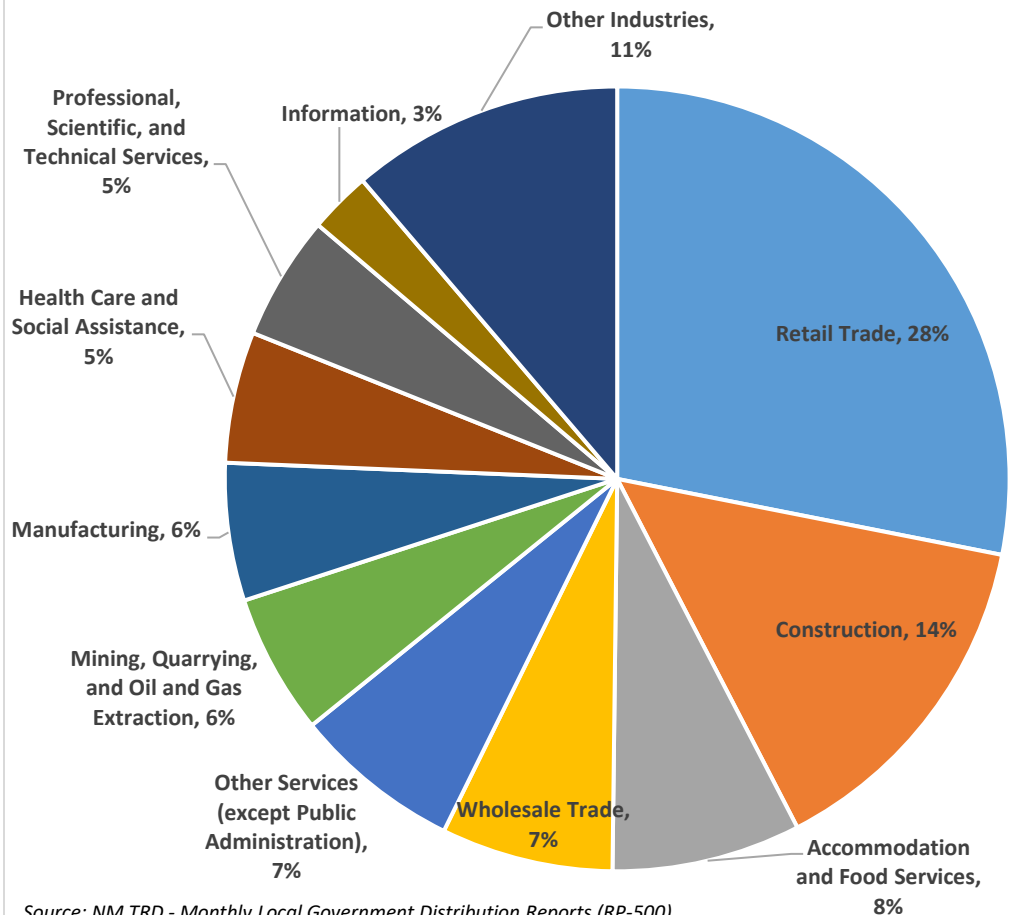

In the first quarter of FY25, 20 out of 33 counties reported positive year-over-year (YOY) economic growth compared to Q1 FY24, with a statewide 1.8% increase in matched taxable gross receipts (MTGR). Statewide growth was observed across most industry sectors, with the construction industry leading the way. Employment, wages, and the number of establishments have also increased YOY at the state level.

San Juan County's MTGR increased by nearly \$60.2M, or 6.3%, from Q4 FY24 to Q1 FY25, as seen in Chart 1. The amount reported during Q1 FY25 (\$1.02B) was \$49M larger than the eight-quarter average (\$972M). As seen in Chart 2, the largest industry as a percentage of MTGR was the retail trade industry, followed by the construction industry. These two industries were also the top two industries in the previous quarter.

Matched Taxable Gross Receipts (MTGR) provide the most accurate tax data for assessing underlying economic activity. The data collection process involves matching tax payments with reported receipts for each taxpayer by industry.

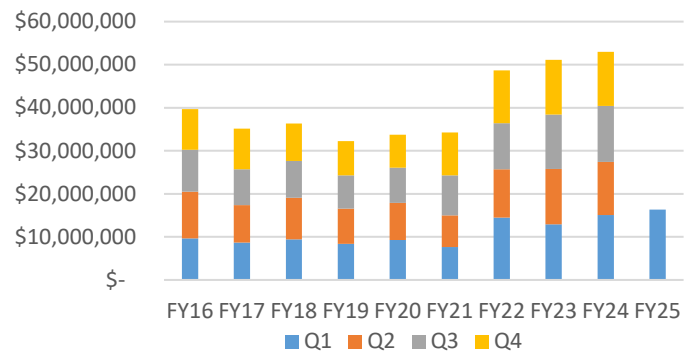

Table 1 shows that all but 6 industries reported a YOY increase. The largest increase came from the construction industry, which posted a YOY increase of \$33.9M. The largest decline came from the utilities industry, which posted a YOY decrease of \$16.2M.

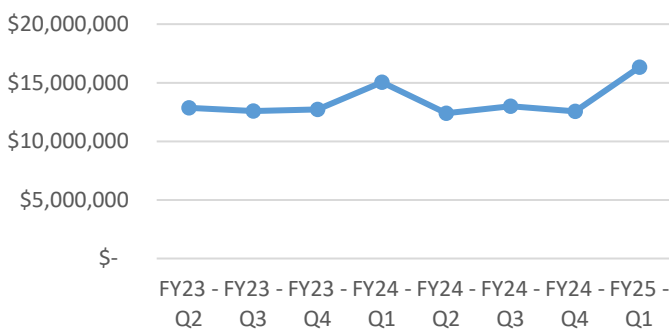
Quarterly gross receipts tax (GRT) collections during Q1 FY25 (\$16.3M), as seen in Chart 4, show an increase of \$3.8M or 30.2% compared to Q4 FY24. The amount collected during Q1 FY25 is also \$2.9M larger than the eight-quarter average (\$13.4M). Both total employment and average weekly wages grew YOY in Q4 FY24 by 1.1% and 2.9%, respectively (Chart 5).

Chart 3. Annual Total GRT Revenue Collections



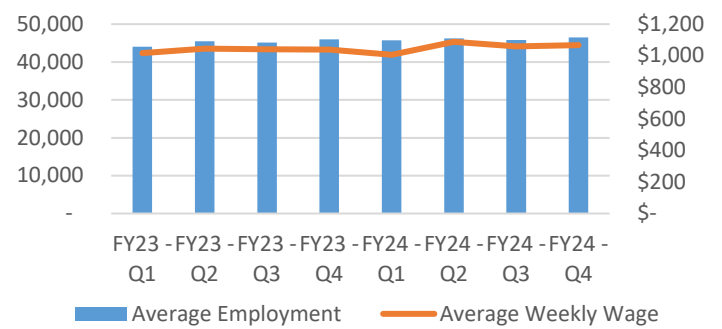

Chart 5. Total Employment & Weekly Wage



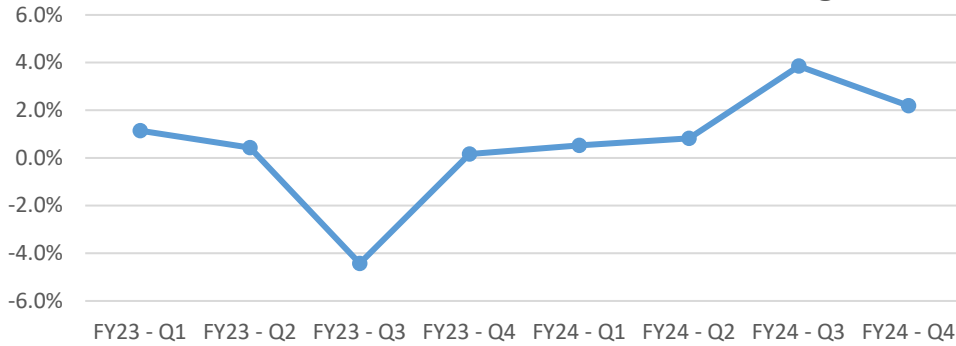

Chart 6. Establishment Year Over Year % Change

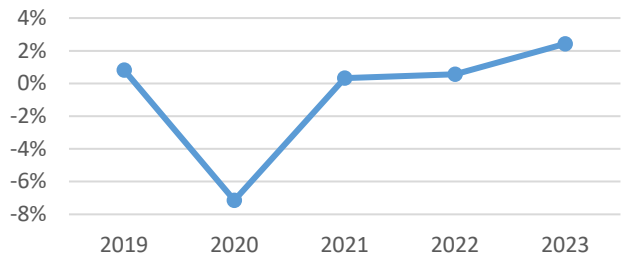

An **establishment**, as defined by the Quarterly Census of Employment and Wages (QCEW) and referenced in Chart 6, is an economic unit, such as a farm, factory, or store, located at a single physical address and engaged in one type of economic activity.

Gross Domestic Product (GDP) measures the value of all goods and services produced within a specific area. Changes in GDP from one period to another are important indicators of how the economy is performing. Chart 7 illustrates the YOY percentage change in real GDP for calendar years. Table 2 below details the percentage contribution of each industry to the total GDP for a specific county and how each industry's GDP changed compared to the previous calendar year.

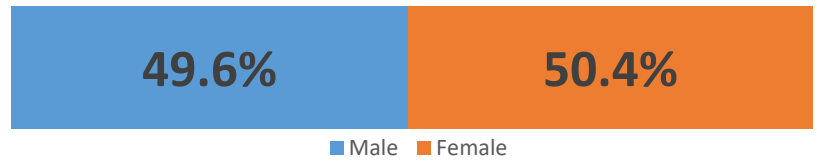

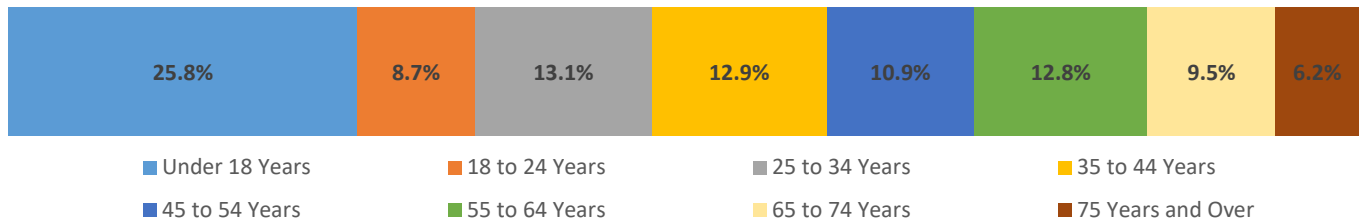

Population Sex



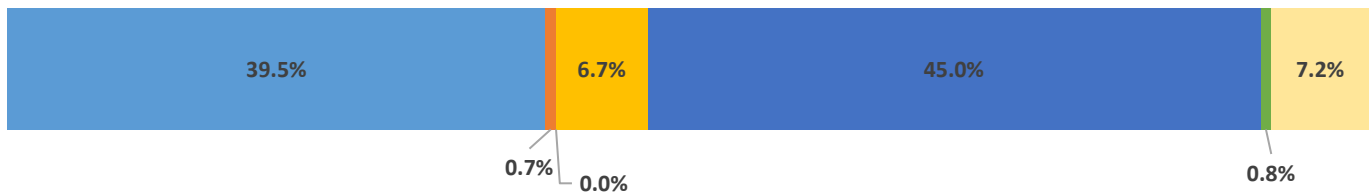

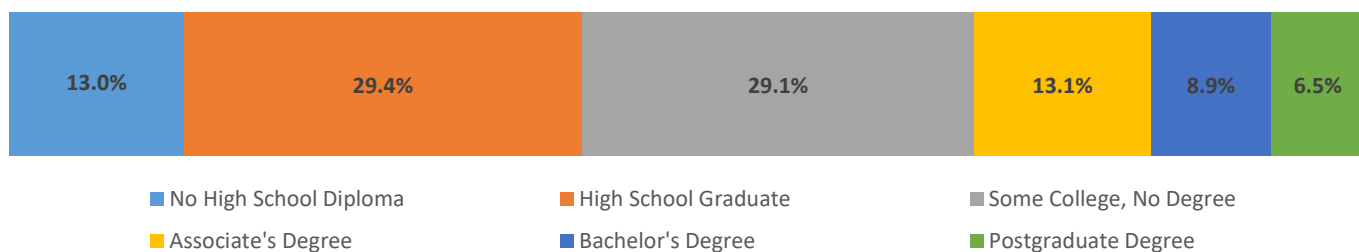
