


largest industries, consistent with the prior quarter. Table 1 on page 2 shows that the largest year-over-year (YOY) increase came from the professional, scientific, and technical services industry, followed by the other services industry. With their growth, New Mexico posted an overall \$1.33B, or 5%, YOY increase in MTGR. Employment in New Mexico experienced YOY growth of 11,427 (1.3%) in Q1 FY25, as seen in Chart 5 on page 3. Average weekly wages also increased YOY by \$63 (5.7%) in Q1 FY25, reaching \$1,159.

Matched Taxable Gross Receipts (MTGR) provide the most accurate tax data for assessing underlying economic activity. The data collection process involves matching tax payments with reported receipts for each taxpayer by industry.

New Mexico's total matched taxable gross receipts (MTGR) in Q2 FY25 increased by \$201.1M (0.8%) from the previous quarter (Chart 1). The average monthly MTGR over the past 24 months is \$8.34B, which is \$1.11B less than the amount reported in December—the highest MTGR recorded in both Q2 FY25 and the entire 24-month period, at \$9.45B. As shown in Chart 2, the largest industry by MTGR was retail trade, contributing 21%, a slight increase from 20% in the previous quarter. Construction and mining, quarrying, and oil and gas extraction remained the second- and third-







The **Quarterly Census of Employment and Wages (QCEW)**, referenced in Charts 4-5, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws, as well as federal workers covered under the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated across various levels, starting from the 6-digit NAICS industry level to broader industry categories (such as NAICS industry groups, sectors, and supersectors) and geographic levels (including metropolitan statistical areas, state, and national levels). Based on information reported by New Mexico employers, the data cover 97% of nonfarm wage and salary workers and are published quarterly. Renowned for their reliability, QCEW data are considered the gold standard for industry statistics, offering the most complete universe of monthly employment and quarterly wage information by detailed industry.

Gross Domestic Product (GDP) measures the value of all goods and services produced within New Mexico. Changes in GDP from one period to another are important indicators of the state's economic performance. Chart 7 provides quarterly statewide GDP, while Table 2 below details a breakdown of GDP by industry and their YOY changes. Both Chart 7 and Table 2 present real GDP figures, adjusted to chained 2017 dollars.





Chart 7. Gross Domestic Product Per


