
### **Quarterly Economic Summary**

#### **New Mexico**



New Mexico's total matched taxable gross receipts (MTGR) in Q3 FY25 slightly decreased by 0.04%, or \$10.8M, from the previous quarter (Chart 1). The average monthly MTGR over the past 24 months is \$8.48B, which is \$526M less than the amount reported in March—the highest MTGR recorded in Q3 FY25 at \$9.01B. As shown in Chart 2, the largest industry by MTGR was retail trade, contributing 19%, a slight decrease from 21% in the previous quarter. Construction and quarrying, and oil and gas extraction remained the second- and third-largest

industries, consistent with the prior quarter. Table 1 on page 2 shows that the largest yearover-year (YOY) MTGR increase came from the construction followed industry. bν unclassified establishments. With their growth, New Mexico posted an overall \$1.45B, or 6%, increase in MTGR compared to Q3 FY24. Average employment in New Mexico experienced YOY growth of 6,826 (0.8%) in Q2 FY25, as seen in Chart 5 on page 3. Average weekly wages also increased YOY by \$62 (5.3%) in Q2 FY25, reaching \$1,227.

Matched Taxable Gross Receipts (MTGR) provide the most accurate tax data for assessing underlying economic activity. The data collection process involves matching tax payments with reported receipts for each taxpayer by industry.






The Quarterly Census of Employment and Wages (QCEW), referenced in Charts 4-5, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws, as well as federal workers covered under the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated across various levels, starting from the 6-digit NAICS industry level to broader industry categories (such as NAICS industry groups, sectors, and supersectors) and geographic levels (including metropolitan statistical areas, state, and national levels). Based on information reported by New Mexico employers, the data cover 97% of nonfarm wage and salary workers and are published quarterly. Renowned for their reliability, QCEW data are considered the gold standard for industry statistics, offering the most complete universe of monthly employment and quarterly wage information by detailed industry.



#### Quarterly Economic Summary New Mexico







Gross Domestic Product (GDP) measures the value of all goods and services produced within New Mexico. Changes in GDP from one period to another are important indicators of the state's economic performance. Chart 7 provides quarterly statewide GDP, while Table 2 below details a breakdown of GDP by industry and their YOY changes. Both Chart 7 and Table 2 present real GDP figures, adjusted to chained 2017 dollars.


