

Looking Ahead

COMPREHENSIVE ECONOMIC DEVELOPMENT STRATEGY

EDD was awarded a grant from the U.S. Economic Development Administration CARES program to complete a Statewide Comprehensive Economic Development Strategy. EDD is working with economic development stakeholders and Council of Governments (COGs) across the state to create a summary of short-term recovery strategies, five-year strategies, and 20-year strategies.

The plan will contain unique strategies for the state's nine target industry sectors, including actionable recommendations and will recognize efforts needed by other state and local organizations as well. It will be directly tied to information obtained through national, statewide, and regional data collection, SWOT (strengths, weaknesses, opportunities, threats) analysis for each industry, the governor's Economic Recovery Council roadmap, COG recovery and five-year plans, and research conducted by the New Mexico Association of Commerce and Industry in coordination with EDD.

A concrete action plan for economic diversification away from the state's current dependence on oil and gas, retail, and public sectors over the next 20 years will also include legislative and infrastructure strategies.

LEDA Recovery Grants (HB-11)

Part of the pandemic-relief bills passed by the 2021 Legislature, it appropriates \$200 million to EDD's LEDA job-creation fund for businesses that commit to hire or rehire workers. The maximum grant is \$100,000, paid in quarterly installments.

Eligible Businesses:

- Operating in New Mexico with fewer than 75 employees per location
- Filed tax returns demonstrating a decline in revenues for 2020
- Current on state and local tax obligations
- Agree to reporting requirements established by EDD and NMFA
- The grant must be accompanied by job creation

Funds may be used for rent, lease, or mortgage obligations, per the LEDA statute and regulations. The first round of applications deadline is June 15, 2021. A second round will be open mid-summer of 2021.

JOB TRAINING INCENTIVES

Job Training Incentive Program (JTIP)

The Job Training Incentive Program (JTIP) funds classroom and on-the-job training for newly created jobs in expanding or relocating businesses for up to six months. The program reimburses 50-85% of employee wages.

Step Up Program

The Step Up Program is an aspect of JTIP that serves incumbent employees and their employers through training and reimbursements.

Step Up provides up to 75% of cost to provide training, up to \$2,500 per employee.



FINANCE DEVELOPMENT

Collateral Assistance Program (CAP)

EDD Collateral Assistance Program (CAP) encourages banks and other financial institutions to make loans to small businesses in under-served markets. EDD can pledge cash to cover a collateral shortfall of a loan in order to enable financing that otherwise might not be available to a small business.

Award amount: up to \$250,000.



Small Business Finance Finder

The Finance Finder connects business owners and aspiring entrepreneurs with lenders and resources. Businesses can submit a summary of their project online, and if it's a good fit, lenders and resource agencies will contact them. They also host regional Finance Fairs, which allow the public to meet with lenders and resource providers to discuss their projects.

Local Economic Development Act (LEDA)

Under the Local Economic Development Act (LEDA) (5-10-1 to 5-10-13 NMSA 1978), the Legislature has granted EDD a \$50 million grant fund to assist expanding or relocating businesses with grant funds. These grants are distributed to the local government to be passed onto the business on a reimbursement basis. The qualifying entity must provide economic impact and public benefit equal to or greater than the amount of the grant.

New Market Tax Credits (NMTC)

New Mexico Finance Authority (NMFA) provides NMTC loan funds dedicated solely to New Mexico businesses. These credits are combined with other financing mechanisms and funding sources to provide businesses in a qualified census tract with a below market financing tool.

Small Business Recovery Loan Fund

This Fund provides loans up to \$150,000 to businesses or nonprofit corporations with less than \$5M in annual net revenue. The applicant must be able to demonstrate a substantial decline in gross revenue or substantial disruption to its operations due to Covid-19 and the ensuing public health orders. The Loan Fund is administered by the New Mexico Finance Authority (NMFA).

Gross Receipts Tax Sharing

LEDA funding, which supports new jobs and investment, will now be sustained by a partial sharing (no more than 50%) of GRT revenues during the construction phase of projects when costs exceed \$350 million. The recapture requires agreement between the state and the participating local government. Multiple small projects can be funded with one large project.

OFFICE OF SCIENCE AND TECHNOLOGY

Business Start-Up Grants

Business Start-Up Grants are competitive grants that provide critical funding needed for early stage science and technology companies with high growth potential, a unique product or service, a scalable product, and an exit potential.

Award amount: \$25,000 average award. Other amounts may be awarded by the Technology Research Collaborative.

N.M. Small Business Innovation Research Grant (NM SBIR)

Provides science and technology companies with federal Small Business Innovation Research Grant Phase I/II (SBIR) awards funding to accelerate the commercialization of their technologies and cover business development costs that are not covered by the federal SBIR grant. The grant covers expenses such as intellectual property assessment, patent filing, commercialization activities, prototype development, regulatory assessment/certifications, meetings with potential customers, partners, investors, and market research/data acquisition.

Award amount: \$50,000-\$100,000.





OFFICE OF INTERNATIONAL TRADE

- Manages the N.M. State Trade Expansion Program (STEP). The STEP Program is funded in part by the U.S. Small Business Administration (SBA) and allows for costs to be offset for trade shows, trade missions, website optimization for e-commerce, market research, and other items related to exporting.
- Coordinates STEP Grant program in partnership with the federal government through the U.S. Department of Commerce Export Assistance Center office.
- Offers one-on-one business consultations to help companies navigate through language, cultural, and structural barriers.
- Operates a foreign trade office in Taiwan to generate qualified trade leads, locate buyers and distribution partners for companies, and support the recruitment of Foreign Direct Investment (FDI) to New Mexico. It also assists with questions regarding regulatory approvals.
- Provides workshops that create an awareness of international market opportunities and educate companies on the export process.
- Recruits and organizes N.M. companies to participate in international trade events.
- Organizes reverse trade missions designed to bring visiting foreign trade and investment delegations to N.M. with an interest in sourcing products produced in the state or to invest in N.M.




Community, Business & Rural Development (CBRD)

EDD's Community, Business & Rural Development staff (CBRD) or regional representatives are located in the regions they serve throughout the state. They assist businesses and communities in a broad variety of economic development needs:

- Passing and using the Local Economic Development Act (LEDA) to provide local incentives for job creation.
- Community infrastructure financing assisted by FUNDIT, a collaborative group of community development funding agencies who review and vet projects in a single meeting.
- Administers the Business Retention & Expansion Program in their respective regions.
- Workforce training for eligible businesses through the Job Training Incentive Program. Team members help businesses complete each step of the application process.
- Business development project funding in collaboration with Finance Development.
- Regional representatives work directly with the local government and business throughout the LEDA funding process.
- Assist businesses in taking advantage of New Mexico's tax credit incentives for job creation.
- Assist communities in responding to Potential Recruitment Opportunities (PROs) from the New Mexico Partnership.
- Help communities identify the best business startup programs to meet their economic development goals.
- Resolve state regulatory or other issues that impact businesses.
- Access to other EDD programs such as MainStreet, Arts & Cultural Districts or the Frontier & Native American Communities Initiative.

New Mexico Film Office (NMFO)



The film and television industry is a key sector of the New Mexico economy with a positive and wide reaching direct and indirect impact. When a film or television show shoots on location in New Mexico, it brings jobs, revenue, and related infrastructure development, providing an immediate boost to the local economy.

Productions that are shot in New Mexico are incentivized to source goods and services from local businesses, and many enjoy the ripple effect with additional revenue stream to local restaurants, hotels, dry cleaners, spas, catering services, lumber yards, secondhand stores, and more. The industry also generates revenue for property owners who list their property as a film location.

The state provides a competitive tax incentive, currently 25-35% of New Mexico production expenditures in transferable tax credits. Productions can take advantage of a 5% uplift by shooting outside Bernalillo and Santa Fe counties, utilizing a qualified production facility (soundstage or western set), or shooting standalone pilots intended for series television.

New Mexico Border Authority (NMBA) NEV



NMBA benefits New Mexico businesses by assisting them in doing business with Mexico and utilizing the international ports of entry. The Border Authority has particularly strong relationships with the States of Chihuahua and Sonora.

NMBA benefits communities by resolving issues and disputes with Mexican and U.S. inspection agencies that negatively affect the flow and amount of traffic at ports of entry. Border Authority staff also support the recruitment of manufacturers and other border-related business and they promote tourism at the three ports of entry.

Office of Military Base Planning & Support (OMBPS)

OMBPS supports the continued presence of Department of Defense (DoD) installations in New Mexico and seeks opportunities to enhance DoD's investment here. This benefits businesses who are DoD contractors and communities around the military bases.

The Office facilitates communication between the military base leadership, community governments and support organizations, state and federal agencies to eliminate areas of conflict. This also supports the development of renewable energy projects.

New Mexico MainStreet (NMMS)

NMMS develops local capacity to engage people, rebuild places, and grow the entrepreneurial, creative and business environment resulting in economically thriving downtowns, greater business and employment opportunities, and a higher quality of life. NMMS currently serves 31 affiliated MainStreet Districts, 12 state-authorized Arts & Cultural Districts, seven Frontier & Native American Community projects, and nine Historic Theaters.

FUNDIT

EDD's FUNDIT invites communities to present their projects to an informal group of federal and state funding agencies to receive feedback and guidance to fund their economic and community development and infrastructure projects. FUNDIT also hosts monthly webinars about development finance topics.

Local Economic Assistance & Development Support Program (LEADS)

The funding provided through LEADS is intended to create jobs through recruitment, retention/expansion and startup activities; develop the tax base; and provide incentives for business development. LEADS applications will be accepted from economic development departments or organizations with a current plan to address business growth in a community that has passed a LEDA ordinance to local governments and eligible partners.

Projects may be awarded up to \$25,000 per year in funding.

Outdoor Recreation Division (ORD)

The ORD works to sustainably grow the outdoor recreation economy in New Mexico through economic and community development, education, and outdoor infrastructure investment. It assists outdoor businesses in their efforts to expand, relocate, hire, and more. ORD offers grants to improve outdoor access, expand outdoor experiences for youth, and jumpstart new outdoor recreation businesses.

Business Incubator Certification

Establishing a certified business incubator is a strategy for fostering new business and new jobs in your community. An incubator is a business support facility with processes that accelerate the successful development of start-up and fledgling companies by providing entrepreneurs with an array of targeted resources and services.

Once all the research, planning, and resource gathering is complete, the final step is certification by the state.

- Business Accelerators

ABQid

ABQid is a business accelerator whose curriculum is influenced by Techstars accelerator. Startups accepted into this program receive \$20,000 in exchange for 6% equity in their company. The three-month program is a constant exercise in the lean startup method, which relies on testing your product/

service and pivoting based on the feedback.

Creative Startups

Creative Startups is an accelerator program targeting the creative economy. Its curriculum is based on the design thinking concepts and the lean startup method. Companies are aligned



with mentors and all of the initial work is virtual. Then the companies meet for an intensive five-day boot camp, a pitch day and more.

In 2020, Creative Startups launched an outdoor recreation business incubator through a network of rural libraries throughout the state.

Los Alamos Connect

Los Alamos Connect was created to nurture economic development by assisting small businesses in Northern New Mexico through various stages of growth. Services offered include: coaching and networking; technical assistance; business expansion and retention; market intelligence; and investments. While Los Alamos Connect focuses its efforts mainly on the Northern New Mexico counties of Santa Fe, Rio Arriba, Los Alamos, Sandoval, San Miguel, Taos, and Mora, there are situations that make reaching outside of these areas appropriate.

Procurement Technical Assistance Center (PTAC)

PTAC is a government-funded program providing assistance to small businesses who want to sell their goods or services to the government, educational institutions, or tribal entities. PTAC offers free, confidential counseling in the areas of: how to register your business in government databases (required for federal contracting); research strategies for accessing federal, state, and local government markets; how to market yourself to the government; how to respond effectively to a (RFP) and a (RFQ); how to obtain federal set-aside certifications for which you may qualify.





New Mexico Small Business Assistance (NMSBA) Program

The New Mexico Small Business Assistance (NMSBA) Program offers technical assistance to New Mexico small businesses. Businesses with a technical challenge that require special expertise can seek assistance from scientists or engineers at Los Alamos National Laboratory and Sandia National Labs. Such projects include testing, design consultation, and access to special equipment or facilities. Other types of technical assistance may be provided through the New Mexico Manufacturing Extension Partnership (NM MEP), the Center for Support of Economic Development (CSED), Small Business Assistance Program at UNM Anderson School of Management/Management of Technology concentration, and the Department of Management at New Mexico Tech.

Small businesses located in Bernalillo County can receive up to \$10,000 in technical assistance per year, while businesses in rural counties can receive up to \$20,000. Each lab is eligible for a state tax credit of \$2.4 million to assist N.M. small businesses. The small business must be for-profit, located in N.M., U.S. owned and operated, and must pay gross receipts tax to the State of N.M..

The BioScience Center

The BioScience Center in Albuquerque is a combination incubator and accelerator with a wet and dry lab for resident companies, along with other quality amenities. The center occupies a 19,500 sq-ft building in a centralized location providing offices, eight wet (chemistry and microbiology) laboratories totaling 2,500 sq. ft., and shared facilities that include reception, IT infrastructure, group purchasing, and conference space.

TCEDC's efforts have resulted in a 24,000 sq. ft business park and community center, which includes a 5,000-sqare-foot commercial food processing facility (Taos Food Center); a community garden and greenhouse which links numerous community groups and individuals to opportunities within the agricultural value-added sector; a small business direct services program; a 14,000-sqare-foot small business incubator; Food Sector Opportunities Program and "Oso Good Foods" cause marketing campaign; and numerous other projects.



INVESTOR INCENTIVE PROGRAMS

EB-5 Immigrant Investor Program

Under the EB-5 program entrepreneurs (and their spouses and unmarried children under the age of 21) are eligible to apply for a green card (permanent resident) if they make a necessary investment in a commercial enterprise in the United States and plan to create or preserve 10 permanent full-time jobs for qualified U.S. workers.

The Opportunity Zones (OZ) program offers three tax incentives for investing in low-income communities thought a qualified Opportunity Fund.

- A temporary deferral of inclusion in taxable income for capital gains reinvested into an Opportunity Fund.
- A step-up basis for capital gains reinvested in an Opportunity Fund.
- A permanent exclusion from taxable income of capital gains from the sale or exchange of an investment in an Opportunity Fund if the investment is held for at least 10 years.

Business Development Tax Incentives

High Wage Jobs Tax Credit

A taxpayer who is an eligible employer may apply for and receive a tax credit for each new high-wage economic-base job. The credit amount equals 8.5% of the wages and benefits paid for each new economic-base job created, up to \$12,750 per job.

Qualified jobs:

- pays at least \$40,000/year in a community with a population of less than 60,000;
- pays at least \$60,000/year in a community with a population of 60,000 or more;
- occupied for at least 44 weeks by the employee.

Qualified employers:

- are growing with employment greater than the previous year;
- are eligible for the Job Training Incentive Program.

Qualified employers can take the credit for 4 years. The credit may only be claimed for up to 1 year after the end of the 3 qualifying periods. The credit can be applied to the state portion of the gross receipts tax, compensating tax, and withholding tax. Any excess credit will be refunded to the taxpayer.

Qualified employees:

- must be a resident of New Mexico;
- cannot be a relative of the employer or own more than 50% of the company.

Rural Job Tax Credit

This credit can be applied to taxes due on (state) gross receipts, corporate income, or personal income tax. Rural New Mexico is defined as any part of the state other than Los Alamos County; certain municipalities: Albuquerque, Rio Rancho, Farmington, Las Cruces, Roswell, Santa Fe, and a 10-mile zone around those municipalities.

Company eligibility:

- companies that manufacture or produce a product in New Mexico
- non-retail service companies that export a substantial percentage of services out of state (50% or more revenues and/or customer base)
- certain green industries

The rural area is divided into 2 tiers:

- *Tier 2* = non-metro area municipalities that exceed 15,000 in population: Alamogordo, Carlsbad, Clovis, Gallup, and Hobbs
- *Tier 1* = everywhere else in a rural area

The maximum tax credit amount with respect to each qualifying job is equal to:

- *Tier 1:* 25% of the first \$16,000 in wages paid for the qualifying job (may be taken at \$1,000 per year for four years)
- *Tier 2:* 12.5% of the first \$16,000 in wages paid for the qualifying job (may be taken at \$1,000 per year for two years)



SUSTAINABLE AND GREEN ENERGY

Advanced Energy Deduction And Advanced Energy Tax Credit

Receipts from selling or leasing tangible personal property or services that are eligible generation plant costs to a person that holds an interest in a qualified generating facility are deductible from gross receipts and compensating tax.

Alternative Energy Product Manufacturers Tax Credit

Manufacturers of certain alternative energy products may receive a tax credit not to exceed five percent (5%) of qualified expenditures for purchase of manufacturing equipment used in the manufacturing operation.

Biodiesel Blending Facility Tax Credit

An operator of a refinery in New Mexico, any person who blends special fuel in New Mexico, or the owner of special fuel stored at a pipeline terminal in New Mexico, who installs biodiesel blending equipment for the purpose of establishing or expanding in a facility to produce blended biodiesel fuel is eligible to claim a credit against gross receipts tax or compensating tax.

Biomass-Related Equipment And Materials Deduction

The value of equipment such as a boiler, turbine-generator, storage facility, feedstock processor, interconnection transformer or biomass material used for bio-power, bio-fuels, or bio-based products may be deducted in computing the compensating tax due.

Renewable Energy Production Tax Credit

A corporate or personal taxpayer who owns a qualified energy generator is eligible for a tax credit in an amount equal to one cent (.01) per kilowatt hour of electricity produced by the qualified energy generator using a qualified energy resource in the tax year.

AEROSPACE AND AVIATION

Aircraft Deduction

For aviation companies the following are deductible from a company's gross receipts tax owed to the state:

- receipts from selling aircraft parts or maintenance services for aircraft or aircraft parts
- receipts of an aircraft manufacturer from selling aircraft flight support, pilot training, or maintenance training services
- receipts from the sale of or from maintaining, refurbishing, remodeling, or otherwise modifying a commercial or military carrier over 10,000 pounds gross landing weight
- 50% of gross receipts from selling other aircraft
- 40% of the receipts from selling jet fuel for use in turboprop or jet engines

Space Gross Receipts Tax Deductions

There are four separate deductions connected with the operation of a spaceport in New Mexico.


- 1. launching, operating or recovering space vehicles or payloads
- 2. preparing a payload in New Mexico
- 3. operating a spaceport in New Mexico
- 4. the provision of research, development, testing and evaluation services for the U.S. Air Force Operationally Responsive Space Program



BORDER LOCATIONS

Texas/New Mexico Border Residents' Tax Exemption

Non-resident employees may allocate their compensation to their home state. Since Texas does not have a personal income tax, Texas residents working at a New Mexico manufacturer will not have to pay any state income tax on their compensation from the enterprise if it is within 20 miles of the Texas border.



Trade Support Company In A Border Zone

The receipts of a customs brokerage firm or freight forwarder may be deducted from gross receipts if the company first locates in New Mexico within 20 miles of an international port of entry in New Mexico on New Mexico's border with Mexico.



MANUFACTURERS

Consumables Gross Receipts Tax Deduction For Manufacturers

Consumables, defined as tangible personal property that is incorporated into, destroyed, depleted, or transformed in the process of manufacturing a product, including electricity, fuels, water, manufacturing aids and supplies, may be deducted from gross receipts tax.

Investment Tax Credit

Manufacturers may take a credit against gross receipts, compensating or withholding taxes equal to 5.125% of the value of qualified equipment when the following conditions are met:

- For every \$750,000 of equipment, one employee must be added up to \$30 million.
- For amounts exceeding \$30 million, one employee must be added for each \$1 million of equipment.
- The manufacturer reduces its tax payment to the state until the amount of the Investment Credit is exhausted. There are provisions for issuing a refund when the credit balance falls under \$500,000.
- Beginning July 1, 2021, the credit will expand to apply against the compensating tax and/or local gross receipts tax.


TECHNOLOGY INTENSIVE

Angel Investment Credit

A taxpayer who files a New Mexico income tax return and who is a "qualified investor" may take a tax credit of up to \$62,500 (25% of a qualified investment) for an investment made in each of up to five New Mexico companies that are engaging in qualified research, as defined by the Internal Revenue Code, or manufacturing.

Technology Jobs And Research And Development Tax Credit

A taxpayer conducting qualified research at a qualified facility and making qualified expenditures of no more than \$5 million in New Mexico is eligible to claim the basic technology jobs and research and development tax credit of 5% against the taxpayer's compensating tax, withholding tax or gross receipts tax, excluding local option gross receipts tax. The tax credit will double to 10% for expenditures in facilities located in rural New Mexico. The approved basic credit may be carried forward for a period of up to three years.



OTHER INDUSTRY-SPECIFIC BUSINESS TAX INCENTIVES

Beer And Wine Producers Preferential Tax Rate

Microbreweries producing less than 5,000 barrels of beer annually and small wineries producing less than 560,000 liters of wine per year qualify for a preferential tax rate.



Locomotive Fuel Gross Receipts & Compensating Tax Exemption

Receipts from the sale of fuel to a common carrier to be loaded or used in a locomotive engine may be deducted from the gross receipts or compensating taxes when certain capital investment thresholds have been met.

Rural Software Development Gross Receipts Tax Deduction

Receipts from the sale of software development services may be deducted from gross receipts tax when the service is performed in a rural area.

Web Hosting Gross Receipts Tax Deduction

Receipts from hosting World Wide Web sites may be deducted from gross receipts. Hosting means storing information on computers attached to the internet.


