New! New Mexico Venture Community Health Assessment: Founder Survey

Be Entered In a \$1,000 Raffle! New Mexico Venture Community Health Assessment: Founder Survey Open Until Sept. 9

Through a project with the LANL Feynman Center for Innovation, projectY cowork (part of Los Alamos Commerce & Development Corporation) and ABQid (powered by CNM Ingenuity) are surveying active founders of New Mexico-based startups that are (or have been) actively attempting to raise venture funding within the past year.

Survey results will be independently and anonymously aggregated by HatchForm, and the analysis of the results will be shared back with those who participated as well as used for external communications helpful to the growth of the venture community. A parallel survey is being sent to partners/fund managers of New Mexico-based VC Funds as well as funds that are actively investing in NM. These results will also be helpful to New Mexico founders and cross-analyzed with this survey.

To sweeten the deal, they'll select one eligible founder at random to receive a \$1,000 cash prize for filling out the survey. You have until **5 p.m. on Wednesday, Sept. 9** to fill out the survey, and the random winner will be announced thereafter.

The STEM Talent Challenge seeks to develop or expand regional workforce capacity to support highgrowth, high-wage entrepreneurial ventures and innovation-driven businesses that have a high likelihood of accelerating economic competitiveness and job creation in their respective regions.\$2,000,000 in total funds,10 awards expected.

Eligible Applicants: State, local, and tribal governments, as well as institutions of higher education, nonprofit organizations, and other economic development organizations. **Deadline: October 14.**

New! The Shubert Foundation Funding for Nonprofit Theatre and Dance

The Foundation provides general operating support to nonprofit, professional resident theatre and dance companies that have an established artistic and administrative track record, as well as a history of fiscal responsibility. A limited number of grants are also made to arts-related organizations that help support the development of theatre and dance and graduate drama departments of private universities. **Deadline: December 2.**

New! Comer Family Foundation: Syringe Service Program

The Foundation's Syringe Service Program seeks to support comprehensive harm reduction programs that improve the health and wellness of people who use drugs. Grants ranging from \$2,500 to \$20,000 are provided to programs that provide free sterile syringes, education, and community wraparound services to reduce opioid overdose and the transmission of HIV and viral hepatitis. **Upcoming Deadline:** November 1.

New! Annie's Grants for Gardens

Annie's Grants for Gardens are provided to K-12 school gardens to help children start thinking more holistically about their food, their communities, and the planet. Grants may be used to purchase supplies for an edible garden, such as plants, seeds, raised beds, fencing, wheelbarrows, greenhouses, and drip irrigation systems. New applicants may apply for grants of \$3,000; returning applicants are eligible for one of three \$5,000 grants. Public, charter, and private schools, as well as school districts and nonprofit organizations supporting a school garden, are eligible to apply. **Deadline: November 2.**

New! Youth Engagement, Education, and Employment Grants

Grants support initiatives to provide young people and veterans with introductory educational experiences in natural resource careers through hands-on engagement and mentoring opportunities relating to US Fish and Wildlife Service programs. \$10,000,000 in total funds, 250 awards expected.

Eligible Applicants: State, local, and tribal governments, as well as relevant nonprofits and institutions of higher education. **Deadline: September 15.**

Choice Neighborhoods Planning Grants

Grants support the development of comprehensive neighborhood revitalization plans that will become the guiding document for the revitalization of the public and/or assisted housing units while simultaneously directing the transformation of the surrounding neighborhood. \$5,000,000 in total funds, 10 awards expected. Eligible Applicants: Tribal and local governments, as well as nonprofits and public housing authorities. **Deadline: September 14.**

Youth Conservation Opportunities on Public Lands

This opportunity is open to any qualified youth conservation corps established by a state or local government, by the governing body of any Indian tribe, or by a qualified nonprofit organization interested in working cooperatively with the BLM to develop and administer multiple-use conservation projects. Conservation projects must focus on providing employment, education, and public-service opportunities for ages 16 to 30 and veterans up to age 35 recruited from local and surrounding communities to assist with projects on public lands. **Deadline: October 22.**

Humanities Connections

Awards support innovative curricular approaches that foster productive partnerships among humanities faculty and their counterparts in the social and natural sciences, and in pre-service or professional programs (such as business, engineering, health sciences, law, computer science, and other technology-driven fields), in order to encourage and develop new integrative learning opportunities for students. **Deadline: September 30.**

Rural Placemaking Innovation Challenge (RPIC)

This opportunity helps rural communities access technical assistance to create places where people want to live, work, and play. Funds can be used to develop actionable placemaking plans, convene partners, identify community needs, and implement priorities to build rural prosperity. Broadband-related projects are encouraged. **Deadline: September 10.**

Brownfields Multipurpose, Assessment, and Cleanup Grants

This opportunity includes several grant programs related to brownfield assessment, cleanup, and planning projects, including those incorporating renewable energy and energy efficiency. Use of funds vary by program. **Deadline: October 28.**

Environmental Workforce Development and Job Training Grants

These grants are available for programs that recruit, train, and place unemployed and under-employed residents. Funds may be used to cover direct training costs to secure full-time employment in the environmental field. **Deadline: September 22.**

Special Projects and Outdoor Infrastructure Grant Program

NM Outdoor Recreation Division (ORD) is accepting applications for its new grant program to help residents improve access to outdoor recreation in their communities. This grant focuses on conservationminded shovel-ready projects that are open to the public and demonstrate a clear benefit to the community. Grant amounts will range from \$5,000 to \$25,000. **Deadline: September 14.**

The Strengthening Community Colleges Training Grants program will build the capacity of community colleges to collaborate with employers and the public workforce development system to meet local and regional labor market demand for a skilled workforce. **Deadline: October 8**.

A Community Thrives Grants

A Community Thrives invests in community-building initiatives. The program is a way to share community improvement ideas on the national stage, gain support through donations and local connections, and get a chance at receiving a portion of an additional \$2 million in grants to help projects succeed. During the campaign, nonprofit organizations have the chance to raise funds for their charities. At the end of the crowdfunding period, the Gannett Foundation will award grants ranging from \$2,500 to \$100,000 to selected organizations. Nonprofit organizations and municipal programs such as libraries and schools may apply. **Deadline: September 11.**
