New Mexico MainStreet Continues to Develop Capacity-Building in the Third Quarter

New Mexico MainStreet, with local affiliates and local government partners, continues to build capacity for local economic revitalization and redevelopment efforts to enhance the entrepreneurial and business climate in local



MainStreet districts and create thriving communities in New Mexico. In the Third Quarter of the FY2018 fiscal year, local MainStreet programs reported \$7,510,930 in Private Sector Reinvestment; 48 Private Building Renovations; 17 Net New Business, 3 Business Expansions; and 106 Net New Jobs created in MainStreet districts.

Each quarter, our MainStreet Districts revitalize their local districts through building rehabilitations, business development and expansion, job creation, planning, and capacity building. Some of MainStreet's Reinvestment, Business and Project

highlights from the quarter include: Portales has invested 4.3 million toward the complete renovation of the Portales Inn, business expansion for AMB Nails, and \$8,000 in façade improvements to Pebsworth Insurance. In Las Cruces, 1.4 million was invested towards the Amador Hotel Project, Community Enterprise Center and Coronado Office. In Las Vegas investments of \$550,000 were made to include interior and exterior renovations of the Castaneda Hotel and dining and kitchen improvements to the Plaza Hotel.

Five new business opened up in Harding County MainStreet district resulting in the creation of 7 new jobs for the community. Clovis MainStreet reported the opening of 6 new businesses with the creation of 9.5 fulltime equivalent jobs. Farmington and Alamogordo were awarded \$50,000 in NMFA Local Government Planning Fund Grants to complete new Metropolitan Redevelopment Area Plans. Ten MainStreet organizations Albuquerque Downtown, Barelas, Carlsbad, Farmington, Gallup, Las Cruces, Las Vegas, Portales, Silver City, and South Valley brought in \$190,000 in private sector grant dollars to their districts.

Focus on New Mexico Advocacy

Advocacy is important to MainStreet organizations as their work is affected by government policy, local government support (program funding), helping business owners or property owners link up with appropriate incentives, and support for infrastructure projects that improve the district and community.

Renee Kuhlman, Director of Policy Outreach, Government Relations and Policy, at the National Trust for Historic Preservation in the report Advocacy in Motion looks at Main Street advocacy and how many people working in Main Street have developed their advocacy skills to build trusted relationships with local government partners.

Catalyst Fund Investment Leverages \$12.5M for BayoTech

BayoTech is a classic New Mexico success story. With technology born at Sandia National Laboratories, the company was the first recipient of a Catalyst Fund investment of \$2M in May 2017. That investment allows BayoTech to begin filling \$1.5B in orders. On April 2nd BayoTech announced it has closed a \$12.5M Series B round of financing. The funds will be used to expand the company's infrastructure and complete the commercialization of its technology. BayoTech is "the world's first modular, scalable, and rapidly deployable platform for the production of hydrogen and nitrogen fertilizer for the agricultural and industrial markets."

BUSINESSES: Your Data is Needed - Please Complete the Economic Census

Every five years the U.S. Census Bureau conducts the Economic Census, the official measure of the nation's businesses and economy. Data is collected on years ending in '2' or '7' and released about one year after the collection period. Title 13 of the United States Code requires businesses and other organizations that receive the questionnaire to answer the questions and return the report to the Census Bureau. This is the first Census in which respondents will use an online, secure portal to respond making filing easier while improving data quality and reducing costs.
