Inaugural FUNDIT Small Business Finance Fair held in Taos

On July 17, we held our first ever FUNDIT-Small Business Finance Fair in Taos, at the El Sagrado Hotel and Resort.

FUNDIT, a NMEDD program which connects funding entities with local, community development projects, is expanding its efforts to assist entrepreneurs and small businesses.

The event, co-sponsored by the Regional Development Corporation, was an opportunity for over 100 small businesses to meet with local lenders and also learn about other less traditional funding sources.

Attending the event were authors, scientists, farmers, and a whole range of entrepreneurs, who left feeling as if they had more resources for making their dreams become reality -- launching or expanding their businesses, hiring local talent, improving the overall economic climate of their community.

Attendees at the event were also treated to a free lunch, provided by El Monte Sagrado Hotel and Resort - the event venue - and folks enjoyed sitting with other business owners in this non-formal setting to network and learn from each other.

Nineteen Companies Receive LEDA Assistance

As Fiscal Year 2019 closed, 19 companies have been assisted by LEDA.

Eighteen companies received the typical LEDA investment and SCEYE received the first LEDA loan of \$2M. Total LEDA funds committed = \$38.9M. Private sector investment by these companies totaled \$1.2 billion, and 3,586 jobs were created. The leveraged ratio of private investment to LEDA funds is 31.99.

There were 8 rural projects, including the SCEYE loan. Private investment totaled \$135.9M and LEDA funds totaled \$13,095,000 for 970 jobs created.

JTIP Assists a Record Number of New Mexico Companies

The Job Training Incentive Program (JTIP) obligated a total of \$16.7M FY19 to train 2,333 New Mexicans. From that total, 274 were Film trainees (\$2.6M obligated); 1,433 in manufacturing jobs; 1,192 were rural trainees; 29 were interns; and 151 were Step Up trainees. The average wage of all trainees was \$18.04: \$14.93 for rural trainees and \$26.82 for urban trainees.

Seventy businesses were assisted in FY19 – a record as far back as we can find data. From that number 24 were rural businesses in communities that include Belen, Berino, Carlsbad, Church Rock, Clovis, Deming, Farmington, Los Lunas, Loving, Navajo Nation, Portales, Questa, Roswell, Santa Teresa, Sunland Park, and Taos.

The Pecos Theater Shines on Route 66 Again



Tim Hagaman reports from Region 4 that renovations have been completed on the Historic Pecos Theater. Built in 1917, the theater operated continuously until 2010. Tim worked with longtime owner Rudy Sanchez to sell the property to Guadalupe County. From there it took a team of community leaders, including Rep. George Dodge, Assistance

Projects Manager Ken Flores, Project Manager Monica Abeyta, Tim and Elmo Baca, working with Stoven Construction to get the renovations completed.

Dozens of images on the <u>contractor's website</u> show the level of work needed to bring back this gem.

The theater is on an important block in downtown Santa Rosa, which includes Luna Community College. Next door to the theater is a space for entrepreneurs. A community meeting space is also available.





The City of Santa Rosa currently has an accelerator MainStreet community that is working on completing their organizational, design, promotion, and economic positioning benchmarks.

- from New Mexico MainStreet (2014-2018)
- Tracked more than 3,181 volunteer hours
- Hosted 27 downtown events and presentations
- Completed 8 beautification projects

New Mexico Innovation Voucher Deadline: July 30

New Mexico Innovation Vouchers are competitive grants designed to enable early stage science and technology companies to overcome business development barriers. This is achieved by providing small amounts of funding at critical moments during company growth. Innovation Vouchers offset the cost of services offered by approved programs allowing companies to focus on and achieve strategic business development goals. For example, a company can use an Innovation Voucher for one month's

rent at a state certified incubator and thus be able to travel for customer recruitment.

Application deadline is approaching soon: Tuesday, July 30, 2019 at 5:00 p.m.
