Job Training Incentive Program Awards 9 Companies \$1,967,435.04 to Create 251 High-Wage Jobs and 3 Internships in February and March

SANTA FE - The New Mexico Economic Development Department's Job Training Incentive Program Board approved \$1,055,508.04 in funding at its February meeting for 215 jobs and 3 internships, and \$911,927.00 for 36 jobs in March. The funding was awarded to 9 companies with an average wage of \$18.31 for the newly-created jobs and an average wage of \$18.00 for the three internships. The Next JTIP board meeting will be Friday, April 11.

"JTIP continues to serve as a key resource to assist New Mexico businesses in expanding their workforce," said Economic Development Secretary Jon Barela. "I am thrilled that we can continue to fund this program year to year now that JTIP became a permanent part of the state budget during the last Legislative Session."

February's JTIP Recipients were:

HT MicroAnalytocal, Inc. - HT MicroAnalytical, Inc. (HT Micro) began as a prototype operation in Albuquerque in 2003. Since then the company has become a leading manufacturer of ultraminiature switches, sensors and precision components serving both commercial and military markets. HT Micro's core product offering consists of inertial and magnetic switches and precision connectors. \$22,313.00 - 1 job

Alliance Data Systems, Inc. - Alliance Data Systems (ADS) is a subsidiary of Alliance Data Systems Corporation, headquartered in Plano Texas. ADS performs processing services and provides service and maintenance for private label and co-brand credit card programs. ADS also provides marketing services for its clients through the design and implementation of strategies that assist its clients in acquiring, retaining and managing valuable repeat customers. \$738,788.00 - 181 iobs

DHF Technical Products - DHF Technical Products was founded in 2008 in California. Bendix King - In late 2012 Honeywell located its Bendix King headquarters in Albuquerque. The decision to move to Albuquerque was based on its central location, good flying weather and existing aviation industry in the region. The Bendix King brand has a rich heritage and is well respected in the General Aviation market. The intent is to reinvigorate this key Honeywell brand through new product introduction and focus on the key consumer market channels. The key target customers for Bendix King are General Aviation pilots and dealers. **\$788,712.00 - 28 jobs**About JTIP

The Job Training Incentive Program reimburses qualified economic-based companies for a portion of training costs associated with job creation. The program provides for classroom or on-the-job training, reimbursing an expanding or relocating business for up to 75 percent of a trainee's wages for as long as six months. The amount of the award depends on the number and complexity of jobs, the wages paid, and the business location.

To qualify, new or expanding companies must either create a product in New Mexico, or provide a non-retail service with 50 percent of the company's costumer or revenue base outside of the state. The eligible jobs must be full-time and year-round. The trainee must be a new hire to the company and have been a New Mexico resident for at least one year at any time prior to being hired.
