






Luna County's matched taxable gross receipts (MTGR) have been trending downward over the last eight quarters, as seen in Chart 1, and has seen guarter over quarter decline since Q4 FY18. Q1 FY20 saw a year over year (YOY) 20% decrease in MTGR. The Construction industry saw the largest YOY decrease in Q1 FY20, decreasing by \$9.7M. Other decrease notable was the Administrative/ Support & Waste Management/ Remediation industry which saw a \$5.5M decrease. The Other Services (except Public Administration)

Industry saw a negative amount in the first quarter of FY20, as seen in Table 1, on page 2. This negative amount for the quarter is likely due to over reporting in a prior period which is being corrected.





Gross Receipts Tax (GRT) revenue collections have been trending downwards over the last eight quarters, as seen in Chart 4. Q1 FY20 saw the first quarter over quarter increase since Q4 FY18. Table 2, on page 3, shows multiple industries having no contribution to GDP in 2018. This is due to the number of companies within the industries being so low that the Bureau of Economic Analysis has withheld the information for the industry to avoid disclosure of confidential information. Table 2 does not necessarily reflect the proportion each industry contributes to overall GDP.


HB6, PASSED IN 2019, MADE WIDESPREAD TAX CHANGES WITHIN NEW MEXICO. ONE NOTABLE CHANGE IS THE CONVERSION TO DESTINATION-BASED SOURCING THAT WILL BEGIN AFTER A TWO YEAR DELAY. DURING THIS DELAY LOCAL GOVERNMENTS WILL RECEIVE A DISTRIBUTION THAT IS A PORTION OF \$2M EACH MONTH. THE PORTION DISTRIBUTED WILL BE BASED ON WHAT THE POPULATION OF EACH COUNTY IS TO THE TOTAL POPULATION OF ALL COUNTIES, AS PER THE MOST RECENT DECENNIAL CENSUS.





