I. Introductions

The meeting convened at 9:02 am. The introduction of board and staff followed.

II. Approval of the Agenda

Mr. Roper advised that USA Beef Packing, LLC was being moved up on the agenda to follow after Rhino Health, Inc. Ms. Bannowsky made a motion to approve the agenda as amended. Ms. Doran seconded the motion. Motion passed.

III. Amendment(s)

a) The Verdes Foundation – Albuquerque

The company requested a total of \$5,120.00 for 1 trainee at an average wage of \$16.00 per hour. The company has been approved for JTIP on one previous occasion.

The company stated that they are growing and were excited to be here; they have been on hold to hire due to more space needed in the kitchen, but plan to move to a bigger facility and hire mid-April; gave a benefits overview.

A motion to approve the request in the amount of \$5,120.00 to hire and train 1 employee was made by Mr. Martinez and seconded by Ms. Bannowsky. Motion passed.

IV. Proposals

a) Rhino Health, Inc. - Church Rock

The company requested a total of \$155,000.00 for 31 trainees at an average wage of \$11.86 per hour. Total request includes \$1,250.00 for audit fees. The company has been approved for JTIP on two previous occasions.

The company gave an overview of the its growth to date; currently have 25 employees; have been running two shifts since January; have an active salesforce; ISO certification in process; are currently developing a benefits package; are looking into a 24-hour shift, with a possible shift differential; recommendation made for a wage increase to be considered for the Line Manager and Quality Control positions if hard to fill; a question was raised regarding wastewater issues related to larger operation expansion over time, some concerns were expressed by the community, but no problems thus far.

A motion to approve the request in the amount of \$155,000.00 to hire and train 31 employees was made by Mr. Duske and seconded by Mr. Martinez. Motion passed.

b) USA Beef Packing, LLC – Roswell and Chavez County

The company requested a total of \$232,321.36 for 36 trainees at an average wage of \$13.94 per hour. Total request includes \$1,250.00 for audit fees. This is the first time the company has applied for JTIP.

The company gave an overview of expansion, company culture and workforce; expressed appreciation for the JTIP opportunity; mentioned that they are USDA inspected, registered with FDA, and have a British Certification; have a new facility downtown; are still doing buffalo/bison as there is a high demand; is working with Workforce Connections for technical and maintenance candidates. The company was encouraged to consider health care benefits as they go along, response was positive.

A motion to approve the request in the amount of \$232,321.36 to hire and train 36 employees was made by Mr. Tremko and seconded by Ms. Doran. Motion passed.

c) UbiQD, Inc. - Los Alamos

The company requested a total of \$120,900.96 for 5 trainees at an average wage of \$41.84 per hour. Total request includes \$1,250.00 for audit fees. The company has been approved for JTIP on six previous occasions.

The company gave an overview of expansion plans; new renovation of unfinished basement will double their capacity when finished; gave a description of the product; advised that 66% of persons hired were due to JTIP; the company was applauded for their 100% retention of JTIP trainees. The next round of funding is in the works.

A motion to approve the request in the amount of \$120,900.96 to hire and train 5 employees was made by Mr. Martinez and seconded by Mr. Tremko. Motion passed.

d) Sendero Midstream Partners, LP - Loving

The company requested a total of \$185,570.00 for 6 trainees at an average wage of \$40.00 per hour. Total request includes \$1,250.00 for audit fees. The company has been approved for JTIP on four previous occasions.

The company gave an overview of their successes - to date no injuries, proud of safety record, they have the highest percent by volume for gas/ethane and they use local construction companies. The construction for their second facility is done and will be commissioned in April; revenue has improved and they anticipate double the cash flow in the next year or so.

A motion to approve the request in the amount of \$185,570.00 to hire and train 6 employees was made by Mr. Duske and seconded by Ms. Bannowsky. Motion passed.

e) AerSale Component Solutions, Inc. – Rio Rancho

The company requested a total of \$139,490.00 for 16 trainees at an average wage of \$20.34 per hour. Total request includes \$1,250.00 for audit fees. This is the first time the company has applied for JTIP under AerSale Component Solutions, Inc.

The company gave an overview – are adding engine components and hydraulic lines; stated that they are ramping up investments and promoting within; they use CNM graduates extensively, tries to keep local; is anticipating a second shift in the near future.

A motion to approve the request in the amount of \$139,490.00 to hire and train 16 employees was made by Mr. Tremko and seconded by Mr. Martinez. Motion passed.

f) Theta Plate, Inc. - Albuquerque

The company requested a total of \$19,920.00 for 2 trainees at an average wage of \$21.75 per hour. Total request includes \$1,000.00 for audit fees. This is the first time the company has applied for JTIP.

The company expressed appreciation for JTIP, the two positions are critical for the company; stated that the head electroplater has been with the company for 40 years, they seek local folks, all hires are New Mexican; are working with CNM to recruit young folks and are ISO certified.

A motion to approve the request in the amount of \$19,920.00 to hire and train 2 employees was made by Mr. Duske and seconded by Ms. Bannowsky. Motion passed.

g) Supply One - Albuquerque

The company requested a total of \$30,820.00 for 8 trainees at an average wage of \$13.72 per hour. Total request includes \$1,000.00 for audit fees. This is the first time the company has applied for JTIP.

The company gave an overview and stated that they purchased \$585,000 in equipment last year – are handling Intel's logistics and bringing in their equipment.

A motion to approve the request in the amount of \$30,820.00 to hire and train 8 employees was made by Mr. Duske and seconded by Ms. Bannowsky. Motion passed.

V. Approval of the Minutes

A motion to approve the minutes for the meeting on January 10, 2020 was made by Mr. Duske and seconded by Mr. Tremko. Motion passed.
