I. <u>Introductions</u>

The meeting convened at 9:01 am. The introduction of board and staff followed.

II. Approval of the Agenda as amended

A revision was made to the agenda to remove RingIR, Inc. until the September 2021 board meeting. Motion to approve as revised was made by Ms. Doran and seconded by Mr. Duske. Motion passed.

III. Consent Calendar

The following companies were presented as a whole, as they have been before the board on previous occasions:

A motion to approve the companies referenced above as a whole was made by Mr. Duske and seconded by Ms. Doran. Motion passed.

IV. Consideration of Proposals

a) Vibrant Corporation – Albuquerque

The company requested a total of \$150,268.00 for 7 trainees at an average wage of \$38.21 per hour. The company has been approved for JTIP on eight previous occasions.

The company expressed appreciation for the opportunity and stated that COVID hurt, but they are doing better now due to the help from the state of NM. The support in the past has allowed growth.

A motion to approve the request in the amount of \$150,268.00 to hire and train 7 employees was made by Mr. Duske and seconded by Ms. Gallup-Rodriguez. Motion passed.

b) New Mexico Harvest, Inc. - Albuquerque

The company requested a total of \$62,760.00 for 8 trainees at an average wage of \$20.09 per hour. This is the first time the company has applied for JTIP.

The company expressed appreciation and stated that they are focused on the local foods of NM; are pushing safety and is the first GAP certified food hub in the state; has contracts with Whole Foods, Montanita Co-ops and others; they need help with "direct package" into grocery stores; regarding recruiting, they are recruiting via Workforce Solutions, also has a large network and already has 1-2 candidates in mind for this project.

A motion to approve the request in the amount of \$62,760.00 to hire and train 8 employees was made by Ms. Gallup-Rodriguez and seconded by Ms. Doran. Motion passed.

c) Santa Fe Brewing Company - Santa Fe

The company requested a total of \$69,096.00 for 3 trainees at an average wage of \$32.00 per hour. The company has been approved for JTIP on three previous occasions.

The company expressed appreciation for the opportunity and stated that they are focusing on their sales and marketing departments as well as retail tap rooms; are investing in tech and production, etc., and the need for expansion is now.

A motion to approve the request in the amount of \$69,096.00 to hire and train 3 employees was made by Mr. Duske and seconded by Ms. Doran. Motion passed.

d) Anna & Eve, LLC. - Placitas

The company requested a total of \$11,420.80 for 1 trainee at an average wage of \$16.70 per hour. This is the first time the company has applied for JTIP.

The company expressed appreciation for the opportunity and stated that although they survived COVID, they were impacted in the first year, due to low stock. They now have inventory on hand and more coming; manufacturing in the USA has proven to be difficult. They received two quotes, one was willing to, but was too expensive; China is okay for manufacturing, but although Taiwan is more expensive, they take care of their employees, and they provide better quality. Mexico may be an option and they will investigate it.

A motion to approve the request in the amount of \$11,420.80 to hire and train 1 employee was made by Ms. Doran and seconded by Mr. Duske. Motion passed.

e) Capitol Bar & Brewery - Socorro

The company requested a total of \$19,360.00 for 2 trainees at an average wage of \$15.08 per hour. This is the first time the company has applied for JTIP.

The company expressed appreciation for JTIP and LEDA; and stated that COVID was hard, the bar part had different standards, the brewery part saved the company.

A motion to approve the request in the amount of \$19,360.00 to hire and train 2 employees was made by Ms. Gallup-Rodriguez and seconded by Mr. Duske. Motion passed.

f) Amfabsteel, Inc. – Bernalillo

The company requested a total of \$240,974.00 for 23 trainees at an average wage of \$17.67 per hour. The company has been approved for JTIP on four previous occasions.

The company stated that they are happy to be back; today they are at 128 employees; they have a big backlog, 98% is out of state; and without JTIP or Step-Up, no expansion would be possible.

A motion to approve the request in the amount of \$240,974.00 to hire and train 23 employees was made by Ms. Doran and seconded by Mr. Duske. Motion passed.

g) Amfabsteel, Inc. - STEP-UP - Bernalillo

The company requested a total of \$15,120.64 for 2 trainees. The company has been approved for JTIP on four previous occasions.

An overview/summary was given by Ms. Borrego. The company had nothing further to add.

A motion to approve the request in the amount of \$15,120.64 to hire and train 2 employees was made by Ms. Doran and seconded by Mr. Duske. Motion passed.

h) Earth Traveler Teardrop Trailers, LLC - Santa Fe

The company requested a total of \$25,840.00 for 6 trainees at an average wage of \$17.25 per hour. This is the first time the company has applied for JTIP.

An overview/summary was given by Ms. Borrego. The company had nothing further to add.

A motion to approve the request in the amount of \$25,840.00 to hire and train 6 employees was made by Ms. Gallup-Rodriguez and seconded by Mr. Duske. Motion passed.

i) Ergomotion, Inc. – Santa Teresa

The company requested a total of \$33,840.00 for 4 trainees at an average wage of \$17.40 per hour. This is the first time the company has applied for JTIP.

An overview/summary was given by Ms. Borrego, and more was given by the company. They stated that they already have some applicants in line for this project.

A motion to approve the request in the amount of \$33,840.00 to hire and train 4 employees was made by Mr. Duske and seconded by Ms. Doran. Motion passed.
