NMSBA allows Los Alamos and Sandia national laboratories to apply their unique expertise and capabilities to help for-profit, New Mexico small businesses solve critical challenges. Technical assistance is provided at no cost to the businesses and is rendered in the form of laboratory staff time and incidental materials. Qualifying businesses are eligible to receive laboratory technical assistance equivalent to \$10K (Bernalillo County) and \$20K (outside Bernalillo County) annually per business. **Deadline: February 9.**

[Farmer Veteran Fellowship Fund](#)

A small grant program (\$1,000 to \$5,000) that provides direct assistance to veterans who are in their beginning years of farming or ranching. The Fellowship Fund gives money to third-party vendors for items the veteran has identified will make a crucial difference in the launch of their farm business. **Deadline: February 14.**

FREE business support program to existing and aspiring agriculture business owners in New Mexico. This 6-week business support program features a revamped curriculum designed to support participants with developing and strengthening their business through guided exploration of the Business Model Canvas. **Deadline: February 15.**

This Week's Highlight:

HOPE VI Main Street Grant Program

[The HOPE VI Main Street Program](#) provides grants to small communities to assist in the renovation of an historic or traditional central business district, or "Main Street" area, by replacing unused, obsolete, commercial space in buildings with affordable housing units.

The objectives of the program are to:

- Redevelop central business districts (Main Street areas)
- Preserve Historic or traditional Main Street area properties by replacing unused commercial space in buildings with affordable housing units
- Enhance economic development efforts in Main Street areas
- Provide affordable housing in Main Street areas

Main Street grant funds can be used to build new affordable housing or reconfigure obsolete or surplus commercial space (or extremely substandard, vacant housing) into affordable housing units.

Eligible applicants are limited to Units of General Local Government, defined as any city, town, township, village, county, parish, or other general purpose political subdivision of a state or territory.

Deadline: January 31.

[USDA Rural Business Development Grants](#)

Funding is available to support business opportunities or business enterprise projects in rural communities. **Deadline: February 28.**

[FY 2023 National Infrastructure Investments](#)

Purpose: This Notice of Funding Opportunity (NOFO) solicits applications for projects funded under the Local and Regional Project Assistance Program, known as the RAISE Grants program. **Deadline: February 28.**

[T-Mobile Hometown Grant Program](#)

Helps fund projects to build, rebuild, or refresh community spaces that help foster local connections in your town. This may include the town square pavilion, a historic building, an outdoor park, a ball field, or a library. Up to \$50,000, for communities with populations less than 50,000. **Deadline: March 31.**

[LOR's Fieldwork Initiative](#)

Provides funding for farmers and ranchers to implement innovative approaches to using water in agriculture. Farmers and ranchers in rural parts of Colorado, Idaho, Montana, New Mexico, and Wyoming are eligible for up to \$10,000 for projects that improve outcomes in the following areas: water efficiency, water reliability, water quality, crop yield or crop diversification, and labor efficiency. LOR will begin accepting project proposals on Feb. 1. Informational webinars on Jan. 19 and 24. **Deadline: February 22.**

[Dream of Flight Renovation and Concessions Redevelopment Project](#)

The Albuquerque International Sunport is hosting a virtual public information session on January 19 at 10 a.m. The session will briefly review the concessions redevelopment, operating a concessions unit at the airport, the upcoming request for proposal process, and Airport Concessions Disadvantaged Business Enterprise (ACDBE) certification.

[The Fruit Guys Community Fund](#)

Grants from \$2,000 to \$5,000 for projects that help small farms and orchards operate more environmentally and economically, while strengthening community outreach. **Deadline: January 30.**

[Transition From Jail to Community \(TJC\) Toolkit Revision/Update](#)

Supports the local reentry efforts of justice-involved adults. **Deadline: February 3, 2023.**

[Grants for Arts Projects](#)
