### **Nasdag Foundation's Quarterly Grant**

### PTAC (aka New Mexico Apex Accelerator)

Government-funded program providing assistance to small businesses who want to sell their goods or services to the government, educational institutions, or Tribal entities.

Interview with Henry (Jake) Foreman, program director at New Mexico Community Capital from UNM Rainforest Innovations' Tribal Entrepreneurship Enhancement Program.

### **RDC Tribal Economic Diversity Fund** Information Session

Grant awards of up to \$8000 for businesses owned by a federally recognized Indian tribe or 51% or more owned by an enrolled Tribal member for critical technical services and equipment. **Grant deadline August 1**.Register for the online information session on **July 18**.

### **Arrowhead Tourism Sprint**

A virtual 6-week program for tourism-related businesses supporting guided exploration of the Business Model Canvas. Also included will be personalized resources and assistance, mentorship, networking, and connections to business experts. Runs Wednesdays from Aug 9 -Sept. 13. **Deadline: July 31.** 

Accelerates progress in diversifying entrepreneurship and empowering a more diverse group of investors. **Deadline: August 11.** 

New Mexico Dept. of Agriculture's Workforce Development Program NMDA will reimburse agricultural businesses up to 50% of qualified costs of hiring interns.

### **USDA's Procurement Forecast**

Lists types of anticipated solicitations that small, disadvantaged, women-owned, HUBZone businesses, service-disabled veterans, and other businesses may be able to participate in contracts with USDA, or through subcontracting opportunities.

### **Renewable Energy Systems and Energy Efficiency Program**

Guaranteed loan financing and grant funding to agricultural producers and rural small businesses for renewable energy systems or to make energy efficiency improvements.

## **This Week's Highlight:** Outdoor Recreation Trails+ Grant

<u>The Outdoor Recreation Trails+ Grant</u> was created to grow outdoor access for New Mexicans and preserve wild places within our state. This grant invests in conservationminded shovel-ready projects. Examples include trail design or construction, signage, river access, whitewater amenities, outdoor classroom infrastructure, trailhead improvements, picnic shelters, and wildlife viewing areas. Eligible applicants include Tribes, Pueblos, and Nations; municipalities; counties; nonprofits; public preschools/schools/districts; colleges/universities; soil and water conservation districts; acequia and land grant associations.

Project must show demonstrable benefit to the local community, either by attracting/retaining residents or attracting visitors. The project must be open for public use. Note: Projects on Tribal lands do not have to be open to the public but should be open to Tribal members.

## **Community Resources**

### **Tribal College Small Business Achievement Grant**

Provides funding for up to four Tribal Colleges and Universities that provide entrepreneurial development services to Native American communities, focusing on supplying services to socially and economically disadvantaged entrepreneurs in locations outside of the geographical areas of existing SBA resources. **Deadline: August 5.** 

### Solar for All

Awards up to 60 grants to states, territories, Tribal governments, municipalities, and nonprofits to expand the number of low-income and disadvantaged communities primed for distributed solar investment. Grantees will use funds to expand existing low-income solar programs or design and deploy new Solar for All programs nationwide. **Deadline: Sept. 26.** 

### NATIVE Act Tribal Tourism Cooperative Agreement

Provides funding for Tribes to conduct feasibility studies to help them make informed decisions about potential tourism projects. **Deadline: September 29**,

### Neighborhood Access and Equity Program

Supports economically disadvantaged or underserved communities in planning, capital construction activities, and regional partnerships that aim to restore community connectivity through the removal, retrofit, mitigation, or replacement of highways, roadways, or other infrastructure facilities that create barriers to mobility, access, or economic development. **Deadline: September 28.** 

### **Creative Placemaking Grant Program**

Supports activities that integrate arts, culture, and design into local efforts that strengthen communities over the long term. **Deadline: August 3.** 

### Affordable Connectivity Program

Provides a discount of up to \$30 per month toward internet service for eligible households and up to \$75 per month for households on qualifying Tribal lands. Eligible households can also receive a onetime discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price.

### <u>Increasing the Supply of Affordable Housing through Off-Site Construction and Pro-</u> <u>Housing Reforms Research Grant Program</u>

Supports research efforts that help accelerate the adoption of effective practices and policies to increase the production and supply of quality, affordable housing. Specifically, the grant focuses on efforts to assess the potential of off-site construction methods and study how local zoning reforms can increase the supply of affordable housing. **Deadline: August 1.** 

### The Teacher Loan Repayment Program

The purpose of the Teacher Loan Repayment Program is to increase the number of teachers in designated high-need teacher positions in public schools through an educational loan repayment

program. The program provides for repayment of the principal and reasonable interest accrued on loans obtained from the federal government for teacher education purposes. **Deadline: August 1.** 

### JustPax Fund

Provides financial and logistical support to individuals and organizations working for effective change in the realm of gender justice, environmental justice, and/or economic justice. **Deadline: August 1.**
