Awards funds between \$100,000 and \$200,000 plus \$50,000 worth of entrepreneurship assistance to science and technology commercialization proposals from faculty/student teams at New Mexico universities.

Deadline: March 4.

Invests in conservation-minded shovel-ready projects. Examples include trail design/construction, signage, access, amenities, outdoor classroom infrastructure, trailhead improvements, picnic shelters, and wildlife viewing areas.

This Week's Highlight: Grant Award Bootcamp from the Local Infrastructure Hub

The Bipartisan Infrastructure Law has provided cities with unprecedented opportunities to apply directly for federal funding, but some cities and towns have fewer resources and staff, impeding their ability to bid effectively.

Through the Local Infrastructure Hub, small and mid-sized municipalities can receive an expert suite of support to develop strong, competitive grant applications through pro bono technical training and grant writing bootcamps.

Community Resources

[Opportunity Enterprise Revolving Fund](#)

A low-cost loan program that provides financing up to \$17.5 million for building or renovation projects to increase the inventory of commercial space that will attract businesses to New Mexico communities and achieve economic benefits for the state. **Deadline: March 1.**

[The Outdoor Recreation Legacy Partnership \(ORLP\) Program](#)

A nationally competitive, dollar-for-dollar matching grant program created to aid disadvantaged, urban communities that lack access to close-by outdoor recreation. Funds can be used for the acquisition, development, or substantial renovation, of public parks and other outdoor recreation spaces. **Deadline: April 30.**

[Southwest Intervention Fund](#)

Provides support for preservation planning efforts and enables prompt responses to emergency threats or opportunities in eligible states. **Deadline February 1.**

[Cultural Properties Restoration Fund \("CPRF"\) Grant Program](#)

Offers agencies and other political subdivisions of the state up to \$250,000 to fund historic preservation efforts. **Deadline: February 2.**

[NM DOT Recreational Trails Program](#)

Provides funding to develop and maintain recreational trails and trail-related facilities for both non-motorized and motorized uses. Contact program for application specifics. **Deadline: February.**

[Rural Business Development Grant](#)

Supports business opportunities or business enterprise projects in rural communities. Projects must be consistent with local community and economic development strategic plans and support other economic development activities in the surrounding community. **Deadline: February 28.**

[Children, Youth, and Families at Risk \(CYFAR\) Funding Program](#)

Improves the quality and quantity of comprehensive community-based programs for at-risk children, youth, and families supported by the Cooperative Extension System. Intended to develop and deliver educational programs that equip limited resource families and youth who are at-risk for not meeting basic human needs with the skills they need to lead positive, productive, and contributing lives.

Deadline: February 15.

[National Historic Preservation Act Grants](#)

Grants to federally recognized Tribes for cultural and historic preservation projects. These grants assist Tribes, Alaskan Natives, and Native Hawaiian Organizations in protecting and promoting their unique cultural heritage and traditions. **Deadline: February 20.**

[Training and Technical Assistance to Improve Water Quality and Enable Small Public Water Systems to Provide Safe Drinking Water](#)

Technical assistance to help communities identify water infrastructure needs, plan for capital improvements, maintain regulatory compliance, improve resiliency, build capacity, and apply for the range of eligible projects under various grant programs. **Deadline: February 2.**

[Energy Transition Act Displaced Worker Assistance Program - Phase 2](#)

Aimed at helping people who lost their jobs in connection with the closure of the San Juan Generating Station and Westmoreland Mine. Available to eligible displaced workers who have not retired. Participants will have the option of choosing between a one-time wage differential payment or a program that will support training, education, or apprenticeship for up to two years.
