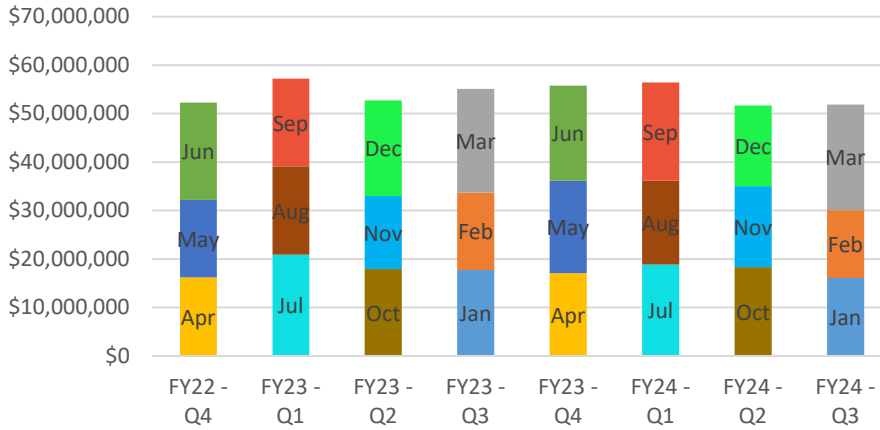

Chart 1. Matched Taxable Gross Receipts Per Quarter

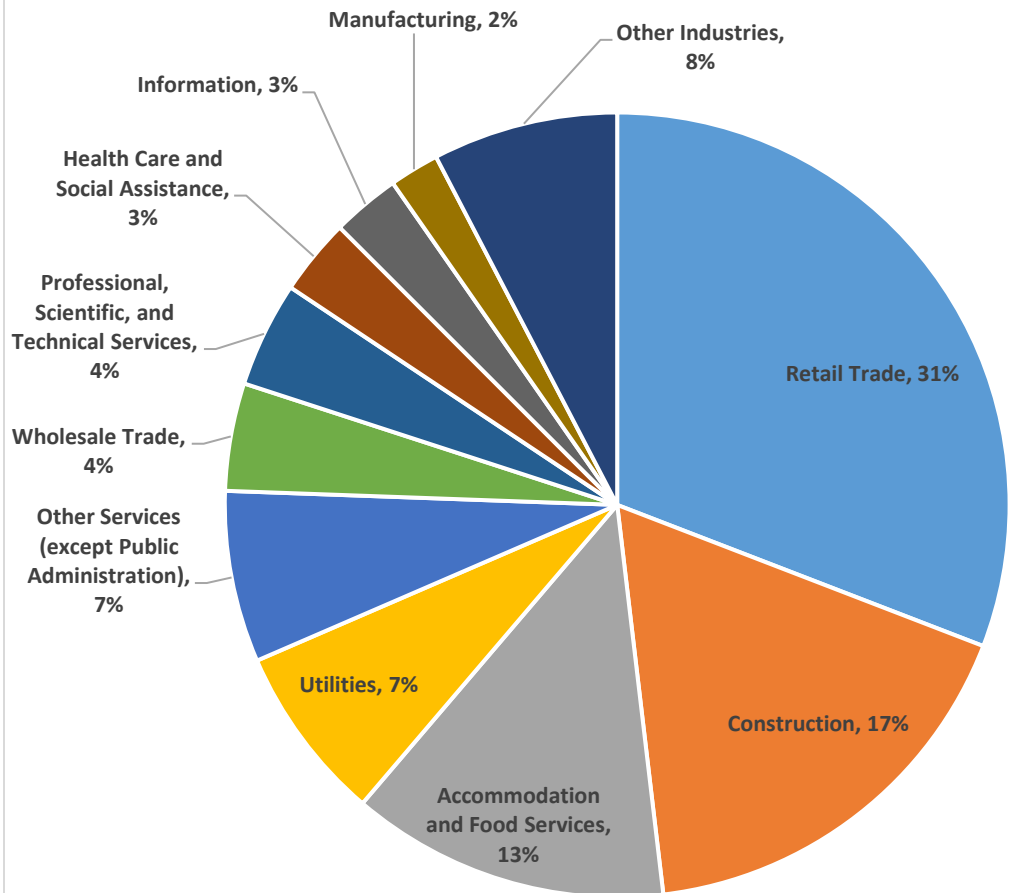

In the third quarter of FY24, 27 out of 33 counties reported positive year-over-year (YOY) economic growth, with a statewide 8.5% increase in matched taxable gross receipts (MTGR). Statewide growth was seen across most industry sectors, with construction and professional, scientific, and technical services leading. As inflation remains stubborn, employment, wages, and the number of establishments are up YOY in New Mexico.

Over the last eight quarters, Quay County's MTGR has averaged \$54.1M, which is \$2.2M more than the amount reported during Q3 FY24 (\$51.9M). From Q2 FY24 to Q3 FY24, MTGR increased slightly by 0.4%, or \$222K. As seen in Chart 2, the construction industry was the 2nd largest industry by share of MTGR (17%), up from 3rd in Q2 FY24 (11%). The accommodation and food services industry was the 2nd in Q2 FY24, comprising 15% of MTGR.

Matched Taxable Gross Receipts (MTGR) are the best tax data available to show underlying economic activity. The data collection process matches a tax payment with reported receipts for each taxpayer by industry.

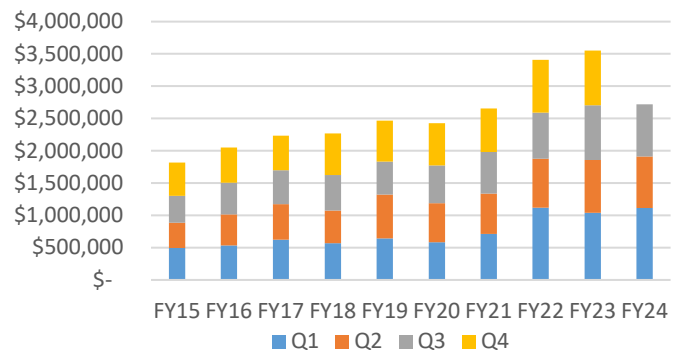

Table 1 shows that all but 7 industries reported a YOY decrease in MTGR, resulting in an overall -6% YOY change. The largest decreases came from the manufacturing and accommodation and food services industries.

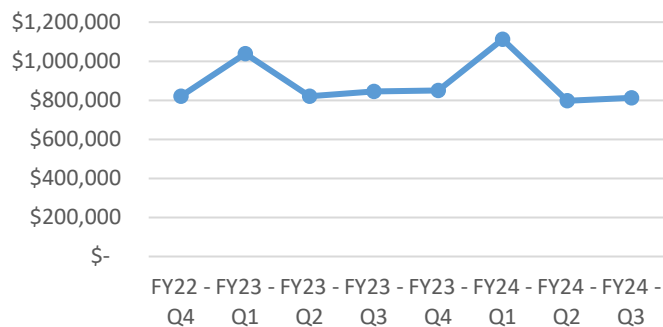
As seen in Chart 4, the quarterly gross receipts tax (GRT) collections during Q3 FY24 (\$812K) show an increase of \$14.9K, or 1.9%, compared to Q2 FY24, but were \$74.8K lower than the last eight-quarter average (\$887K). While average employment decreased by 1.4%, or 37, YOY, average weekly wages posted an increase of \$28, or 3.5%, YOY (Chart 5).

Chart 3. Annual Total GRT Revenue Collections



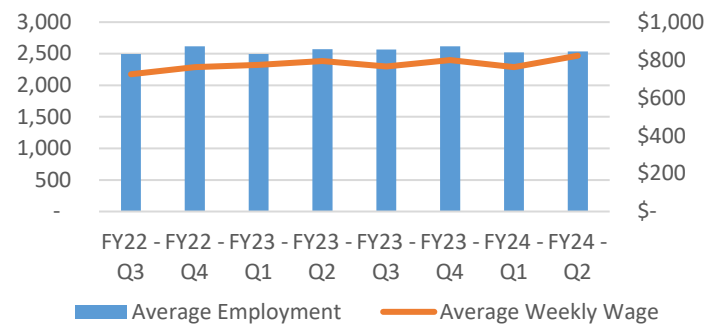

Chart 5. Total Employment & Weekly Wage



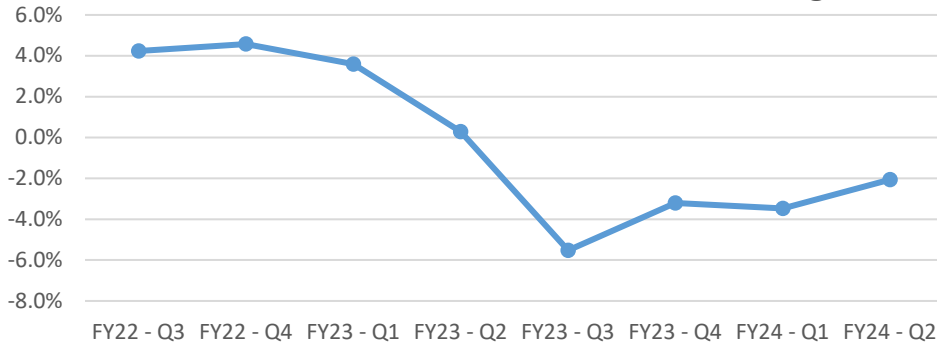

An **establishment**, as used in the QCEW and subsequently Chart 6 and Table 2, is an economic unit, such as a farm, factory, or store, which produces goods or provides services at a single physical worksite and is engaged, predominantly, in one type of economic activity.

The **Quarterly Census of Employment and Wages**, or the **QCEW**, used in Charts 5-6 and Table 2, produces comprehensive data on the number of establishments, monthly employment, and quarterly wages for workers covered by state unemployment insurance (UI) laws and federal workers covered by the Unemployment Compensation for Federal Employees (UCFE) program. These data are aggregated to many different levels, starting at the 6-digit NAICS industry level, to higher industry levels (NAICS industry groups, sectors, and supersectors), and to higher geographic levels (MSA, state, and national).

Data are based on information reported by New Mexico employers, covering 97% of nonfarm wage and salary workers. Data are published every quarter. Considered the gold standard for its reliability of industry data, the QCEW data are the most complete universe of monthly employment and quarterly wage information by detailed industry.

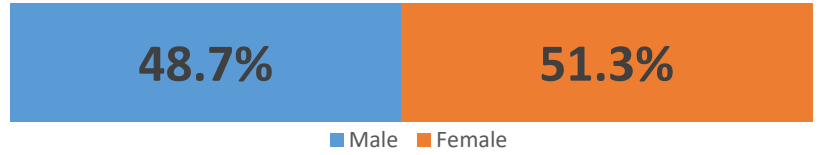

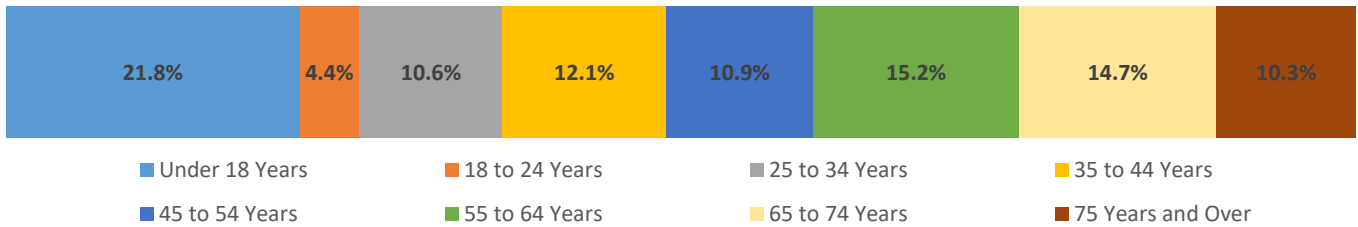

Population Sex



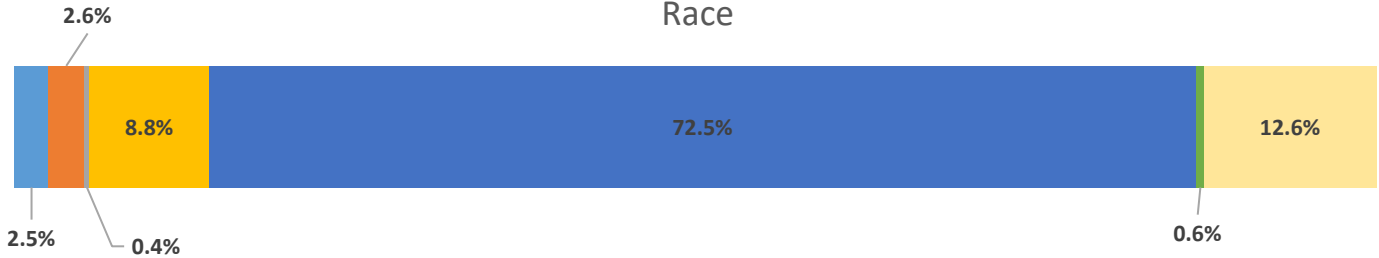

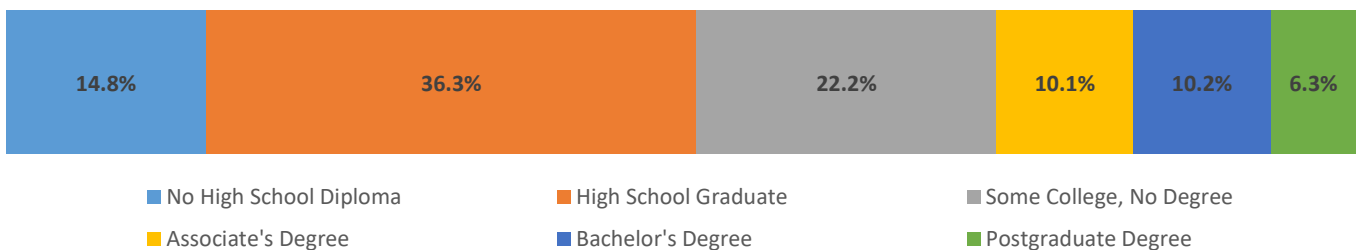
