I. Introductions

The meeting was called to order at 9:02 am. The introduction of the board and staff followed.

II. Approval of the Agenda

A motion to approve the agenda was made by Kelley Allen and seconded by Monica Sandoval - Johnson. Motion passed unanimously.

III. Consideration of Proposals and Amendments

a) Spiritus Technologies 2024-0071 – (Amendment)

The company is requesting \$254,896.00 for 4 trainees. The positions are high wage jobs and are eligible for an additional 5% reimbursement.

A motion to approve this request was made by Marc Duske and seconded by Kelley Allen. Motion passed unanimously.

b) Century Sign Builders 2024-0074 – (Amendment)

The company is requesting \$15,080.00 for 1 trainee. The company is requesting funds for trainee as an Environmental Graphic Designer.

A motion to approve this request was made by Monica Sandoval-Johnson and seconded by Marcos Martinez. Motion passed unanimously.

c) Kilonewton -

The company is requesting \$154,623.88 for 4 trainees and 4 interns. KiloNewton has been approved for JTIP on eight previous occasions. Several positions are high wage jobs and are eligible for an additional 5% reimbursement.

A motion to approve this request was made by Marcos Martinez and seconded by Marc Duske. Motion passed unanimously.

d) Redwire (LoadPath) -

The company is requesting \$172,242.00 for 5 trainees. Redwire, formally known as LoadPath, has been approved for JTIP on nine previous occasions. Trainees wanted for Lab Manager, Mechanical Engineer -Jr (2), Mechanical Engineer -Sr, and Supply Chain Buyer. All positions are high wage jobs and are eligible for an additional 5% reimbursement.

A motion to approve this request was made by Kelley Allen and seconded by Marcos Martinez. Motion passed unanimously.

e) Pajarito Powder LLC -

The company is requesting \$431,418.36 for 22 trainees. Pajarito Powder has been approved for JTIP on six previous occasions. 11 out of 22 of these positions are

high wage positions and eligible for an additional 5% reimbursement.

A motion to approve this request was made by Marc Duske and seconded by Marcos Martinez. Motion passed unanimously.

f) Flow Aluminum, Inc. -

The company is requesting \$41,290.00 for 2 positions. This is Flow Aluminum's first JTIP application. The company is requesting funds for training two employees in the following job classifications: Senior Battery Technician and Battery Technician. Both positions are high wage jobs and are eligible for an additional 5% reimbursement.

A motion to approve this request was made by Monica Sandoval-Johnson and seconded by Marc Duske. Motion passed unanimously.

g) EMPOCC, LLC dba Oasis Cannabis Company -

The company is requesting \$229,911.00 for 40 trainees. Oasis Cannabis Company has been approved for JTIP on one previous occasion. The positions for this project include Packagers (25), Labeler (10), and Manufacturing Manager (5). The Manufacturing Manager position is a high wage position and is eligible for an additional 5% reimbursement.

A motion to approve this request was made by Marcos Martinez and seconded by Kelley Allen. Motion passed unanimously.

h) Gridworks, Inc.

The company is requesting \$245,244.12 for 11 trainees. Gridworks has been approved for JTIP on eleven previous occasions. 9 out of 11 positions are high wage. They are eligible for an additional 5% reimbursement.

A motion to approve this request was made by Kelley Allen and seconded by Marcos Martinez. Motion passed unanimously.

i) Golightly Company, LLC -

The company is requesting \$73,773.00 for 5 trainees. Golightly Company has been approved for JTIP on two previous occasions. Two out of five positions are high wage jobs. The Pattern Designer and Marketing Manager are both eligible for an additional 5% reimbursement.

A motion to approve this request was made by Marc Duske and seconded by Kelley Allen. Motion passed unanimously.
