The mission of the New Mexico Economic Development Department is to improve the lives of New Mexico families by increasing economic opportunities and providing a place for businesses to thrive.


Community, Business & Rural Development (CBRD)

EDD's Community, Business & Rural Development (CBRD) staff, or regional reps, are located in the regions they serve throughout the state. They assist businesses and communities in a broad variety of economic development needs:

- Passing and using the **Local Economic Development Act (LEDA)** to provide local incentives for job creation.
- Working directly with local governments and businesses throughout the **LEDA funding** process.
- Implements the **Business Retention & Expansion Program**.
- Connects businesses to the **Job Training Incentive Program (JTIP)** team and provides technical assistance through the application process.
- Business development project funding in collaboration with finance programs.
- Marketing outreach, education and technical assistance with the LEADS and Certified EDO programs.
- Assist businesses in taking advantage of New Mexico's **tax credit incentives** for job creation.
- Assist communities in responding to **Potential Recruitment Opportunities** (PROs) from the New Mexico Partnership.
- Community infrastructure financing assisted by FUNDIT, a collaborative group of community development funding agencies who review and vet projects in a single meeting.
- Resolve state regulatory or other issues that impact businesses.
- Access to all other EDD programs, including New Mexico MainStreet, New Mexico Film Office, Outdoor Recreation Division, and more (see programs and divisions listed on the following pages).

EDD Business Resources

Local Economic Development Act (LEDA)

The Legislature has granted EDD the authority to administer the multimillion-dollar LEDA grant fund to assist expanding or relocating businesses. These grants are distributed to a local government to be passed onto the business on a reimbursement basis. The qualifying entity must provide economic impact and public benefit equal to or greater than the amount of the grant.



Economic-base employers deemed eligible for the Job Training Incentive Program (JTIP) may qualify for LEDA. Eligible uses of funds are related to the purchase or development of land, building and infrastructure for the purpose of conducting business in New Mexico.

EDD determines eligibility and provides technical assistance throughout the application and

approval processes. All funding decisions are made at the executive level, by the governor's office.

LEDA Rural Infrastructure Grants

EDD may award funding to rural communities when critical infrastructure is needed for economic growth. Publicly owned industrial properties that attract business development are eligible.

Gross Receipts Tax Sharing

LEDA funding, which supports new jobs and investment, will now be sustained by a partial sharing (no more than 50%) of GRT revenues during the construction phase of projects when costs exceed \$350 million. The recapture requires agreement between the state and the participating local government. Multiple small projects can be funded with one large project.

Job Training Incentive Program (JTIP)

JTIP funds classroom and on-the-job training for newly-created jobs in expanding or relocating businesses for up to 6 months. Once training is complete, the program reimburses a *minimum* of 50-75% of employee wages during training.

The JTIP program strengthens New Mexico's economy by providing financial incentives to companies that create new economic-base jobs in New Mexico. Training funded by JTIP also elevates the skill level of the New Mexico residents who fill funded positions. Companies may also be eligible for the High Wage and Rural Job Tax Credits.

JTIP reimbursement rates are based on company location, with higher rates in rural and frontier communities, and the potential for additional reimbursement if certain criteria are met.

Custom training at a New Mexico Higher Education institution (HEI) may also be reimbursed, up to \$6,000 per trainee. New Mexico HEIs are equipped to quickly design and implement training programs that are customized to a company's specifications. The cost of the development and delivery of the training can be offset with JTIP funds. This aspect of JTIP complements the JTIP wage reimbursement and contributes to the overall training plans for new hires.

JTIP eligibility is based on the company's business, the role of the jobs, and the trainees themselves. JTIP staff determines eligibility and provides technical assistance to companies throughout the process. All funding decisions are made by the JTIP board, which meets monthly to consider applications.

Step Up Program - Reimburses JTIP-eligible companies for a portion of the cost of upskills training for incumbent workers, up to \$6,000 per trainee.

Food, Hunger, and Agriculture Program

The Food, Hunger, and Agriculture Program supports the intersection of economic development in New Mexico's food and agricultural sector with increased food security for New Mexicans. It is part of the Governor Michelle Lujan Grisham Food Initiative.

The program supports several grants and projects:

New Mexico Healthy Food Financing Fund - a grant program that provides financial and technical assistance for food and agriculture enterprises to grow, raise, aggregate, distribute, and sell local, fresh, healthy food through expanded retail and institutional in-state market

channels in rural and underserved communities.

Resilient Food System Infrastructure (RFSI) Program - EDD is partnering with the NM Dept of Agriculture and the US Dept of Agriculture to address middleof-the-supply-chain needs for locally and regionally produced food products (excluding meat



and poultry), increase resource access, create more and better markets for small and mid-size producers, and bridge gaps in existing federal funding.

New Mexico Healthy Food Financing Fund Partnership is funded through the America's Healthy Food Financing Initiative (HFFI) Partnerships Program. This Partnership will conduct outreach and new market studies to evaluate the needs of New Mexico's food ecosystem and design loan, grant, and technical assistance programs that improve sustainability and resiliency for local healthy food retail and food retail supply chain projects. The Partnership is comprised of Vida Mejor Capital, EDD, NMSU, Santa Fe Farmers' Market Institute, and New Mexico Community Development Loan Fund.

Socially Disadvantaged Farmer and Rancher Access to Capital Program - The CDFA-NASDA Foundation Access to Capital Program helps rural communities understand the many financing programs available to build successful operations.

SSBCI federal funding is provided to governments to assist small businesses and empower job-creating opportunities. SSBCI TA, the Collateral Assistance Program (CAP), and the Venture Capital (VC) programs are all made possible through SSBCI funding.

Collateral Assistance Program (CAP)


CAP encourages banks and other financial institutions to make loans to small businesses in under-served markets. EDD can pledge cash to cover a collateral shortfall of a loan in order to enable financing that otherwise might not be available to a small business. Awards up to \$250,000.

Venture Capital Program (VC)

The Venture Capital Program Fund was created to advance economic development objectives of the state by making investments for startup, expansion, product or market developments, recapitalization, or earlystage development. NMFA is administering the funding in partnership with EDD.

Office of Strategy, Science & Technology (OSST)

OSST works to connect New Mexico's innovation infrastructure to the commercial market and support science and tech startups in New Mexico. The office strives to lead and execute programs that encourage and enable the startup, growth, and relocation of technology-based industries in New Mexico by focusing on growing and diversifying existing technology companies, rapidly commercializing technologies, and promoting research and development in emerging technologies.

OSST facilitates the activities of the Technology Research Collaborative (TRC), and manages several grant programs, including:

The Advanced Energy Award Pilot Program is a competitive state-funded grant that awards non-dilutive funds to proposals in advanced energy innovation and commercialization from New Mexico small businesses engaged in research and development. The funds seek to assist early-stage companies developing a unique product with strong growth potential. Awards range between \$250,000 and \$1,000,000.

The Small Business Innovation Research (SBIR)/Small Business Technology Transfer (STTR) Matching Grant is a competitive state-funded grant that awards non-dilutive funds for business development expenses to New Mexico businesses with federal Phase I/II SBIR/STTR awards. Awards range between \$25,000 and \$100,000 depending on phase and proposal.

The Science & Technology Business Start-Up Grant is a competitive state-funded grant that awards non-dilutive funds for business development expenses to early-stage technology companies with high-growth potential commercializing their technologies and doing business in New Mexico. The average award amount is \$25,000.

The Outdoor Recreation Division (ORD) works to sustainably grow the outdoor recreation economy in New Mexico and increase equitable access to the outdoors. The division achieves this through investing in economic and community development, education, and outdoor infrastructure investments.



Outdoor Equity Fund (OEF)

The Outdoor Equity Fund supports programs that provide transformative, educational outdoor experiences for youth, particularly those from lowincome families, fostering stewardship and respect for the state's lands, waters, and cultural heritage. Applicants must serve a population where at least 40% are low-income youth up to age 18. Awards range from \$5,000-\$40,000. Applications are open July 1-August 31.

Outdoor Recreation Trails+ Grant

The Outdoor Recreation Trails+ Grant program supports outdoor infrastructure projects that enhance community access to equitable outdoor

recreation opportunities and promote regional economic development. All projects must be open for public use unless on Tribal land, in which case they must be open to Tribal members. Awards range from \$25,000-\$99,999. Applications are open on a rolling basis starting July 1 and are offered in multiple rounds until funds run out.

ActivatOR Outdoor Recreation Growth Accelerator

ORD partnered with CNM Ingenuity to develop and execute a free 14-week business accelerator program tailored to startups and established outdoor recreation businesses and nonprofits located in or expanding to New Mexico. Applications will open Spring 2025 and 2026.

International Trade

EDD's International Trade program assists companies to capitalize on opportunities in the global marketplace by focusing on these key areas:

- The New Mexico State Trade Expansion Program (STEP) Grant, funded by the U.S. Small Business Administration (SBA), is a reimbursement grant program of up to \$7,500 for approved activities. Funds may be used to offset the costs for international trade shows/missions, global website optimization, market research, foreign product registration, and business matchmaking.
- Coordination with the U.S. Department of Commerce International Trade Administration, New Mexico Commercial Service office to provide export assistance to New Mexico companies. Services provided by the New Mexico Commercial Service may also be eligible for STEP Grant reimbursement.
- Maintenance of a foreign trade office in Taiwan to generate qualified trade leads, locate buyers and distribution partners for companies, assist with questions regarding regulatory approvals, and support the recruitment of Foreign Direct Investment (FDI) to New Mexico. It also assists with questions regarding regulatory approvals.
- One-on-one business consultations to help companies navigate through language, cultural, and structural barriers.
- Workshops that create an awareness of international market opportunities and educate companies on the export process.
- Recruitment and coordination of N.M. companies to participate in international trade events.
- Reverse trade missions designed to bring visiting foreign trade and investment delegations to N.M. with an interest in sourcing products produced in the state or to invest in N.M.

New Mexico Film Office (NMFO)

The film and television industry is a key sector of the New Mexico economy with a positive and wide reaching direct and indirect impact. Productions filmed in New Mexico bring revenue to the state and are incentivized to hire New Mexico residents and buy from New Mexico vendors.

New Mexico's nationally and internationally competitive 25% refundable tax credit with a maxi-

mum incentive of 40% when certain criteria is met, such as filming outside Bernalillo and Santa Fe counties, utilizing a qualified production facility (soundstage or western set), or filming an eligible TV pilot/series. The New Mexico Film Office provides workforce development trainings and programs to prepare New Mexico residents for work in the high-wage jobs the film and television industry offers.

In February 2022, EDD and the NMFO announced the establishment of the New Mexico Media Academy (NMMA), in partnership with the Higher Education Department, New Mexico Film Partners Netflix and NBCUniversal, IATSE Local 480, and fifteen (15) statewide post-secondary film/media programs and institutions. NMMA will be the epicenter for training New Mexicans in specific on-demand crafts and will provide paid apprenticeships and accruement of union/guild hours upon completion.

Additional incentive programs include:

- Film Crew Advancement Program (FCAP)
- Operation Soundstage (OSS)







New Mexico Border Authority (NMBA)

NMBA benefits New Mexico businesses by assisting them in doing business with Mexico and utilizing the international ports of entry. The Border Authority has particularly strong relationships with the States of Chihuahua and Sonora.

NMBA benefits communities by resolving issues and disputes with Mexican and U.S. inspection agencies that negatively affect the flow and amount of traffic at ports of entry. Border Authority staff also support the recruitment of manufacturers and other border-related business and they promote tourism at the three ports of entry.

Office of Military Base Planning & Support (OMBPS)

OMBPS supports the continued presence of Department of Defense (DoD) installations in New Mexico and seeks opportunities to enhance DoD's investment here. This benefits businesses who are DoD contractors and communities around the military bases.

The Office facilitates communication between the military base leadership, community governments and support organizations, state and federal agencies to eliminate areas of conflict. This also supports the development of renewable energy projects.

NMMS's core objective is downtown revitalization. As a Main Street America™ Coordinating Program since 1985, NMMS helps communities implement the Main Street Approach™ to transform communities.

NMMS's three economic transformation strategies guide the program's work:

- 1. Build capacity for local economic revitalization and redevelopment efforts
- 2. Enhance the entrepreneurial and creative economy
- 3. Create thriving places



NMMS staff and revitalization specialists work with program partners to engage people, rebuild places, and revitalize economies by providing professional technical assistance that supports asset-based economic development.

Capital Outlay public infrastructure projects leverage private sector reinvestment, make visible upgrades to streets and amenities, improve pedestrian safety, and create vibrant places for economic growth. The Great Blocks on MainStreet program dramatically upgrades 2-3 district blocks in a core commercial area.

Justice, Equity, Diversity and Inclusion (JEDI) Office

The JEDI Office works to address systemic inequities and create equitable representation for all New Mexico businesses while promoting diversity and inclusion. It addresses the specific concerns of minority-owned business, serves as a liaison, support, and voice for underserved businesse, and connects minority-owned businesses and community organizations in underserved communities with economic development programs, resources, and opportunities.

Creative Industries Division

The Creative Industries Division is charged with supporting the state's creative industries by:

- Increasing and advancing creative industry-based economic development.
- Supporting entrepreneurs and small businesses in creative industries.
- Assisting organizations that support creative industry companies and workers.
- Supporting educational and workforce training initiatives that facilitate creative industry growth and success.
- Identifying and helping establish public infrastructure to support creative industries.
- Serving as an information clearinghouse by providing resources and opportunities to creative industry stakeholders.
- Acting as a liaison between creative industries-related businesses and organizations.

Local Economic Assistance & Development Support (LEADS)

LEADS funding creates jobs through recruitment, retention/expansion, and startup activities; develops the tax base; and provides incentives for business development. Applications are accepted from economic development departments or organizations with a current plan to address business growth in a community that has passed a LEDA ordinance to local governments and eligible partners. Projects may be awarded up to \$25,000 per year in funding.

Certified Economic Development Organizations

The Certified Economic Development Organization program recognizes excellence in EDOs, heightens the visibility of the economic development process, builds capacity for EDOs, and encourages professional development. EDD assists local EDOs to build capacity so that they are equipped to provide economic development services and support their communities. Applications are open annually. Certified EDOs receive funding (subject to availability) of up to \$40,000 annually and certification is renewable for up to 10 years. Funds may be used to offset expenses like marketing events, attendance at trade shows and sales missions, advertising, and additional staff costs over and above one full-time position.

Business Incubator Certification

An incubator is a business support facility with processes that accelerate the successful development of startup companies by providing entrepreneurs with an array of targeted resources and services. Once all the research, planning, and resource gathering is complete, the final step is certification by the state.

High Wage Jobs Tax Credit

A taxpayer who is an eligible employer may apply for and receive a tax credit for each new high-wage economic-base job. The credit amount equals 8.5% of the wages and benefits paid for each new economic-base job created, up to \$12,750 per job.

To qualify, jobs must pay at least \$40,000/year in a community with a population of less than 60,000 or pay at least \$60,000/year in a community with a population of 60,000 or more; and be occupied for at least 44 weeks by the employee. Employers/positions must be eligible for the Job Training Incentive Program.

The credit can be applied to the state portion of the gross receipts tax, compensating tax, and withholding tax. Any excess credit will be refunded to the taxpayer.

Rural Job Tax Credit

This credit can be applied to taxes due on state gross receipts, corporate income, or personal income tax. Rural New Mexico is defined as any part of the state other than Los Alamos County; certain municipalities: Albuquerque, Rio Rancho, Farmington, Las Cruces, Roswell, Santa Fe, and a 10-mile zone around those municipalities.

To qualify, companies must manufacture or produce a product in New Mexico and be a non-retail service companies that exports a substantial percentage of services out of state (50% or more revenues and/or customer base). Certain green industries may also qualify.

The percentage of tax credit is dependent upon location.
